Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Citgo Petroleum Corporation Medical, Dental, Vision and Life Insurance Program for Salaried Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical



requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information



to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of Benefit Plans

The CITGO Petroleum Corporation Medical, Dental, Vision and Life Insurance Program for Salaried Employees (the Plan) is a health and welfare plan covering substantially all salaried employees of CITGO Petroleum Corporation (CITGO) and its participating subsidiary companies (collectively, the Company). The Plan was effective January 1, 1984, and amended and restated effective January 1, 2005.

The following description of the Plan provides only general information. Participants should refer to the Plan's Summary Plan Description (SPD) or the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

(a) General

The Plan provides medical, prescription drug, dental, vision, life and dependent life, personal accident, accidental death and dismemberment, occupational accidental death benefits, long term disability benefits and health care flexible spending account reimbursement and health savings account employer incentive contributions to eligible employees and eligible retirees, as applicable, and their eligible spouses and dependents. Eligible employees for the Plan include all regular full-time and regular part-time salaried employees as defined in the Plan document. Medical, prescription drug, dental and vision coverage for post-65 retirees ended December 31, 2012. Effective January 1, 2013, eligible post-65 retirees and their eligible post-65 spouses receive a subsidy from the Company deposited into a retiree reimbursement account, which is not part of the Plan, to purchase individual coverage from UnitedHealthcare. Non post-65 spouses and dependents of eligible post-65 retirees continue to receive benefits through the Plan.

(b) Master Trust

At December 31, 2024 and 2023, the CITGO Petroleum Corporation Employees' Benefit Trust (the Master Trust and Subtrusts), a Voluntary Employees' Beneficiary Association (VEBA), consists of the investments of the Plan and the CITGO Petroleum Corporation Medical, Dental, Vision, and Life Insurance Program for Hourly Employees (collectively, the Benefit Plans).

(c) Benefits

UnitedHealthcare processes medical and health care flexible spending account reimbursement claims. UHC Optum Rx processes prescription drug claims. Metropolitan Life Insurance Company (MetLife) processes dental claims. Vision, life, dependent life, travel, personal accident, accidental death and dismemberment and occupational accidental death benefits are provided through fully insured arrangements.

Effective June 20, 2022, CITGO Petroleum Corporation adopted a Change in Control Severance Plan. Severance benefits are payable under the plan if an employee is involuntarily terminated within 12 months to 24 months, depending on eligibility, contingent upon a "Change in Control". Change in control is defined as the acquisition of a majority of the voting securities of CITGO, or its U.S. parent

companies, or an acquisition of substantially all of the CITGO assets. Benefits are unfunded and would be paid from General Assets of CITGO.

(d) Contributions

The Plan provides that the Company and participants make contributions as determined by the Company's management and/or the Company's Benefit Plans Committee (the Committee). During 2024, eligible retirees contributed approximately 13.1% of the cost of providing their postretirement medical benefits and spouses and dependents of eligible retirees contributed approximately 15.2% of the cost of providing their postretirement medical benefits. Eligible retirees and spouses and dependents of eligible retirees generally pay 100% of the cost of their dental and vision benefits.

Eligible active employees may elect to make pre-tax contributions into health care flexible spending accounts for reimbursement of eligible medical, prescription drug, dental, and vision claims. Eligible active employees enrolled in the Company's self-directed health plan may elect to make pre-tax contributions into health savings accounts or limited health care flexible spending accounts. Active employees and their spouses who participate in the Company's healthy rewards program may earn employer incentive contributions into a health care flexible spending account or a health savings account.

The activity associated with the health savings accounts other than the payment of employer incentive contributions to the health savings accounts, are excluded from the Plan's financial statements as the Plan is not obligated to pay these benefits.

(e) Termination

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan subject to the provisions set forth under ERISA. Upon termination, the assets of the Plan would be allocated to accrued liabilities and those liabilities incurred as a result of the termination and to any claims existing at the time of termination. Any remaining assets of the Plan would be used to pay benefits on behalf of the Plan's participants.

(f) Trustee and Administrative Costs

The Committee serves as the Plan's Administrator and BOK Financial Corporation (BOKF, NA), a qualified institution (the Trustee) serves as the Plan's Trustee. All expenses incurred by the Trustee and certain administrative costs, consisting primarily of claims processing fees, are paid from the Master Trust and charged to the applicable Benefit Plans and other participating plans as applicable. Other administrative costs, unless paid directly by the Company, are paid by the Plan.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

(b) Management Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, benefits currently payable, postemployment benefit obligations and postretirement benefit obligations, and the reported amounts of changes therein, during the reporting period. Accordingly, actual results could differ from those estimates.

(c) Valuation of Investments and Income Recognition

The Benefit Plans' investments are collectively invested in the Cavanal Hill Government Securities Money Market Fund (formerly Cavanal Hill Cash Management Fund) as a part of a Master Trust agreement. The Cavanal Hill Government Securities Money Market Fund is valued at the Net Asset Value (NAV) of shares held by the Master Trust at year end. The fund is also required to publish its daily net asset value and to transact at that price. The fund is deemed to be actively traded. Security transactions are recorded in the Master Trust on a trade date basis and income is recognized as earned. All interest income received by the Master Trust is allocated among the Benefit Plans based on each Benefit Plans' respective interest in the Master Trust assets.

(d) Interest in the Master Trust

All of the investments of the Benefit Plans are held by the Master Trust, which was established for the investment of assets of the Benefit Plans. Separate legal subtrusts were put into effect as of December 2006 for each individual plan. Each individual plan has an interest in the Master Trust. The assets of the Master Trust are held by the Trustee. Interest income relating to the Master Trust is allocated to the individual plans based upon monthly balances invested by each Benefit Plan. The Master Trust administrative expenses are determined by the transactions of each Benefit Plan.

(e) Benefit Obligations (Other than Postemployment and Postretirement Benefit Obligations)

The Plan's obligations for medical, prescription drug and dental benefits (other than postemployment and postretirement benefit obligations) represents benefit claims currently payable and claims incurred but not reported pursuant to the provisions of the Plan. Claims incurred but not reported are based on the Plan's historical claims experience.

(f) Claims Incurred but Not Reported

The Plan's liability for active participant health claims incurred but unreported at year-end is estimated using actuarial methods that use historical trend information developed through studies of medical claim lag patterns incurred in the prior years. The estimated liabilities for retired participants' health claims incurred but unreported as of December 31, 2024 and 2023 are included in the postretirement benefit obligation. These amounts are paid by the Plan only if claims are submitted and approved for payment.

(g) Postemployment Benefit Obligations

The postemployment benefit obligations for continuation of coverage for participants while on long term disability benefits are reported based on actuarial estimates of future benefits (using a discount rate of

5.05% and the 2012 Group Long-Term Disability Table for disabled employees, for 2024 and a discount rate of 5.36% and the 2012 Group Long-Term Disability Table for disabled employees, for 2023).

(h) Postretirement Benefit Obligations

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31 of each reporting year, reduced by actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired pre-65 employees and pre-65 spouses and dependents and (2) active employees and their beneficiaries and dependents (pre-65) upon retirement from service with the Company. The postretirement benefit obligation represents the amount that is expected to be paid by the Company and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the Company rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is actuarially determined and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The reported obligations and following assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation as of the termination date.

For measurement purposes, healthcare cost trend rates were assumed to be 8.34% for 2025 gradually decrease to 4.5% in the year 2034 and remain at that level; and 7.96% for 2024 gradually decrease to 4.50% in the year 2033 and remain at that level.

The health care cost trend rate assumption has an impact on the amounts reported in the accompanying financial statements. If the assumed rates increased by 1 percentage point in each year, the postretirement benefit obligation would have approximately increased at December 31 2024 and 2023 by \$6,800,000 and \$6,100,000, respectively.

Other significant assumptions used in the valuations as of December 31, 2024 and 2023, were as follows:

- Discount rates of 5.94% and 5.34%, respectively, to determine the accumulated postretirement benefit obligations. The actuarial assumption changes for the years ended December 31, 2024 and 2023 primarily relate to the change in the discount rate.
- The mortality assumption is based on Pri-2012 White Collar Mortality Table with generational mortality improvement scale MP-2021.

- The life insurance administration load of 10%.

There were no plan provision changes since the prior valuation for the years ended December 31, 2024 and 2023.

(i) Benefits

Premiums paid by the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Claims paid by the claims processor to participants and providers prior to year-end that are not reimbursed by the Plan as of year-end are recorded as claims payable in the statement of benefit obligations and are not recorded as claims until the Plan reimburses the claims processor.

(j) Pharmacy Rebates

The Plan utilizes a pharmacy benefit manager which periodically provides rebates to the Plan based on actual utilization patterns for specific prescription drugs. Pharmacy rebates are recorded when earned. Pharmacy rebates due as of the financial statement date have been reported as rebates and refunds receivable, with the offset being netted against benefits paid. Pharmacy rebates totaling \$9,261,935 have been netted with benefits paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

(k) Forfeited Accounts

Any amounts remaining in a participant's health care flexible spending account as of March 31 after the end of the plan year will be forfeited. Forfeitures, if any, are available for use by the Company to offset administrative expenses of the health care flexible spending accounts. Health care flexible spending account forfeitures as of December 31, 2024 and 2023 were \$11,740 and \$26,691, respectively.

(l) Unrelated Business Income Taxes

The Plan accounts for income taxes under the liability method as prescribed by Accounting Standards Codification (ASC) 740, Income Taxes. Under the liability method, deferred income taxes are derived on the differences between the book and tax basis of assets and liabilities. Under IRC Section 512 and related regulations, a portion of the Plan's investment income is taxable as unrelated business income for both federal and State purposes if investment assets exceed Plan benefit obligation amounts currently payable. As the Plan had unrelated business taxable income from its investments for the year ended December 31, 2024, an income tax expense of \$326,056 has been included in the Plan's financial statements. There were no deferred taxes reflected in the Plan's net assets.

(3) Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures, (ASC 820) defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the

measurement date. ASC 820 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 – inputs to the valuation methodology are observable for the asset or liability (other than quoted prices included within Level 1), either directly or indirectly. Observable inputs are those that reflect the assumptions market participants would use in pricing the asset developed on market data obtained from sources independent of the Plan.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement. Unobservable inputs are those that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing the asset, developed based on the best information available in the circumstances.

A financial instrument’s categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the Master Trust’s valuation methodologies for assets measured at fair value. There have been no changes in methodologies used or transfers in levels at December 31, 2024 and 2023.

Money Market Fund

The money market fund is valued at the closing NAV as quoted in an active market and is classified within Level 1 of the valuation hierarchy.

(4) Postretirement Benefit Obligations Funding

(6) Tax Status

The latest exemption letter was obtained in February 2004, in which the Internal Revenue Service (IRS) stated that the Master Trust (the Trust), as then designed, was exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code of 1986, as amended (IRC). The Plan Administrator believes that the Master Trust, as amended, continues to qualify and operate in compliance with the applicable requirements of the IRC and therefore believes that the Master Trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Risks and Uncertainties

The actuarial present value of postemployment and postretirement benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

In October 2023, the Special Master appointed by the United States District Court for the District of Delaware in connection with the case of Crystallex International Corp. v. Bolivarian Republic of Venezuela (D. Del. Case. No.17- 151-LPS) commenced a process under which the shares of PDV Holding, Inc., the indirect parent company of CITGO Petroleum (the plan sponsor), are proposed to be sold to satisfy certain creditor claims. This sale process is subject to a number of conditions and contingencies and CITGO Petroleum cannot predict the outcome of the sale process. Accordingly, CITGO Petroleum cannot estimate whether the resolution of the sale process and related litigation matters will have a material adverse effect on the Plan.
