## INDEPENDENT AUDITOR'S REPORT

To the Administrator and Participants of the

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Rush University Medical Center 403(b) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 - PLAN DESCRIPTION**

The following description of the Rush University Medical Center 403(b) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document (including adoption agreement) for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Rush University Medical Center (the Company), Rush Oak Park Hospital, and Rush Medical Group (known collectively as the Companies or Plan Sponsor) who are not excluded as defined per the Plan document. Employees are eligible to participate in the Plan and may enter on the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions and Vesting: Participants may elect to defer to the Plan up to 50% of their eligible earnings on a pre-tax basis up to the maximum allowed under Section 402(g) of the Internal Revenue Code (IRC). Participants may contribute funds from another qualified plan as rollover contributions. Roth contributions are permitted under the provisions of the Plan. Newly hired employees are automatically enrolled in the Plan at a contribution level equal to 6% of eligible compensation unless the employee, within 60 days from their hire date, elects to contribute a different percentage or zero. A participant's initial automatic enrollment rate will automatically increase by one percentage point each year, but not to exceed 10%, in contributions.

The Companies contributed a matching contribution equal to 100% of the first 6% of eligible compensation that an eligible employee contributed to the Plan, except for employees covered under the collective bargaining agreement with the Hospital Employees Labor Program of Metropolitan Chicago Local 743 that receive a matching contribution equal to 50% of the first 6% of eligible compensation that a participant contributed to the Plan.

Students, non-resident aliens, temporary and part-time staff with less than 1,000 hours of service are not eligible to receive employer contributions.

All participants are immediately 100% vested in employee contributions and 100% vested in employer contributions after completing three years of vesting service. Regardless of the number of years of vesting service, a participant is entitled to 100% of his or her account balance upon his or her separation from service with the Companies due to retirement after attaining age 65, death, or disability.

Investment Options: Upon enrolling in the Plan, a participant may direct the investment of their account into any of the investment options offered by the Plan. Participants generally may change their investment elections daily.

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the employer contribution, and the Plan's earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits: Upon termination of service and at the participant's request, a participant will receive the vested value of his or her account in the form of a lump sum payment, an annuity, installment or a rollover distribution. A participant may withdraw all or a portion of the value of his or her vested interest prior to termination of employment upon meeting certain requirements as set forth in the Plan document. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. The Plan also permits withdrawals to be made by participants after the attainment of age 59½.

**NOTE 1 - PLAN DESCRIPTION** (Continued)

Forfeitures: Forfeitures of nonvested amounts are used to pay plan expenses and reduce future employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,197,419 and \$1,859,622, respectively. The Plan used \$2,698,089 of forfeitures to reduce 2024 employer contributions.

Administrative and Investment Management Expenses: Plan's recordkeeping and participant fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES** (Continued)

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Self-directed Brokerage Accounts:* Accounts consist of investments mainly in registered investment companies. Fair values are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

*Registered Investment Companies:* The fair values of investments in registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as liquidity, interest rate, market, and credit risks, as well as risk associated with global events. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and its related regulations. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

**NOTE 4 - CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the custodian of the Plan).

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fidelity Management Trust Company is the custodian for the Plan. A significant portion of the Plan's investments are Registered Investment Companies managed by Fidelity Investments (an affiliate of the custodian). Investment management fees and expenses paid by the Plan, which are reported as a reduction in the investment returns of the specific investments held by the Plan, also reflect party-in-interest transactions.

**NOTE 6 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated August 7, 2017 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
