### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Capitol Valley Electric, LLC 401(k) Profit Sharing Plan-2 (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### *Opinion*

**Note 1:      Description of Plan**

The following description of the Capitol Valley Electric, LLC 401(k) Profit Sharing Plan-2 (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established January 1, 2015, to provide eligible employees of Capitol Valley Electric, LLC (the Company) with retirement benefits in accordance with section 401(k) of the Internal Revenue Code (IRC). Employees are eligible to participate, provided they do not belong to an excluded labor class, after reaching 21 years of age and 1 year of service at the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Employees may elect to make tax deferred and after-tax 401(k) contributions to the Plan up to the lesser of 100% of their eligible compensation or \$23,00 for 2024. The deferral elected by the participants is withheld from their paychecks and contributed to the Plan by the Company. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to a limit of \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified plans.

The Company makes qualified non-elective contributions pursuant to the Davis-Bacon Act and the California Labor Code. Qualified non-elective contributions, or prevailing wage contributions, are allocated to participants according to the applicable prevailing wage schedule determined by the Department of Industrial Relations. The Company made qualified non-elective contributions of \$387,412 during the Plan year ended December 31, 2024.

The Company makes matching contributions equal to 100% of the first 4% of each participant's contributions up to 4% of compensation. The Company made matching contributions of \$35,452 during the Plan year ended December 31, 2024.

The Company may also make discretionary profit-sharing contributions. The Company did not make any profit-sharing contributions to the Plan during the Plan year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's own contributions, an allocation of the Company's contributions, and an allocation of net earnings from investments and changes in investment values. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account.

**Vesting**

Participants are vested immediately in their elective deferral contributions, prevailing wage contributions, safe harbor matching contributions, and transfers from other qualified retirement plans.

Participants vest in all other employer contributions at the rate of 20% per year after the second year of credited service, increasing by 20% for each year of service thereafter. After six years of service, participants are fully vested in employer contributions. The non-vested portion of a terminated participant's account balance is forfeited.

**Notes Receivable from Participants**

Loans to participants consist of promissory notes received from participants in exchange for the distribution of cash from the Plan. A participant is allowed to borrow a minimum of \$1,000, up to one half of the present value of the vested balance of their Plan account, up to a maximum of \$50,000. Loans bear interest at a rate determined by the Company. Loans are generally payable in full upon the participant's termination or the occurrence of certain other events. The loans are secured by the participant's balance.

**Payment of Benefits**

Withdrawals are allowed in the event of termination of employment, death, disability, attainment of age 59½, or financial hardship. The balances in the participant's account will be distributed to the participant, their beneficiaries, or a designated rollover recipient in a lump sum, at the election of the participant or beneficiary, provided such balances are not less than \$7,000 at the time of the distribution event.

**Administrative Expenses**

The Company, as Plan sponsor, pays certain administrative expenses on behalf of the Plan. Participants' accounts are adjusted for fees pertaining to loan or termination processing and are charged for expenses incurred by the Plan service providers in the performance of their duties.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Payment of Benefits**

Benefits are recorded when paid.

**Investment Valuation and Income Recognition**

Investments are stated at fair value and contract value as certified by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Use of Estimates**

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Subsequent Events**

In preparing the accompanying financial statements, management has considered events that have occurred after December 31, 2024, through October 14, 2025, the date these financial statements were available for issuance. Except for the matter discussed below, as of such date, management was not aware of any subsequent events requiring additional disclosure.

In July of 2025, the Plan custodian was changed from Matrix Trust Company to Ascensus Trust Company.

**Note 3:**      **Information Certified by the Custodians**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company and United of Omaha Life Insurance Company.

**Note 4:**      **Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1)      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
  
- Level 2)      Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3)      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments or redemption restrictions as of December 31, 2024.

*Pooled separate accounts:* Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information. There were no unfunded commitments or redemption restrictions as of December 31, 2024 and 2023.

**Note 5:**      **Guaranteed Investment Contract with Insurance Company**

The Plan entered a fully benefit-responsive group annuity contract issued by United of Omaha Life Insurance Company. United of Omaha Life Insurance Company maintained the contributions in a general account. The account was credited with a fixed rate of interest. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contract was benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by United of Omaha Life Insurance Company, represented contributions made under the contract, plus interest earned, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value less an early withdrawal charge, when applicable.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

Certain events could have limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial Plan termination or a merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator did not believe that any events which would limit the Plan's ability to transact at contract value with participants were probable of occurring.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6:**      **Tax Status**

On July 1, 2024, the IRS stated that the non-standardized pre-approved plan adopted by the Plan as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7:**        **Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to suspend its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all accounts become fully vested and non-forfeitable, and the Plan administrator will distribute to the participants all assets remaining in the Plan as of the date of such termination, less any expenses properly charged to the Plan.

**Note 8:**        **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9:**        **Party-In-Interest Transactions**

Certain Plan investments include shares of registered investment company funds managed by Matrix Trust Company. As Matrix Trust Company is the custodian of these assets, transactions with this entity qualify as exempt party-in-interest transactions.

**Note 10:**      **Non-Exempt Transactions**

During the Plan years ended December 31, 2024, and 2023, the Company failed to remit to the Plan's custodian certain employee contributions and participant loan repayments totaling \$10,854 and \$48,768, respectively, within the period prescribed by the Department of Labor regulations. Delays in remitting contributions and loan repayments to the custodian were due to administrative errors. Management made corrective contributions associated with these late remittances during the Plan year ending December 31, 2025, to compensate the participants as a result of lost earnings due to the delays.
