- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## NOTES TO THE FINANCIAL STATEMENTS

### A. NOTE - PLAN DESCRIPTION

The following description of the VRC Companies, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan maintained by VRC Companies, LLC (the "Company"). Vital Holdings, LLC has adopted the provisions of the Plan and is a participating employer of the Plan. The Plan covers all employees who have completed thirty days of credited service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Plan Amendment**

Effective January 1, 2024, the Plan was amended to change the eligibility requirement for participant elective deferrals from one year of service to 30 days of service. This amendment allows employees to begin making salary deferral contributions to the Plan sooner than under the previous provisions. The eligibility requirements for employer contributions, including safe harbor matching contributions, were not changed and continue to require completion of one year of service.

#### **Contributions**

For 2024, participants may contribute up to the lesser of \$23,000 or a specified percentage of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 or older are eligible to make catch-up contributions (maximum catch-up contribution for 2024 is \$7,500). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and collective investment funds as investment options for participants. The Company makes a safe harbor matching contribution equal to 100 percent of the first 3 percent of eligible compensation that a participant contributes to the Plan, plus 50 percent of the next 2 percent of eligible compensation that a participant contributes to the Plan. Generally, employees who are twenty-one years of age or older, and have one year of service as defined by the Plan, are eligible to receive the Company's safe harbor matching contribution. In addition, a special discretionary or profit-sharing contribution may be made each year as determined by the Company. Contributions are subject to certain limitations.

#### **Participant accounts**

Each participant's account is credited with the participant's contribution and an allocation of the Company's matching contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**A. NOTE - PLAN DESCRIPTION - CONTINUED**

**Vesting**

Participants are immediately 100 percent vested in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

**Payment of benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

**Forfeitures**

The Employer may use forfeitures to pay Plan expenses. In some cases, remaining forfeitures will be used to reduce Employer contributions. Any remaining amounts are used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,057 and \$0, respectively. During the year ended December 31, 2024, forfeitures of \$5,703 were used to reduce employer contributions.

**B. NOTE - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by Nationwide and Voya. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual method. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**B. NOTE - SUMMARY OF ACCOUNTING POLICIES - CONTINUED**

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events**

Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued.

**C. NOTE - INFORMATION CERTIFIED BY THE CUSTODIANS (UNAUDITED)**

During the plan year, the Plan changed custodians from Nationwide to Voya Retirement Insurance and Annuity Company (VRIAC). Substantially, all plan investments were transferred to the new custodian except for the stable value fund, which remained with the former custodian due to a contractual 12-month redemption notice period. Information certified by both custodians has been relied upon in preparing these financial statements and forming the auditor's opinion.

The following is a summary of the Plan's information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by VRIAC and Nationwide, the custodians of the Plan. The Plan Administrator has obtained certifications from the custodians that the information provided to the Plan Administrator by the custodians related to the following information is complete and accurate:

**D. NOTE - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Collective investment trusts (CIT):* CIT's are pooled investment vehicles organized as trusts and maintained by a trust company. CIT's are designed to facilitate investment management by combining assets into a single fund with a specific investment strategy. Investments are redeemed at the day's computed net asset value (NAV) measurement date. The NAV is used as a practical expedient to estimate fair value. CIT's may hold a variety of underlying assets. The Large Cap Value Fund R1 and Mid Cap Growth Fund II R1 are collective investment trusts that have no unfunded commitments, the redemption frequency is daily, and there are no redemption notice periods. The Morley Stable Value fund is a collective trust fund that has no unfunded commitments, the redemption frequency is daily, and a 12-month redemption notice.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**E. NOTE - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and collective investment trusts managed by Voya and a collective investment trust managed by Nationwide. Voya and Nationwide are the custodians of these investments and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments.

**F. NOTE - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**G. NOTE - TAX STATUS**

The Plan adopted a pre-approved plan offered by VRC Companies, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**H. NOTE - AMOUNTS OWED TO WITHDRAWN PARTICIPANTS**

As of December 31, 2024, the amount of net assets available for benefits that were in accounts of participants that are not current employees of the Plan sponsor totaled \$3,263,242. Of those balances, no amount has been requested to be paid to the participants.

**I. NOTE - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
