### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Milestones Behavioral Services, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering eligible employees of Milestones Behavioral Services, Inc. (referred to as the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

All employees who complete a service requirement of six consecutive months of employment from their hire date with the Company and attain the age of 21 are eligible to enter the Plan. Employees may enter the Plan on the first day of the month coinciding with or next following the date in which the employee satisfies the eligibility requirements.

#### **Contributions**

##### ***Participants***

Each year, participants may contribute the maximum amount allowed under the Internal Revenue Code (IRC) of annual compensation, as defined in the Plan. Participants can also contribute amounts representing distributions from certain other eligible retirement plans (rollover contributions) as defined in the Plan.

##### ***Employer***

The Company will make employer matching contributions to eligible participant accounts each year. For 2024, the Company matched salary deferral contributions made by participants at 100% of the participants' first 3% of compensation plus 50% of the participants' salary deferrals between 3% and 5% of compensation under the IRS safe harbor matching provisions.

The Company may also makes nonelective contributions to the Plan's eligible participant accounts at the Company's Board of Directors' discretion. The allocation is based on a grouping method, where each participant constitutes a separate classification. The Company made a discretionary profit sharing contribution of 4% of eligible participant's salary in the amount of \$43,559 during Plan Year 2024.

All participant and employer contributions are limited under current Internal Revenue Code regulations.

#### **Participant Accounts**

Each participant's account is credited with their own salary deferral contributions, their rollover contributions from other plans and the Company's contributions as well as investment earnings (losses) within the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

All participants are vested in all contributions immediately, including their salary deferral contributions and their rollover contributions plus actual earnings (losses) as well as in all Company contributions.

### Participant Loans

Participants may receive loans up to 50% of their account balances. Amounts may be borrowed between \$1,000 and \$50,000, utilizing the participant's remaining account balance as security for the loan. Interest is charged at 1% above the prime rate and is fixed throughout the duration of the loan. Loans must be repaid within five years unless the loan is used for the purchase of a participant's primary residence, in which case the loan may be repaid under an alternative time frame as determined by the plan administrator. Participants who do not repay their loans under certain circumstances, as defined in the Plan, will be deemed to have received a distribution subject to federal income taxes under the Plan.

### Investment Options

The Plan's participants direct the investment of all contributions within their own accounts into various investment options consisting of mutual funds and a fixed annuity account offered by the Plan through insurance contracts.

### Payment of Benefits

On separation of service due to death, termination or retirement, or in the event of a participant's disability, a participant, or the participant's beneficiary(ies) in the event of death, may receive a lump-sum amount equal to the value of the participant's account.

In-service withdrawals, other than hardship withdrawals (as discussed below) are permitted under the Plan for participants who attain age 59½. Qualified reservist distributions for certain military personnel are also available under the Plan's terms.

### Hardship Withdrawals

In the event of financial hardship, as defined under the Plan and under current Internal Revenue Service regulations, participants are permitted to receive hardship withdrawals of funds held within their own elective deferrals.

### Forfeited Accounts

For the year ended December 31, 2024, the Company elected to use forfeitures to pay for a portion of employer match. At December 31, 2024 and 2023, forfeited vested accounts totaled \$1,208 and \$7,555, respectively.

### Evaluation of Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

## NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Plan investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant fails to make payments when they are due under the terms of the loan, the participant's loan will be considered to be in default. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Payment of Benefits

Benefits were recorded when paid.

### Administrative Expenses

The plan sponsor pays significant costs for administration of the Plan, which includes custodian, third party administration, plan investment advisor and plan audit fees. Certain other expenses of the Plan for administrative fees related to participant specific benefit payments for withdrawals and loan requests are charged to the Plan participants' accounts.

### NOTE 4 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Empower holds the Plan's assets and provides custodial and recordkeeping services for the Plan. As a provider of services to the Plan, Empower received fees from the sponsor and the Plan participants for their services and is a party-in-interest to the Plan under ERISA.

Morningstar Investment Management, LLC is an investment financial advisor for the Plan. As a provider of services to the Plan, Morningstar Investment Management, LLC is a party-in-interest as defined under ERISA. Morningstar Investment Management, LLC receives fees from the sponsor for their services.

PASI, LLC provides third party administrative services to the Plan for participant recordkeeping including compliance testing and annual report preparation. PASI, LLC receives fees for their services from the employer for their contractual services. These transactions qualify as party-in-interest transactions.

Notes receivable from participants totaled \$48,417 and \$70,431 at December 31, 2024 and 2023, respectively and interest income on notes receivable from participants totaled \$2,873 for the year ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, no further contributions would be made to the Plan and all amounts credited to participant accounts would continue to be 100% vested and would be distributed to participants as soon as practicable.

### NOTE 6 – TAX STATUS

The Plan was originally effective on July 1, 2007. The Plan's latest determination letter as a Prototype Non-standardized Profit Sharing Plan of PASI, LLC is dated June 30, 2020 which the plan sponsor is relying on with respect to qualification of the Plan. The plan administrator believes the Plan is qualified and the related trust is tax-exempt as of the financial statement date based on the advice of the Plan's third party administrator and plan technical advisor. Therefore, management believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 7 – RISKS AND UNCERTAINTIES

#### Investments and Market Conditions

The Plan participants invest in various investment options offered by the Plan. Investment options offered in the Plan are subject to various risks, such as interest rate, market value and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics, international conflicts or financial institution collapses. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 8 – FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 9 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

As of December 31, 2024 and 2023, the Plan held a fixed annuity contract through Empower. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract; plus earnings, less participant withdrawals and administrative expenses.

The following represents the disaggregation of contract value between types of investment contracts held by the Plan.

The Empower fixed annuity contract provides a guarantee of principal and interest backed by a general account of the issuing company.

The issuing insurance company is contractually obligated to repay the principal and interest at a specified rate to the Plan. Interest earned on the amounts invested in the fixed annuity contract is compounded daily at the declared interest rate. At the end of each calendar quarter, the interest rate will be declared and credited to the Plan's assets held in the fixed annuity accounts next calendar quarter.

Except for premature terminations of the contract by the Plan or Plan termination, the insurance company may not cause the contract to be terminated at an amount other than contract value. The plan sponsor has not expressed any intention to take either of these actions.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations.

### Fully Benefit-Responsive Investment Contracts, continued

The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The following events might limit the ability of the Plan to transact at contract value with the contract issuer:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, the following events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.
