### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We were engaged to perform audits of the financial statements of the Spelman College Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Disclaimer of Opinion*

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### *Basis for Disclaimer of Opinion*

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) did not provide, sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.



As described in Note 2, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, pursuant to the DOL's Field Assistance Bulletin (FAB) No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. Related to such accounts, as reported by Corebridge Financial, net assets available for benefits of \$206,800 and \$198,875 were excluded from the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively. Further, investment gains of \$19,503 and distributions of \$11,548 related to such accounts, as identified by Corebridge Financial, have also been excluded in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. In addition, pursuant to FAB No. 2009-02, such excluded pre-2009 contracts, accounts, and amounts were not covered by our auditing procedures. Accounting principles generally accepted in the United States of America (GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

#### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.



***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

### 1. Description of the Plan

The following description of the Spelman College Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The original effective date of the Plan was January 1, 1974. The Plan has since been amended to comply with regulations and other Employer-specific requirements.

The Plan is a defined contribution plan under Section 403(b) of the Internal Revenue Code (IRC) and covers substantially all employees of Spelman College (the College or the Employer). All employees are eligible to contribute to the Plan, unless they are a student of the College. There are no minimum age requirements to be eligible to make contributions into the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

All employees except students, temporary, or summer service providers are also eligible to participate in the Spelman College Defined Contribution Retirement Plan.

#### *Contributions*

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan up to the maximum allowable under the IRC. In addition to making pre-tax contributions, Plan participants may elect to make Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants with 15 years of service are also allowed to make special catch-up contributions subject to limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Contributions are subject to certain limitations.

Participants may direct the investment in their contributions into various investment options offered by the Plan.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of the Plan earnings. Allocations are based on participant earnings or account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon.

#### *Plan Loans*

Participants may borrow directly from Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of present value of the vested accrued benefit of the annuitant or 45% of

the combined accumulations attributable to their retirement plan assets. Collateral equaling 110% of the requested loan amount must be held in the TIAA Traditional Annuity Contract.

The loans are not shown in the Plan's statements of net assets available for benefits as the loans are not made from Plan assets and are therefore not considered assets of the Plan. When the Plan loan is issued, the collateral for the Plan loan is held within the borrowing participant's TIAA Traditional Annuity account balance. Loan interest rates are variable at prevailing interest rates and can be increased or decreased once a year by TIAA and CREF. Principal and interest is paid ratably by the participant directly to TIAA and CREF. A default charge will be assessed against the portion of the loan collateral used to foreclose on all or part of any loan.

Loan balances outstanding from TIAA and CREF to the Plan's participants were \$99,904 and \$84,597 as of December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, loan collateral of \$0 and \$2,268, respectively, was foreclosed upon by TIAA and CREF and segregated from participant accounts to repay the defaulted loan at the proper time a distributable event occurred with the participant.

### ***Payment of Benefits***

On termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or other specified payment options as provided in the Plan. Withdrawals from the Plan may also be made upon circumstances of financial hardship and upon reaching age 59½, in accordance with provisions specified in the Plan. All vested balances less than \$5,000 may be automatically distributed after termination of employment.

## **2. Summary of Accounting Policies**

### ***Annual Reporting Requirements***

Prior to January 1, 2009, TIAA and CREF maintained records at a contract, not a plan level and administratively decided not to provide accounting records and supporting documentation at the participant or plan level relating to certain annuity and custodial accounts issued to current and former employees. As such, neither the College nor TIAA and CREF have been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Prior to 2009, the Plan Sponsor utilized an additional custodian, Corebridge Financial, for the Plan and has elected to exclude from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to certain employees, as permitted by the Department of Labor's (DOL) Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The related investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits.

Specifically, the administrator of a 403(b) plan does not need to treat annuity contracts and custodial accounts as part of the employer's Title I plan or as plan assets for purposes of ERISA's annual reporting requirements provided that:

- The contract or account was issued to a current or former employer before January 1, 2009.
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact ceased making contributions to the contract or account before January 1, 2009.
- All of the rights and benefits under the contract or account are legally enforceable against the insurer or custodian by the individual owner of the contract or account without any involvement by the employer.
- The individual owner of the contract is fully vested in the contract or account.

In accordance with accounting principles generally accepted in the United States of America (GAAP), if the identified contracts were included, net assets available for benefits would increase by \$206,800 and \$198,875 as of December 31, 2024 and 2023, respectively. Further, a net investment gain of \$19,503 and benefit payments of \$11,548 related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. GAAP requires that these accounts and the related income and distributions be included in the accompanying financial statements.

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The investments of the Plan with the exception of fully benefit-responsive (FBR) investment contracts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The Plan's FBR investment contract with TIAA (Note 5) is valued at contract value. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Contributions Receivable*

Participant contributions are recognized in the period during which the College makes the respective payroll deduction from the participant's compensation.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the College and are excluded from these financial statements. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Investment gains and losses are presented net of investment management fees paid by the Plan in the statement of changes in net assets available for benefits.

### *Reclassifications*

Certain amounts in the 2023 financial statements have been reclassified to conform to the current year financial statement presentation. These reclassifications had no effect on the net assets available for benefits or the net increase in the net assets available for benefits as previously reported.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments as of December 31, 2024 and 2023, and dividend income, interest income from fixed annuity contracts, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

## **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Fixed Annuity Contracts* - The non-fully benefit responsive (NFBR) fixed annuity contracts, composed of the TIAA Traditional Annuity Contracts, are reported at fair value. Fair value is determined using a discounted cash flow model. The TIAA Traditional Annuity Contracts are not available for sale or transfer on any securities exchange. The fixed annuity accounts are subject to various restrictions. See Note 5.

*Pooled Separate Account (PSA)* - The PSA consists of units held in the TIAA Real Estate Account. The value of the PSA is determined at the close of each business data at unit value, which is based on the fair market value of the underlying investments of the account less its liabilities. The net asset value (NAV), as provided by TIAA, is used as a practical expedient to estimate fair value. The unit value of the PSA is published on NASDAQ; however, the PSA is not publicly traded. The PSA holds between 15% and 25% of its net assets in investments other than real estate and real estate related investments, comprised of liquid, fixed income investments. Determination of fair value of the real estate assets involves significant judgment. The value of the underlying real estate properties is determined by external appraisals generally on a quarterly basis, which are estimates based on professional opinions. The PSA provides participants with a liquidity guarantee enabling the account to have funds available to meet participant redemptions, transfers, or cash withdrawals. TIAA guarantees that the participants can redeem their accumulated unit value determined after their transfer or cash withdrawal request is received in good order.

TIAA limits the ability of participants to transfer funds into the TIAA Real Estate Account. Specifically, individual participants are limited from making internal transfers into their account if, after giving effect to such transfer, the total value of such participant's account (under all contracts issued to such participant) would exceed \$150,000. A participant is not required to reduce his or her contract balance to a level at or below \$150,000 if the participant's account totals more than \$150,000.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Other Registered Investments* - These investments are registered investments through variable annuity contracts issued by CREF that invest principally in equity securities, fixed-income

instruments, and short-term investments in accordance with each portfolio's investment objectives. Units held in the other registered investments are valued at NAV and are published daily on NASDAQ; however, the registered investments are not publicly traded. The NAV, as provided by CREF, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the other registered investments will sell for an amount different than the reported NAV. The NAV is measured based on the fair value of the underlying investments held by the fund less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that employ various pricing methods to value the investments including matrix pricing. Money market account holdings are generally valued at amortized cost. On a daily basis, units in these investments are revalued to reflect performance of the underlying investments minus any fees and charges.

The investment objectives for the other registered investments measured using the NAV are as follows:

- (a) *Multi-Asset* - This fund primarily invests in domestic and foreign stocks and other equity securities, bonds, and other fixed-income securities that reflect the investment performance of the financial markets while giving special consideration to certain social criteria.
- (b) *Equities* - These investments are primarily invested in a broad diversified portfolio of domestic and foreign common stocks to meet a specified favorable long-term rate of return.
- (c) *Fixed Income* - These investments are primarily invested in U.S. Treasury and other governmental securities, corporate bonds, and mortgage-backed securities with high income yields, returns that outpace inflation, or returns that are designed to track a specified inflation index.
- (a) *Money Market* - This investment is primarily invested in cash, U.S. government securities, and repurchase agreements that are collateralized fully by cash or U.S. government securities to maintain liquidity and preserve capital.
- (b) *Real Estate* - The investment objective of the TIAA Real Estate Account, the PSA offered by the Plan, is to generate favorable total returns primarily through rental income and appreciation of a diversified portfolio of directly held, private real estate investments and real estate related investments, while offering investors guaranteed, daily liquidity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

### 5. Fixed Annuity Contracts

As discussed in Note 4, fixed annuity contracts consist of investment options available to participants known as the TIAA Traditional Annuity Contracts (Annuity). Annuity contracts are established between the participants and TIAA, an insurance company registered in the state of New York. This investment option is offered in a variety of formats, including Retirement Annuities (RA), Group Retirement Annuities (GRA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The return of annuity contributions plus interest to participants is subject to TIAA's claims-paying ability.

Annuity accounts are credited with a guaranteed minimum rate of interest that is determined annually. Participants may also earn interest in addition to the guaranteed rate at the discretion of TIAA. Such discretionary interest, if any, is declared by TIAA on a year-by-year basis and remains in effect for the subsequent 12-month "declaration year".

Contributions to the annuity accounts are grouped by TIAA into "vintages" comprised of premiums received over defined time periods of one or more contiguous calendar months. The interest crediting rate for each vintage is determined, in part, by the net investment earnings rate of the TIAA assets supporting that vintage, minus a charge for administrative expenses and an amount set aside for contingency reserves. Crediting rates are also determined by the performance of investments contained in TIAA's general account.

Lump-sum withdrawals from the GRA account are permitted within 120 days following termination of employment and are subject to a 2.5% surrender charge. Other participant-initiated transfers or withdrawals from the GRA account may only be made in ten annual installments over a period of approximately nine years. RA account balances may only be withdrawn over ten annual payments. Because these provisions are considered to restrict participants' "reasonable access" to their contract balances, RAs and GRAs are not considered to be fully benefit-responsive investment contracts as defined by ASC 962, *Plan Accounting-Defined Contribution Pension Plans*.

SRAs and GSRA are considered fully benefit-responsive investment contracts, because they are fully liquid and immediately cashable once a participant terminates employment with the Employer (unless they are pledged as collateral on loans). See Note 1.

### 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by TIAA, CREF, and Nuveen, an affiliate of TIAA. TIAA and CREF are the Plan's insurance providers, recordkeeper, and custodian. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 7. Plan Termination

Although it has not expressed any intent to do so, the College has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the participants would remain 100% vested in their Plan assets.

### 8. Tax Status

The Plan sponsor adopted the ERISA 403(b) Volume Submitter Plan document with an effective date of March 1, 2018. The 403(b) Volume Submitter Plan document received a favorable opinion letter from the Internal Revenue Service (IRS) on August 7, 2017, stating that the written form of the underlying standardized plan document is qualified under Section 403(b) of the IRC and that any employer adopting the standardized plan is considered to have a qualified plan under the IRC and qualify as exempt from taxation. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. At December 31, 2024, two investments comprised 24% of total net assets available for benefits. At December 31, 2023, one investment comprised 17% of total net assets available for benefits.

### 10. Subsequent Events

The Plan has evaluated subsequent events from the date of the statement of net assets available for benefits through October 15, 2025, the date the financial statements were available to be issued.
