Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matters – Supplementary Information Required by ERISA***

The supplementary information listed in the table of contents as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplementary information, other than the information in the supplementary information that agrees to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplementary information related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to Financial Statements

### **Note 1. Description of the Plan**

The following description of the Plumbers and Steamfitters Local 60 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### **General**

The Plan is a multi-employer, defined contribution participant-directed 401(k) pension plan established effective June 1, 2001, under the provisions of an Agreement and Declaration of Trust, as amended, pursuant to a collective bargaining agreement between the Plumbers and Steamfitters Local 60 Union (the Union) and the Mechanical Contractors Association of Louisiana, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings. The Plan covers all persons employed by contractors covered under the collective bargaining agreement. The Plan also covers employees of the Union, the Plumbers and Steamfitters Local 60 Education Fund and the Plumbers and Steamfitters Local 60 Health and Welfare Fund. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### **Contributions**

##### Participants

Contributions are made to the Plan by participants who may elect to defer from 1% to 50% of their annual compensation by a salary reduction election, subject to certain Internal Revenue Service imposed limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of both theirs and employers' contributions into various investment options offered by the Plan.

##### Employers

Each employer shall contribute to the Plan a discretionary amount determined by each contributing employer pursuant to the terms of the collective bargaining agreement. In addition, each contributing employer may contribute a discretionary matching contribution on behalf of employees who are eligible to share in matching contributions for the plan year. Notwithstanding the foregoing, however, the contributing employer's contributions for any plan year shall not exceed the maximum amount allowable as a deduction to the employer under the provisions of Internal Revenue Code Section 404.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the employer's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements

### Vesting

Participants are fully vested at all times in their participants' accounts attributed to Participant Elective Deferrals, Employer Elective Contributions, and Employer Non- Elective Contributions. The vested portion of any participant's account attributable to Employer Matching Contributions shall be a percentage of the total amount credited to his participant account determined on the basis of the participant's number of years of service according to the following schedule:

Two	20%
Three	60%
Four	100%

### Investment Options

The Plan has investment fund options which are offered pursuant to contracts with Prudential Financial Services, Inc., the trustee of the Plan. Each participant may direct their contributions among the specific funds in multiples of 5%.

### Payment of Benefits

A participant is entitled to receive, upon the earlier of the participant's death, total and permanent disability, early or normal retirement, or after the attainment of age 59 1/2, the amount in his or her vested portion of the combined account. If a participant permanently terminates covered employment before any of the above events occur, the participant can receive a full distribution of the vested portion of the terminated participant's combined account, on the earlier of 24 months from the date covered employment terminates, or the date the participant becomes a pensioner. The normal form of benefit is a lump sum payment.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled of \$111,822 and \$44, respectively. These accounts will be used first to reduce the Plan's ordinary and necessary administrative expenses for the plan years in which they are incurred, and second, any remaining forfeitures shall be allocated to participants' accounts. No amounts were used to reduce the Plan's ordinary and necessary administrative expenses during the years ended December 31, 2024 and 2023.

## Note 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Notes to Financial Statements

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's losses and gains on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and the matching contributions from the contributing employers are recorded in the year in which the employee contributions are withheld from compensation.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Expenses of maintaining the Plan are paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

### **Plan Management's Review of Subsequent Events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

### **Note 3. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (EAICA), the trustee/custodian of the Plan. EAICA held the Plan's investment assets and executed investment transactions from January 1, 2023 to December 31, 2024.

The Plan has a fully-benefit-responsive group annuity contract (GAC) with EAICA. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GAC is included in the financial statements at contract value as reported to the Plan by EAICA. The contract value represents the principal balance plus contributions, earnings, and interest, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the GAC. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

## Notes to Financial Statements

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-off of a subsidiary) that cause significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at NAV of shares held by the Plan at year end based on quoted market price. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(a) The various Empower Annuity Insurance Funds seek a balance between growth and conversion of capital. They are multi-asset portfolios that become more conservatively invested over time. The investment objective of the Funds is to perform consistent with its custom blended benchmark over a full market cycle.

#### Note 5. Guaranteed Annuity Contract with Empower Annuity Insurance Company

During 2024 and 2023, the Plan held a fully benefit-responsive guaranteed annuity contract (GAC) with EAICA. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GAC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4 percent. The crediting rate is reviewed on a quarterly basis for resetting. The GAC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

## Notes to Financial Statements

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligation under the contract, (2) a material misrepresentation, or (3) a material amendment to the agreement without the consent of the issuer.

### **Note 6. Related Party and Party-in-Interest Transactions**

The Plan is related to jointly administered, collectively bargained, employee benefit plans connected to the Union. Since these plans and the Union exist in the same premises utilizing mutual resources and personnel to effectuate cost-savings and to minimize duplication of efforts, relationships have been established on a continuing basis.

Direct expenses are charged to the appropriate organization and common administrative expenses are allocated to the applicable organization based on predetermined percentages. The amounts charged and/or allocated to or from the other plans and the Union totaled \$15,909 and \$14,835 for the years ended December 31, 2024 and 2023, respectively.

Certain plan investments are managed by Empower Annuity Insurance Company Inc., the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### **Note 8. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated August 7, 2012, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Of the participating employers, two and three employers represent approximately 27% and 31% of total contributions for the years ended December 31, 2024 and 2023, respectively, and approximately 43% and 13% of total contributions receivable at December 31, 2024 and 2023, respectively.
