We have performed audits of the financial statements of VEVO 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the VEVO 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan effective as of July 1, 2009, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

UMG Recordings, Inc. (UMG) administered the Plan from the inception through December 31, 2012. VEVO LLC (the Company or Plan Sponsor) assumed the responsibility of administering the Plan as of January 1, 2013.

Eligibility: As defined in the Plan document, all employees on the payroll of the Company are eligible to participate in the Plan, except for the following:

- Union employees
- Nonresident aliens
- Leased employees
- Temporary employees who work for fewer than 1,000 hours in the year of eligibility determination

Eligible full-time and part-time participants may enroll immediately upon employment and temporary employees must reach 1,000 hours of service in a 12-month period to become eligible to enroll.

Contributions: Each year, non-highly compensated employees, as defined by the Plan, may elect to contribute to their pre-tax accounts on a pre-tax basis (Pre-Tax Contributions) and/or to their after-tax accounts on an after-tax basis (After-Tax Contributions) through payroll deductions of 1% to 25% (in the aggregate) of their annual salary (as defined in the Plan), in multiples of 1%, in any combination. Highly compensated employees, as defined by the Plan, may contribute up to 10% (in the aggregate) of their annual salary to their pre-tax and after-tax accounts. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan, at its discretion, will accept into participants' rollover accounts cash received by participants from a qualified plan within the time prescribed by applicable law (Rollover Contributions). Pre-Tax Contributions and After-Tax Contributions are subject to limitations imposed by federal laws for qualified retirement plans.

The Plan provides for matching contributions by the Company payable to the participants' Company match accounts. The Company matches 60% of the participants' contributions up to the first 6% of the participants' eligible compensation each payroll period. The Company's contributions are subject to limitations imposed by federal laws for qualified retirement plans.

The Plan also provides for profit-sharing contributions by the Company. This contribution is a discretionary contribution and is determined by the Company. Eligible participants must be employed with the Company as of the end of the Plan year to be eligible for profit sharing contributions. There were no profit sharing contributions paid or payable to the Plan as of December 31, 2024.

Participants may elect to have their contributions and matching contributions invested in a variety of investment funds. Investment elections or contribution rate changes can be changed on any business day and must be made in increments of 1%. The Plan currently offers various mutual funds, pooled separate accounts and the guaranteed fund as investment options for participants.

Note 1. Description of the Plan (Continued)

Participant accounts: Each participant's account is credited and debited with the participant's contributions and withdrawals, as applicable, and an allocation of (a) the Company's matching contribution, (b) the Company's profit sharing contribution (if applicable), and (c) Plan earnings. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: A participant in the Plan shall always be 100% vested in his or her own contributions and in his or her Company match account upon participant's death or disability (as defined in the Plan). Upon termination of employment for any other reason, a participant vests in the funds held in his or her Company match account and profit-sharing account in accordance with the following vesting schedule:

Upon termination of employment for reasons other than the death or disability of a participant who was not fully vested in his or her Company match account, the nonvested portion of the participant's Company match account shall be forfeited. Any account forfeited shall be used to reduce the Company's contributions and to pay reasonable administrative expenses in accordance with the terms of the Plan. Any amount forfeited shall be restored if the participant is reemployed by the Company before incurring a five-year break in service and if the participant repays to the Plan (within five years after his or her reemployment commencement date) an amount in cash equal to the full amount distributed to him or her from the Plan on account of termination of employment, excluding amounts from the after-tax and rollover accounts at the participant's election.

The Plan also allows recognition of service with other employers, specifically, if VEVO LLC directly hires an employee immediately following employment with UMG Recordings, Inc. or Sony Music Entertainment; former employees of Sony Music Entertainment hired on or before January 1, 2010, shall be fully vested.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the value of the vested portion of the participant's accounts. The maximum repayment terms are five years for general purpose loans and 15 years for primary residence loans. Applications for loans must be approved by Principal Trust Company (the custodian). The amounts borrowed are transferred from the investment funds in which the participant's accounts are currently invested.

Repayment and interest thereon are credited to the participant's current investment funds through payroll deductions made each pay period. The notes receivable from participants are secured by the vested balance in the participant's account and bear interest at a rate ranging from 4.25% to 9.25% at December 31, 2024 and 2023. The interest rate for notes receivable from participants is based on the prime rate as received by the custodian from *The Wall Street Journal* on the first business day of the month in which the loan is made plus one percentage point.

Note 1. Description of the Plan (Continued)

Payment of benefits: Upon termination of employment, or for reason of death or disability, the participant or his or her beneficiary shall receive the value of his or her accounts. However, if the termination of employment is for reasons other than death or disability, the participant shall receive only the value of the vested funds in his or her accounts.

In accordance with the procedures established by the Administrative Committee and the terms of the Plan, certain terminated employees may elect to defer final distribution from the Plan. Upon such election, the amount of such participants' vested interest in the Plan is entitled to continue to receive investment income and losses and is held by the custodian until the date of distribution as elected by the participants. Prior to termination of employment, the participant may withdraw amounts from the participant's accounts in accordance with the provisions of the Plan.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$13,555 and \$3, respectively. These accounts may be used to reduce future employer contributions or pay reasonable Plan expenses. The Company used approximately \$11,381 of forfeitures to pay administrative expenses of the Plan and \$353,114 of forfeitures to pay employer contributions owed to the Plan during 2024.

Note 2. Summary of Significant Accounting Policies

The Plan's significant accounting policies are as follows:

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition: The Plan's investments are reported at fair value, except for the fully benefit-responsive group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Contract value is the relevant measure for the portion of the net assets available for benefits of the Plan attributable to direct investments in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are treated as distributions based on the terms of the Plan document.

Note 3. Information Certified by the Custodian

Note 4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures (FASB ASC 820), provides the framework for measuring fair value. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

All transfers between fair value hierarchy levels are recognized by the Plan at the end of each reporting period. There were no transfers between Levels 1, 2 and 3 during the year.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Prices are obtained from readily available sources for market transactions involving identical assets or liabilities and these are classified as Level 1 investments.

Pooled separate accounts: Pooled separate accounts are valued at the NAV or equivalent based on units of the pooled separate accounts held by the Plan. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Guaranteed Fund Contract

The Plan has a fully benefit-responsive group annuity contract with Principal Life Insurance Company. The group annuity contract, Principal Guaranteed Option, is a fixed income account that is part of the general account of Principal Life Insurance Company. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium long-term portfolio compared to the minimum interest crediting rate, and prevailing market conditions. The interest crediting rate is reset semi-annually. As described in Note 2, contract value is the relevant measurement attributable for this fund. The contract value was \$40,494 and \$35,757 as of December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include premature termination of the contracts by the Plan, Plan termination, Sponsor bankruptcy and early retirement incentives. The Plan Administrator believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The insurance company may not terminate the contract at any amount less than the contract value.

The average yield earned by the Plan is derived by averaging the semi-annual gross interest rates for the fund over the year. The average yield for the years ended December 31, 2024 and 2023, was 4.85% and 4.35%, respectively. The actual average yield by the Plan is derived by averaging the Plan's semi-annual interest rates. The actual average based on earnings for each of the years ended December 31, 2024 and 2023, was 4.61% and 4.35%, respectively.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Tax Status of Plan

The Internal Revenue Service has determined and informed the Company, by a letter dated July 15, 2010, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Sponsor's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that required adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the board of directors of the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire accounts.

Note 9. Related-Party Transactions

Some of the Plan's expenses, including trustee, custodial and certain record-keeping fees, were paid by the Company for the year ended December 31, 2024.

Note 10. Subsequent Events

The Plan Administrator has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
