We have performed audits of the financial statements of the TriHealth 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Description of the Plan

The following description of the TriHealth 401(k) Retirement Savings Plan (the Plan) provides general information about the Plan's provisions. TriHealth, Inc. (the Company) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Company.

General

The Plan is a defined contribution plan with a cash or deferred arrangement for the benefit of certain eligible employees of the Company and other related organizations. The related organizations that participate in the Plan are as follows: Bethesda Hospital, Inc.; Bethesda, Inc.; Bethesda Healthcare, Inc.; The Good Samaritan Hospital of Cincinnati, Ohio; TriHealth G, LLC; TriHealth OS, LLC; TriHealth W, LLC; TriHealth Digestive Diseases Institute, LLC; TriHealth Surgical Institute, LLC; TriHealth Hospital, Inc.; TriHealth H, LLC; TriHealth CIPHO, Inc.; TriHealth Heart Institute, LLC; TriHealth HF, LLC; TriHealth Oncology Institute, LLC; TriHealth Physician Enterprise Corp.; TriHealth Physician Institute; TriHealth Physicians Practices, LLC; Bethesda Healthcare, Inc.; and TriHealth Q, LLC (collectively, the Companies).

The Retirement Plan Committee of the Plan (the Committee) is responsible for the general administration of the Plan. Empower Trust Company, LLC (formerly known as Great-West Trust Company, LLC) and Empower Annuity Insurance Company of America (formerly known as Great-West Life & Annuity Insurance Company) are the trustees of the Plan (the Trustees) and Empower Retirement is the record-keeper and third-party administrator for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Eligibility for purposes of participant contributions is one hour of service. Participants who have attained or will attain the age of 50 before the close of a plan year are eligible to make a catch-up deferral contribution. If a participant receives, or is entitled to receive, a qualifying distribution from another eligible employer plan or from an individual retirement account or annuity, he or she may "roll over" such amount, or request that the trustee of the other plan roll over such amount, into a rollover account upon approval of the Committee or its representative.

Participants may elect to contribute from 1% to 80% of their pre-tax or after-tax eligible compensation to the Plan, subject to maximum dollar contribution limits of the Internal Revenue Code (the Code).

Notes to Financial Statements

1. Description of the Plan (continued)

Eligible participants are automatically enrolled in the Plan. A participant must submit an election with the third-party administrator if he or she does not wish to participate in the Plan. The automatic enrollment contribution is 3% of a participant's eligible compensation, with an increase of 1% annually up to 10%.

The Companies make a safe harbor contribution on behalf of each participant who makes a salary deferral contribution, a Roth deferral contribution, or a catch-up deferral contribution for the plan year. The Companies will match 100% of the first 1% of each eligible participant's deferred contribution and 50% of the next 5% of each eligible participant's deferred contribution. The aggregate amount of the safe harbor contributions made by the Companies shall not exceed 3.5%.

In addition, the Companies also make an annual contribution to eligible participants based on a formula ranging from 1.5% to 3.5% of their annual eligible compensation. The Companies also make certain non-elective supplemental contributions, including (1) 1.5% to 3.5% of eligible compensation for any participant who has pay in excess of the annual Social Security wage base and (2) 2% of annual eligible compensation for all participants with an average hourly rate less than \$16.00 for the plan year.

All contributions are subject to certain limitations of the Code.

Investment Options

Participants direct their elective contributions into various investment options offered by the Plan. Unless the participant chooses a different investment option, their participant account will be invested in the T. Rowe Price Target Date Fund based on their age at enrollment. Participants can change their contribution allocations daily and may elect to transfer amounts between investment options throughout the plan year. The Companies' contributions are allocated in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant account is credited with the participant contributions, eligible contributions of the Companies, and allocations of Plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

1. Description of the Plan (continued)

Vesting

Participants are immediately vested in their salary deferral contributions, Roth deferral contributions, and rollover contributions. Vesting in the Companies' contributions is based on years of service. A participant is 100% vested after two years of credited service.

Forfeitures

Forfeitures represent the non-vested portions of participant account balances upon termination. Forfeited balances of terminated participants' non-vested accounts are first applied to the restoration of forfeitures, as applicable, then used to reduce future contributions by the Companies. During the year ended December 31, 2024, \$674,884 of forfeitures were used to reduce the Companies' contributions for the year ended December 31, 2023. As of December 31, 2024 and 2023, forfeitures of \$1,306,541 and \$541,126 were available for application against future contributions of the Companies and are included as forfeiture asset holding and unallocated plan assets on the statements of net assets available for benefits.

Participant Loans

A participant may request a loan from their account by electronically contacting the Empower Retirement Participant Service Center. Only participants who are actively employed by the Companies are eligible to apply for a loan. The minimum amount a participant can borrow is \$1,000. The maximum amount of the loan is the lesser of: (a) one-half of the combined total of the participant's salary deferral account, Roth deferral account, and rollover account, or (b) \$50,000. Participants may have only one loan outstanding at any time.

Interest will be charged at 1% over the prime interest rate in effect when the loan is processed. Loans normally will be repaid through payroll deductions. Generally, the term of a loan may not exceed five years; however, if the loan is for the purchase of a primary residence, the Committee may permit a longer repayment period at its discretion.

Payment of Benefits

Participants become eligible for benefit payments upon retirement, termination of employment, disability, or death, at which time benefits are distributed in a single sum equal to their vested balance.

1. Description of the Plan (continued)

Benefits under the Plan generally are not distributed while a participant is actively employed by the Companies. However, at the attainment of age 59½, participants may elect to receive a distribution of all or a portion of the vested amount in their participant account.

Participants may withdraw amounts from their participant accounts for financial hardship if certain conditions are met. This hardship distribution is not in addition to other benefits and, therefore, will reduce the benefit that will be received at retirement.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include record-keeping and trustee fees. Expenses relating to purchases, sales, or transfer of the Plan's investments are charged to the particular fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements.

Plan Termination

The Company has not expressed any intent to terminate the Plan; however, it may do so at any time subject to the provisions of ERISA. In the event of such termination, all participant accounts shall become fully vested and subject to distribution under provisions of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The significant accounting policies followed in the preparation of the financial statements, which have been prepared on the accrual basis of accounting, are as follows.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned and included in interest and dividend income. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Contribution Receivable from Employer

The contribution receivable from employer represents the amount to be funded to the participant accounts after the statement of net assets available for benefits date. The contribution receivable from employer at December 31, 2023, was funded in March 2024. The contribution receivable from employer at December 31, 2024, is net of \$1,364,338 of forfeitures that were applied against the contribution amount when funded.

Other Income

Other income is comprised of the net appreciation in fair value of investments held in self-directed brokerage accounts and the revenue from the revenue credit arrangement with the record-keeper.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit-responsive investment contracts with Empower Annuity Insurance Company of America) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price).

2. Summary of Significant Accounting Policies (continued)

Management is responsible for determining the Plan's valuation policies and analyzing information provided by the investment custodians and issuers that is used to determine the fair value of the Plan's investments. Management reports to the Committee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in a fully benefit-responsive guaranteed investment contract. Contract value is the relevant measurement attributable to the fully benefit-responsive guaranteed investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive guaranteed investment contract represents contributions plus earnings less participant withdrawals and administrative expenses.

Fair Value Measurements

In conformity with Accounting Standards Codification Topic 820, *Fair Value Measurement*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

- Level 1 – Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2 – Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 – Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management's judgment about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety. See Note 4 for further discussion and disclosures related to fair value measurements.

3. Investments

All investment information and notes receivable from participants for the Plan presented and disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value, group annuity contract at contract value, forfeiture asset holding, unallocated plan assets, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and other income for the year ended December 31, 2024, were obtained or derived from information provided to the Company and certified as complete and accurate by the Trustees of the Plan.

4. Fair Value Measurements

5. Fully Benefit-Responsive Investment Contract

The Plan holds a traditional investment contract with Empower Annuity Insurance Company of America that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made, plus earnings, less participant withdrawals and administrative expenses. The traditional investment contract is a fully benefit-responsive group annuity contract at contract value. The contract issuer, Empower Annuity Insurance Company of America, is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. Such events include:

- Plan termination or merger
- Premature termination of the contract
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor event (e.g., divestitures or spin-offs of a subsidiary) that significantly affects the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan’s investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

8. Related-Party and Party-in-Interest Transactions

The Plan holds a group annuity contract issued by the Trustee of the Plan. The related transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

9. Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

9. Tax Status (continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Subsequent Events

Management evaluated subsequent events for the Plan through October 15, 2025, the date the accompanying financial statements were available to be issued.
