Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the EI-AI Israel Airlines, Ltd. Employees' Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the EI-AI Israel Airlines, Ltd. Employees' Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. - 1. Description of Plan** The following summary description of the El-Al Israel Airlines, Ltd. (the "Company") Employees' Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.
- General** The Plan is a defined contribution plan covering most employees of the Company who have completed thirty days of eligible service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- Contributions** Participants may contribute up to 80% of their annual compensation (as defined) each plan year through payroll deductions, subject to limitation. There are two types of elective deferrals available to participants: pre-tax and Roth deferrals. The Plan contains an automatic salary deferral feature which through December 31, 2023 was 4% of an eligible participant's compensation, unless the participant made an affirmative election. Pursuant to an amendment executed by the Plan, effective January 1, 2024, the automatic salary deferral is 6% of an eligible participant's compensation, unless the participant makes an affirmative election. Salary deferral contributions for automatically enrolled participants will automatically be increased by 1% each year up to 10%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.
- The Company makes contributions to the Plan known as profit sharing contributions, for those participants with at least six months of eligible service. Through December 31, 2023, the contribution amount was equal to 2.5% of each participant's compensation, as defined. Pursuant to a amendment executed by the Plan, effective January 1, 2024, matching contributions are now at the discretion of the Plan Sponsor.
- Participants may also rollover part or all of an "eligible rollover distribution" received from a prior employer's qualified plan.
- Participant Accounts** Each participant's account is adjusted to reflect contributions, withdrawals, distributions, investment fund transfers and reallocations, income earned or accrued, expenses paid from the assets of the Plan and any increase or decrease in the fair market value of the assets of the Plan. Adjustments are based on participant account balances.
- Vesting** Participants are immediately vested in their voluntary contributions, the Company's matching contributions and non-elective contributions, plus actual earnings thereon.
- Forfeitures** Forfeited amounts, which consist of unclaimed distributions, are used to pay administrative expenses of the Plan or to offset the Company's contributions to the Plan. As of December 31, 2024 and 2023, there were no amounts available in the forfeiture account.

1. Description of Plan (Continued)

Payment of Benefits The Plan provides for normal retirement at age 65 or early withdrawal in certain instances at age 59½. The Plan permits distribution to participants upon termination of service, disability or death. Withdrawals from the Plan may also be made upon circumstances of financial hardship.

Plan Expenses The Plan's expenses are paid by the Plan, as provided by the Plan document and recorded as deductions in the accompanying statement of changes in net assets available for benefits.

2. Significant Accounting Policies

Basis of Accounting The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits Benefits are recorded when paid.

Subsequent Events The Company has evaluated events and transactions that occurred between December 31, 2024 and October 10, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

3. Investment Information Certified by the Plan Trustee

The following is a summary of the investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by, or derived from, information provided by Principal Life Insurance Company, ("Principal"), the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustee that such information is complete and accurate.

**4. Fair Value
Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: The fair value of the common collective trust is determined by the custodian of the common collective trust based on the underlying assets, which represents the net asset value (NAV). Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

Pooled Separate Accounts - Investments in pooled separate accounts are stated at fair value, which have been determined based on the unit values of the accounts. Unit values are determined by the custodian by dividing the account's net assets at fair value by its units outstanding at the valuation date. Pooled separate accounts are classified as Level 1 in the fair value hierarchy. Participant directed redemptions can be made on any business day and do not have a redemption notice period.

For the years ended December 31, 2024 and December 31, 2023, there were no changes in the fair value hierarchy methodology and no transfers of assets between levels within the fair value hierarchy.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. If the Plan is terminated, the total amount in each participant's account shall be distributed, as the Plan administrator shall direct, to him or for his benefit or continued in trust for his benefit.

6. Tax Status

On August 8, 2014, the Internal Revenue Service stated in an opinion letter that the prototype plan adopted by the Plan administrator was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and management believe that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, they believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. As of December 31, 2024, investments in two mutual funds and one common collective trust represents approximately 56% of total investments.

8. Party in Interest Transactions

The common collective trust and pooled separate account are managed by affiliates of Principal Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Other fees and expenses such as plan administration fees may be deducted directly from investment returns in accordance with applicable investment options selected by the participant. In addition, providers of other administrative fees (i.e., accounting) paid by the employer or the Plan are considered a party-in-interest as defined by ERISA.

Amounts due from trustee represent the inadvertent duplicate payment of certain fees, incurred in 2022-2023 that were reimbursed in 2024.

9. Prohibited Transactions

During 2023, the Company failed to deposit \$47,071 of participant deferrals within the required time frame as stated by the Department of Labor ("DOL") principally as a result of a misunderstanding in connection with a change in payroll companies. In addition, during 2024, the Company failed to deposit \$59,123 of participant deferrals within the required time frame, principally as a result of a change in personnel. The DOL considers late deposits to be prohibited transactions. In addition, in connection with the delinquent participant deferrals, there were delinquent employer match contributions in the amount of \$8,939 and \$15,287, for the years ended December 31, 2023 and 2024, respectively. The Company also failed to deposit \$4,196 of employer match contributions within the required time frame as a result of a clerical error in 2023, which was repaid in 2024. In October 2025, the effected participants were reimbursed for the majority of the lost earnings for both 2023 and 2024, outside the Voluntary Fiduciary Correction Program ("VFCP"). The Company plans to reimburse the effected participants for the remaining lost earnings outside the VFCP by the end of October 2025. Finally, during 2024 four new eligible participants' automatic salary deferrals were delayed by one pay period as a result of a clerical error. The Company also plans to reimburse these participants for lost earnings by the end of October 2025.
