Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of the Bellisio Foods, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

Notes to the Financial Statements

December 31, 2024 and 2023

NOTE 1: PLAN DESCRIPTION

The following description of the Bellisio Foods, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all nonunion employees of Bellisio Foods, Inc., and all employees of Overhill Farms, Inc. who have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may make pre-tax contributions to the 401(k) plan as defined in the Plan, up to the maximum allowable under the Internal Revenue Code. Beginning January 1, 2015, the automatic enrollment feature was added. All newly eligible participants will be enrolled at a 6% contribution rate. In addition, participants may make voluntary after-tax and rollover contributions subject to limitations. The Plan was amended on April 1, 2020 to allow for employee after-tax roth contributions. The employer may make discretionary matching contributions to the Plan each year. Effective July 1, 2019, matching contributions are made for all employees who were active participants at any time during the plan year. Participants direct the investment of the contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's matching contributions, if any; (b) the Company's discretionary contributions, if any; and (c) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their nonforfeitable account balance. The notes are secured by the balance in the participant's account and bear an interest rate between 5.25% and 10.5%. Principal and interest is paid ratably through regularly scheduled payroll deductions.

Payment of Benefits

On termination of service or upon reaching normal retirement age as defined by the Plan, a participant may elect to receive either a lump-sum amount equal to the vested balance in his or her account, or an annuity determined under the provisions of the Plan. Those participants with account balances of less than \$5,000 upon termination will be paid in a lump sum. The Plan allows in-service distributions under certain circumstances as defined by the Plan. Certain minimum distribution rules apply as defined by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$105,167 and \$102,041, respectively. These accounts will be used to pay administrative fees to Principal or will be used to reduce future employer contributions. Administrative fees of \$7,046 and \$106 were paid from forfeited nonvested accounts during 2024 and 2023, respectively. Employer contributions were reduced by \$174,508 and \$117,770 during 2024 and 2023, respectively.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statement of the Plan is prepared under the accrual method of accounting.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Plan sponsors. No officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan or the Plan sponsors.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclose contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Excess contributions payable are recorded for refunds to participants resulting from contributions made in excess of Plan guidelines or Internal Revenue Service limitations.

Administration Expenses

Plan administrative services are paid for by both the Plan and the Company.

Subsequent Events

Plan management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Value determined by Principal Life Insurance Company at the NAV per unit held by the Plan based on the publicly quoted prices of the underlying assets less any daily mortality and expense risk and administrative charges, if any.

Common/collective trust funds: Valued at net asset value (NAV) of units of the common/collective trust which is based on the fair value of the underlying assets less account level expenses as reported in the audited financials of the trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (issuance and redemptions) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 6: PLAN AMENDMENTS AND TAX STATUS

The Plan adopted a non-standardized Pre-Approved Profit Sharing Plan, which received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan Sponsor and the Plan Administrator believe that the trust continues to qualify and to operate within applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. Therefore, they believe the Plan was qualified and the related trust was tax exempt as of December 31, 2024. U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

The Plan was amended and restated effective February 18, 2022. The amendment and restatement was to bring the Plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37 (i.e., the 6-year pre-approved plan restatement cycle).

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8: PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate accounts and a general investment fund managed by Principal Life Insurance Company and Trust Company. Principal Life Insurance Company is the custodian of the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan paid administrative fees totaling \$120,147 and \$109,634 to Principal Life Insurance Company during 2024 and 2023, respectively.

Without a complete system of internal controls to accomplish this function, the potential of missing disclosures exists. Because the Plan does not have a system of internal controls to accomplish this function, we are required to disclose this as a deficiency in your Plan's internal control to those in charge of governance. As is inherent in many Plans, the Plan and the Plan's sponsor has management and employees who, while knowledgeable, skillful and competent in fulfilling the daily and monthly functions, do not have the time to maintain the current knowledge and expertise to fully apply U.S. GAAP in preparing financial statements and the related disclosures. The Plan's management has determined that it is not cost beneficial to obtain the necessary U.S. GAAP training for retirement benefits department personnel to prepare the once a year function.

Although our firm has assisted with the preparation of your financial statements and related note disclosures, the Plan's management has reviewed the statements and has accepted responsibility for these statements as their own.

All significant transactions have been recognized in the financial statements in the prior period.

Accounting estimates are an integral part of the financial statements and are based on your knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Plan management's estimate of fair value of the investments which was based on the assumptions listed in Note 4 and the adopted accounting pronouncements ASU 2015-07 and ASU 2015-12. We evaluated the key factors and assumptions used to develop the fair value of the investments in determining that it is reasonable in relation to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.
