We have performed audits of the financial statements of Spotco, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Plan Description

The following description of the Spotco, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Spot and Company of Manhattan, Inc. (Plan Sponsor) on January 1, 1999, and most recently restated on May 1, 2024, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is operated for the exclusive purpose of providing benefits to employees of the Plan Sponsor and adopted controlled groups (Reach4Entertainment Inc. and Enhanced Outdoor, LLC) who have completed three months of service, are at least 21 years old and are not members of a collective bargaining agreement or non-resident aliens. Entry date will be the first day of each month after the date eligibility requirements are satisfied. The Plan's investments are 100% participant directed. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees. ADP Workforce Solutions is the custodian and recordkeeper of the Plan beginning May 1, 2024.

Contributions: The Plan provides for the following contributions, which are to be maintained in separate accounts for each participant:

Employee contributions: Each year, participants of the Plan may elect to contribute up to 100% of eligible annual compensation, as defined in the Plan, subject to the maximum amount allowed by the Internal Revenue Code (IRC), as defined, up to the maximum allowable by the Internal Revenue Service (IRS). Roth deferrals are allowed. Participants aged 50 and over may elect to defer additional amounts (catch-up contributions) to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Employer contributions: The Plan Sponsor will make a matching contribution in an amount equal to 50% of the employee contributions that are not in excess of 6% of eligible compensation. Additionally, discretionary contributions may be made at the option of the Plan Sponsor. There were no such discretionary contributions for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the employee's contributions and employer contributions, as well as allocations of plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Employee contributions are credited to their respective accounts, as directed, as soon as practicable, after receipt. Investment income is allocated daily.

Participant investment options: Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan. Participants are allowed to change their investment options on a daily basis.

Note 1. Plan Description (Continued)

Vesting: Participants are vested immediately in their employee contributions, plus actual earnings thereon, plus catch-up contributions and any rollover contributions made to the Plan. Participants vest in any employer contributions based on the vesting schedule as described in the Plan. Vesting in the employer contributions are based on a five-year vesting schedule with 25% after two years of service, 50% after three years of service, 75% after four years of service and fully vested after five or more years of service. Participants also become fully vested upon attainment of normal retirement age while an employee, death while an employee, or disability while an employee. Upon retirement or termination of service, any non-vested amounts will be forfeited.

Notes receivable from participants: The Plan permits participants to borrow a minimum of \$1,000, up to 50% of their vested account balance, not to exceed \$50,000. Notes receivable must be repaid over a period not extending beyond five years from the date of the note receivable, unless such note receivable is used for the purchase of primary residence, in which the note term is up to 20 years. The maximum number of notes receivable outstanding at any one time is unlimited. For the year ended December 31, 2024, the interest rate on notes receivables is commensurate with local prevailing rates. Principal and interest are paid through payroll deductions from each regular paycheck.

Payment of benefits: Benefits are paid to the participant or beneficiary upon death, hardship, retirement or termination of employment or attaining the age of 72, up to the amount of the participant's vested account balance. Once a participant has reached the age of 59½, distributions may be made at the participant's election. The Plan allows for the automatic lump-sum distribution of terminated participants' vested account balances that do not exceed \$5,000.

Forfeited accounts: Forfeitures may be used to reduce plan administrative expenses or future employer contributions to the Plan. A forfeiture will occur in the plan year that the participant receives a distribution of their vested account. Forfeited nonvested accounts totaled \$33,616 and \$5,566 at December 31, 2024 and 2023, respectively. During 2024, \$90,412 were used to reduce employer contributions and no forfeitures were used to pay administrative expenses.

Note 2. Significant Accounting Policies

Basis of accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Contributions: Contributions from plan participants, and the matching contributions from the employer are recorded in the year in which participant contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Valuation of investments and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Note 2. Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of benefits: Benefit payments to participants are recorded when paid.

Administrative expenses: The Plan permits payment of plan expenses from plan assets. If expenses are paid using the Plan's assets, the expenses will generally be allocated among all participants and allocated proportionally based on the value of the account or as a dollar amount based on the number of participants. Expenses directly attributable to a plan participant are deducted directly from the participant's account.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 14, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Shares of pooled separate accounts: Valued at the total of the net asset value (NAV) of shares of mutual funds held by the account at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value.

Note 4. Fair Value Measurements (Continued)

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust fund at readily determinable fair value: Valued based on daily published NAV per unit which is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less liabilities.

Classifications within the fair value hierarchy table are based on the lowest level of any input that is significant to the fair value measurement. The following tables set forth by level, within the fair value hierarchy, the Plan's assets measured at fair value as of December 31:

Note 5. Related-Party and Party-in-Interest Transactions

Investments are managed by John Hancock Life Insurance Company of New York, the former trustee. These transactions, therefore, qualify as party-in-interest. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Plan Sponsor. There were \$8,678 of fees paid by the Plan for recordkeeping services in 2024. In addition, certain administrative functions are performed by the Plan Sponsor or employees of the Plan Sponsor for which no compensation is received from the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 8. Income Tax Status

The Plan has adopted a non-standardized form of a preapproved defined contribution plan sponsored by ADP, LLC. The pre-approved plan received an opinion letter from the IRS dated October 6, 2020 as to the pre-approved plan's qualified status.
