Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of EFCO Contribution and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. We have performed audits of the financial statements of EFCO Contribution and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Plan Description

The following description of EFCO Contribution and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan covering all eligible employees of EFCO Corp. (EFCO); Wilian Holding Company, EFCO's parent; and any domestic subsidiary of Wilian Holding Company (collectively, the Company). Employees are eligible immediately to make elective deferral contributions and receive employer matching contributions. Effective March 25, 2019, employees whose compensation is determined under the terms of a collective bargaining agreement became allowed to participate in the Plan. Employees become eligible to receive discretionary profit-sharing contributions after one year of qualified service. The Fiduciary Review Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (IRC) provisions.

Eligible employees are requested to complete a salary reduction agreement which determines their deferral rate and investment elections. Failure to complete this enrollment form results in the eligible employee being automatically enrolled with a 5% contribution by the employee and an automatic selection of a Vanguard Institutional Target Retirement Fund option based upon the birth date of the participant.

Contributions and investment options: Each year, participants may contribute a stated dollar amount or percentage of their compensation, subject to an annual limit, as defined by the Plan. The Company provides a matching contribution up to 100% of the first 3% of the employee contribution and 50% of the next 2% of base compensation that the participant contributes to the Plan. The Company may also make a discretionary profit-sharing contribution; no such discretionary contribution was made during 2024. Participants may direct the investment of employee and employer contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a common collective trust fund. Participants may change their investment options at any time.

Participant accounts: Each participant's account is credited with the participant's contribution and the Company's matching contributions and allocations of the Company's discretionary profit-sharing contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations of Plan earnings and administrative expenses are based upon the participant's account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Participants become immediately vested in employer matching contributions. Participants cliff vest in employer discretionary profit sharing contributions after three years of service, as defined by the Plan.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from one to five years or in the case of a mortgage loan, 10 years. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by Vanguard Fiduciary Trust Company, the custodian. Principal and interest are paid ratably through payroll deductions. Notes receivable outstanding at December 31, 2024, had maturity dates ranging from January 2025 to July 2034 and bear interest between 4.25% and 9.50%. Notes receivable outstanding at December 31, 2023, had maturity dates ranging from February 2024 to December 2028 and bear interest between 4.25% and 9.50%.

Note 1. Plan Description (Continued)

Payment of benefits: Participants or their beneficiaries are eligible for benefits upon retirement, termination, death or disability. If the value of the participant's vested balance is under \$5,000, the participant may roll over the amount into another qualified plan or receive a lump-sum distribution. If the vested balance is \$5,000 or more, the participant may roll over the amount into another qualified plan, receive a lump-sum payment or annuity payments in substantially equal installments over a time period not to exceed the life expectancy of the participant or, if applicable, the joint life expectancies of the participant and designated beneficiary.

Forfeitures: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$82,000 and \$76,000, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses. During the year ended December 31, 2024, forfeitures of \$0 from nonvested account balances were used to reduce employer contributions.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Accounting estimates and assumptions: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Investment valuation and income recognition: Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fiduciary Review Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent loans are treated as distributions based upon terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3. Administrative Expenses

Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a termination of the Plan, participants will become 100% vested in their accounts and accounts shall be disbursed to all participants after participation in any additional earnings credited, expenses charged and appreciation or depreciation of assets. No part of the assets of the Plan will be used for the benefit of the Company at any time.

Note 6. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party Transactions

Certain Plan investments are shares of mutual funds and a common collective trust managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian totaled \$52,815 for the year ended December 31, 2024. The Company also pays certain administrative expenses on behalf of the Plan.

Note 8. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board Accounting Standards Codification requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the topic establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active or other inputs that are observable or can be corroborated by observable market data.
- Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

A description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. The level to which an asset or liability is classified is based upon the lowest level of input that is significant to the fair value measurements. There have been no changes in valuation methodologies at December 31, 2024 compared to December 31, 2023. The Plan's policy is to recognize transfers between levels at the date of the change in circumstances. The Plan did not make any transfers between levels during the year ended December 31, 2024.

Common collective trust fund: The common collective trust fund is valued using net asset value as a practical expedient to estimate fair value. The net asset value is based upon the fair value of the underlying investments comprising the trust fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Mutual funds: Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

The investments are designed to deliver safety and stability by preserving principal and accumulated earnings.

Note 10. Prohibited Transactions

During the year ended December 31, 2024, the Plan sponsor inadvertently failed to deposit \$707,066 of participant deferrals within the required time frame as stated by the DOL. The DOL considers late deposits to be prohibited transactions. The Plan sponsor will file form 5330 and reimburse the Plan for lost interest in 2025. The excise tax payments will be made from the Plan sponsor's assets and not from the assets of the Plan.
