**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We were engaged to perform audits of the financial statements of The Children's Aid Society Voluntary Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Disclaimer of opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

**Basis for disclaimer of opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to date, such as January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

**Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

**Other matter – supplemental schedules required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### NOTE A - DESCRIPTION OF PLAN

The following description of The Children's Aid Society Voluntary Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution 403(b) retirement plan covering all employees who are not covered by a collective bargaining agreement of The Children's Aid Society ("Children's Aid" or the "Sponsor" or the "Employer" or the "Plan Administrator"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

As of December 31, 2024 and 2023, the Plan assets were held by Teachers Insurance and Annuity Association ("TIAA") and College Retirement Equities fund ("CREF") (collectively "TIAA and CREF"), Voya Retirement Insurance and Annuity Company and Voya Institutional Trust Company (collectively "VOYA"), Empower Annuity Insurance Company [formerly Prudential Retirement Insurance and Annuity Company] ("Empower"), and Mutual of America Life Insurance Company ("MOA") (collectively, "the Trustees").

#### **Eligibility**

All employees of Children's Aid who are not covered by a collective bargaining agreement are eligible to participate in the Plan.

#### **Contributions**

All eligible employees ("Participants") can make salary reduction contributions. Such contributions should not be less than \$200 during a full calendar year. The maximum annual allowable employee contribution is limited by the Internal Revenue Service ("IRS") regulations.

For automatically enrolled Participants, the rate of the Salary Reduction Contributions will be equal to 2% of compensation, as defined by the Plan document. Automatically enrolled Participants may elect to stop participating in the Plan or change the rate of future deferrals, subject to the \$200 minimum annual contribution.

Effective January 1, 2019, the Plan provides for:

- (a) an annual Employer core contribution of 3% of compensation (as defined by the Plan) for all eligible employees;
- (b) an Employer matching contribution of 100% of the first 2% of compensation contributed by eligible employees; and,
- (c) with respect to employees hired prior to 2012 who are age 50 or older:
  - (1) a supplemental, age-based annual Employer core contribution ranging from 2%-6% of compensation (for a total core contribution of 5%-9% of compensation); and,
  - (2) a supplemental Employer 100% matching contribution up to the next 2% of compensation contributed to the 403(b) Plan (for a total matching contribution of 100% of the first 4% of compensation contributed).

#### ***Participant Accounts***

Each Participant's account is credited with the Participant's contributions, Employer contributions, and earnings (losses) thereon, and charged with an allocation of administrative expenses. Allocations are based on Participant earnings or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the balance in the Participant's account. Participants direct the investment of account balances into the various investment options offered by the Plan.

#### ***Vesting***

For Participants hired prior to January 1, 2012, Participants are 100% vested in their account balances at all times. For Participants hired January 1, 2012, or later, Participant contributions are 100% vested at all times, and will be 100% vested in Employer contributions, plus earnings thereon, following the completion of three years of service.

#### ***Notes Receivable from Participants***

Participants who are active employees may obtain loans from the Plan. The minimum loan is \$1,000. The maximum loan is the lesser of \$50,000 or 50% of the participant's vested account balance, which is pledged as security for the loan. Loan repayments are made through payroll deductions over a period that may not exceed 10 years for mortgages and five years for other loans from the date the loan was made. Participants may only have one loan outstanding at a time. The interest rate is 1% over the prime rate as published in the Wall Street Journal at the inception of the loan and is fixed for the entire repayment period. If a Participant ceases to make loan repayments and the Plan Administrator deems the Participant loan to be in default, the defaulted balance will be recorded as a distribution. \$0 and \$2,000 in Participant loans were deemed to be in default and recorded as distributions for the years ended December 31, 2024 and 2023, respectively.

#### ***Plan Loans - TIAA***

Loans are available to Participants through TIAA, subject to certain limitations. Plan loans are issued directly from the funds owned by TIAA and loan proceeds are not removed from a Participant's account balance. However, a portion of a Participant's TIAA Traditional Annuity Contract ("TIAA TA") account balance is reserved, or held in collateral, to cover 110% of the outstanding loan amount for the period of time the loan is outstanding. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution occurs.

As of December 31, 2024 and 2023, Participants had outstanding loan balances due to TIAA of approximately \$4,000 and \$7,000, respectively. These loans were collateralized by TIAA TA account balances of approximately \$5,000 and \$8,000 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, there were no accumulations used to satisfy plan loan defaults.

#### ***Payment of Benefits***

On termination of service due to death, disability or retirement, a Participant may elect to receive either a lump-sum amount equal to the value of the Participant's vested interest in their account, or annual installments over a 10-year period. For termination of service for other reasons, a Participant may receive the value of the vested interest in their account as a lump-sum distribution. In addition, Participants may elect in-service withdrawals of their elective deferral account balance after reaching age 59½. The Plan also allows hardship withdrawals under certain conditions based on Participant eligibility. Rollover account balances may be withdrawn at any time, provided the rollover contributions have been properly segregated. Minimum required distributions for Participants who have reached age 72 also apply per IRS regulations.

***Forfeited Accounts***

Forfeitures of non-vested accounts, as a result of terminations, are utilized to cover plan expenses or reduce the Sponsors contributions. As of December 31, 2024 and 2023, there were approximately \$51,000 and \$31,000 respectively, of forfeited non-vested account balances included in plan assets. For the years ended December 31, 2024 and 2023, forfeited non-vested account balances were used to cover plan expenses and reduce Sponsor contributions by \$109,000 and \$132,000, respectively.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Presentation***

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by the Plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for the portion of the net assets available for benefits of the Plan attributable to fully benefit-responsive investment contracts because contract value is the amount Participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan has invested in guaranteed investment contracts with TIAA, MOA, Empower and VOYA, most of which are considered fully benefit-responsive. These investments are reported at contract value. See Note E for further discussion of these investments.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date. In order to increase consistency and comparability in fair value measurements, a fair value hierarchy prioritizes observable and unobservable inputs used to measure fair value into three levels, as described in Note D.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payments of Benefits***

Benefits are recorded when paid.

***Notes Receivable From Participants***

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Certain other fees related to the administration of the Plan are paid from plan assets, and fees related to the administration of notes receivable from Participants are charged directly to the Participant's account; these expenses are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**NOTE C - INVESTMENT AND INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustees of the Plan have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, including fully benefit responsive investment contracts and notes receivable from Participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment income and interest on notes receivable from Participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**December 31, 2024 and 2023**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds reported under Level 1 held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission and are deemed to be actively traded.

*MOA and Empower Separate Accounts (Pooled Separate Accounts):* Valued based on the market value of the underlying net assets in the separate accounts. The majority of the underlying net assets have observable Level 1 quoted pricing inputs which are used to determine the unit value of the pooled separate account which is not publicly quoted. These pooled separate accounts are classified as Level 2. There are no redemption restrictions and no unfunded commitments related to the Plan's investment in these separate accounts.

*TIAA Real Estate Account (Pooled Separate Account):* Valued based on the fund's daily net asset value. The unit value of the fund is calculated daily and available to plan administrators and client investors on NASDAQ's website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Although the underlying assets of the fund cannot be quickly sold and converted to liquid assets, the TIAA general account provides the fund with a liquidity guarantee whereby TIAA ensures that the fund has funds available to meet Participant redemption, transfer or cash withdrawal requests. Although this interest has a readily determinable fair value, management has classified this within Level 2 as a result of the associated redemption provisions. There are no unfunded commitments from Participants in the Plan who invest in this account.

*CREF Variable Annuity Accounts:* Valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods, including matrix pricing. Money market account holdings are generally valued at amortized cost. On a daily basis, units in these investments are revalued to reflect performance of the underlying investment, minus any fees and changes. The price is available daily to plan administrators and client investors on NASDAQ's website (Level 1).

*TIAA TA - Non Fully Benefit-Responsive, including an investment through the Retirement Annuity ("RA"):* Valued based on a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The accumulated crediting interest rate on the non fully benefit-responsive fixed rate contract was approximately 5.25% and 6.50%, net of annual fees for the years ended December 31, 2024 and 2023, respectively. The crediting interest rate is calculated on a daily basis. Observable prices for identical or similar investments to the RA do not exist, and it is classified as Level 3. The RA does not allow lump-sum cash withdrawals and transfers must be distributed over 10 annual installments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments may result in a different fair value measurement at the reporting date. The Plan's policy is to recognize transfers in and transfers out at the end of the reporting period. There were no transfers of investments among any of the Levels during 2024 or 2023.

**NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS, AT CONTRACT VALUE**

The TIAA TA (fully benefit-responsive portion totaling approximately \$4,132,000 at December 31, 2024 and \$4,164,000 at December 31, 2023), the MOA Interest Accumulation Account ("MOA IAA") (approximately \$1,071,000 at December 31, 2024 and \$860,000 at December 31, 2023), the Empower Guaranteed Interest Account ("EGIA") (approximately \$259,000 at December 31, 2024 and \$264,000 at December 31, 2023), and the VOYA Fixed Plus Account III ("VOYA FPA") (approximately \$1,418,000 at December 31, 2024 and \$1,913,000 at December 31, 2023) are guaranteed fixed annuity contracts available as investment options to plan Participants. Each contract is fully and unconditionally guaranteed by TIAA, MOA, Empower, and VOYA, respectively.

The TIAA TA is a guaranteed fixed annuity contract that is available to plan Participants. Each contract is fully and unconditionally guaranteed by TIAA. The TIAA TA is offered through a variety of contract types, including the Supplemental Retirement Annuity ("SRA") and Group Supplemental Retirement Annuities ("GSRA") contract types, which are fully benefit-responsive. The type of contract through which a Participant invests in the TIAA TA determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the Participant's account, and the options for receiving income upon retirement. When Participants choose to allocate a portion of their retirement savings to the TIAA TA (accumulation phase of the contract), they may elect at retirement to purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The Participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA TA also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate, which all SRA and GSRA contracts provide for full Participant directed liquidity. The SRA and GSRA contracts guarantee principal and a 3% minimum annual interest rate for all premiums. When a Participant's accumulation in the TIAA TA is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

The Plan also holds investments in the MOA IAA. The IAA is part of the general assets of MOA (its general account). The Plan does not own any underlying securities of MOA's general account. The Plan has guaranteed benefits under the terms of the contract. The accounts are credited with earnings on the underlying investments and charged for Participant withdrawals and administrative expenses. The group annuity contract issuers are contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan. When Participants choose to allocate a portion of their retirement savings to the MOA IAA, their principal, plus a specified minimum rate of interest, is guaranteed by MOA's claims-paying ability. The current minimum rate has been set at 1.75% in accordance with this formula for all contracts that do not have a contractual minimum guarantee of 3.00% or 1.50%. If a Participant's contract has a contractual guaranteed minimum rate of 3.00% or 1.50%, the interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year.

The Plan also holds investments in the EGIA. The EGIA is an insurance company annuity valued at contract value, as reported by Empower. All rates are set at Empower's discretion. Assets held in the EGIA are valued at contract value, representing contributions, reinvested income, less any withdrawals, plus accrued interest. When Participants choose to allocate a portion of their retirement savings to the EGIA, their principal, plus a specified minimum rate of interest, is guaranteed by Empower's claims-paying ability. The crediting rate can never be less than 3.00%.

The Plan also holds investments in the VOYA FPA. The VOYA FPA is available through group annuity or other type of contract issued by Voya Retirement Insurance and Annuity Company ("VRIAC"). The value of the account is determined by the daily crediting of interest which is subject to minimum contractual

guarantee and does not have a maturity date. Investment transfers to and from the account, and withdrawals to pay Participant benefits are made at contract value and paid in installments or lump sum.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and also that limit the ability of the Plan to transact at contract value with Participants.

#### **NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments as of December 31, 2024 and 2023 are mutual funds, pooled separate accounts, and investment contracts managed by the Trustees of the Plan; therefore, these transactions qualify as party-in-interest transactions.

#### **NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, Children's Aid has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, Participants will become 100% vested in their accounts.

#### **NOTE H - TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code ("Code"). The terms of the Plan have been prepared to conform to the sample language provided by the IRS in Revenue Procedure 2007.71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan Participants under Section 403(b). The Plan Administrator believes that the Plan is currently designed and operated, in all material respects, in accordance with the applicable requirements of Section 403(b) of the Plan and, therefore, believes that the Plan is qualified and tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

#### **NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amount reported in the statements of net assets available for benefits.

#### **NOTE J - ACCOUNTING AND PAYROLL RECORDS**

In November 2007, the DOL issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting and disclosure requirements under Part 1 of Subtitle B of Title I of the ERISA, as amended. Prior to the amended regulations, the Plan was not viewed as a separate reporting entity. Historically, the Plan was viewed as a collection of individual contracts with which Participants could engage in a range of actions with limited involvement, if any, by the Plan Sponsor. Accordingly, various accounting and payroll records related to the Plan's 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009 were not sufficiently maintained by the Plan. Plan Administrator is unable, at this time, to determine the outcome of these matters but will take the necessary corrective actions to maintain the tax-exempt status of the Plan. Consequently, the financial statements have been prepared based on available records analyzed by plan management. As certain records were not available from the inception of the Plan, the effect, if any, on the completeness or accuracy of the Plan's financial statements cannot be determined.

**NOTE K - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued, and determined that there were no subsequent events that required adjustment to or disclosure in the financial statements as of and for the year ended December 31, 2024.
