NOTE A – DESCRIPTION OF PLAN

The following description of Allegheny Direct Logistics, LLC 401(k) Plan (hereinafter referred to as “the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a contributory defined contribution plan covering all employees of Allegheny Direct Logistics, LLC who are 21 years of age or older and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective March 9, 2022.

Contributions

Participants may contribute, through payroll deductions, pre-tax or Roth deferrals up to 90% of eligible compensation. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Additionally, the Plan includes an automatic deferral feature. Accordingly, Allegheny Direct Logistics, LLC will automatically withhold a portion of the participant’s compensation from each pay and contribute that amount to the Plan as a pre-tax deferral unless the participant has a salary reduction agreement or the participant’s existing deferral amount is equal to or greater than the scheduled deferral increase. The automatic deferral will be effective on the first day of the participant’s enrollment in the. The automatic deferral is 4% at the time of enrollment.

Allegheny Direct Logistics, LLC matches 100% of participant contributions up to a maximum of 4% of eligible compensation. In addition, Allegheny Direct Logistics, LLC may make discretionary nonelective contributions. There were no discretionary nonelective contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing rollovers from other qualified plans.

Participants have the ability to opt-out of contributing to the plan.

Investment Options

Each participant directs the manner in which contributions are to be allocated among the investment options available under the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Allegheny Direct Logistics, LLC’s contributions, as well as allocations of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants are immediately 100% vested in participant contributions. Participants are 0% vested in Allegheny Direct Logistics, LLC matching contributions until 2 years of service is completed, at which point they become 100% vested.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the amount of the highest loan balance during the previous 12 months) or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.0%. Loan terms are one to five years, or up to 30 years for the purchase of a primary residence. All notes are deemed collectible.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or in installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to plan provisions.

Forfeited Accounts

Forfeitures are used to reduce Allegheny Direct Logistics, LLC's contributions and/or to pay administrative expenses.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments purchased and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by Allegheny Direct Logistics, LLC or the Plan, at the discretion of the Company. Expenses paid by the Company are excluded from these financial statements.

NOTE C – CERTIFICATION OF INVESTMENT INFORMATION

Certified information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, LLC as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE D – FAIR VALUE OF INVESTMENTS

The Plan follows the requirements of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10-50-2, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., exit price) in an orderly transaction between market participants at the measurement date. FASB ASC 820-10-50-2 requires disclosures that categorize assets and liabilities measured at fair value into one of three different levels, depending on the assumptions (i.e., inputs) used in the valuation. Level 1 provides the most reliable measure of value, whereas Level 3 generally requires significant management judgment. Financial assets and liabilities are classified in their entirety based on the lowest level of input significant to the fair value measurement. FASB ASC 820 fair value hierarchy is defined as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE D – FAIR VALUE OF INVESTMENTS (CONTINUED)

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability as a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair Value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G – TAX STATUS

The Plan has adopted a Prototype Standardized Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the IRS on June 30, 2020 stating that the Plan is acceptable under section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE H – PARTY-IN-INTEREST TRANSACTIONS

The Plan makes loans to participants who are considered to be party-in-interest. The guaranteed investment contract is managed by Matrix Trust Company, LLC, the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest. In addition, certain fees are paid by the Plan for investment management services. Fees for these services amounted to \$1,258 for the year ended December 31, 2024.

NOTE I — SUBSEQUENT EVENT

The Plan has evaluated subsequent events and determined that there are no subsequent events necessary for disclosure as of the date of the independent auditors' report.
