Report of Independent Auditors

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

December 31, 2024 and 2023

1. Description of Plan

The following description of the Cooper Health System, Inc. Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan adopted effective January 1, 2002. The Plan covers any person employed on a regular basis by Cooper Health System, Inc. (the “Health System”) and certain of its affiliates that adopt the Plan, except leased employees, residents, fee for service employees, and student employees, as defined, and employees covered by a collective bargaining agreement. Effective January 1, 2003, the Plan was amended to allow eligible employees represented by Health Professionals and Allied Employees Union Nurses of New Jersey (Local 5118) to participate in the Plan.

Employees are eligible to participate in the Plan when they have reached age 21 and have been credited with one year of service by completing at least 1,000 hours of service during a twelve-month period, as defined. An eligible employee becomes a participant in the Plan on January 1, April 1, July 1 or October 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Finance Committee of the Health System’s Board of Trustees is responsible for the general administration of the Plan. Fidelity Management Trust Company is the trustee and Fidelity Workplace Services LLC is the record-keeper of the Plan.

Contributions

The Health System contributes a matching contribution for each participant who makes a salary reduction contribution to The Cooper Health System 403(b) Plan. The matching contribution for each participant for a pay period shall equal the lesser of 2.5% of the participant’s base pay for the pay period or 50% of the participant’s salary deferrals from base pay for the pay period. However, with respect to each eligible participant employed by the Health System on December 31 of each Plan year, the matching contribution for that year equals the lesser of 2.5% of the participant’s base pay for that Plan year or 50% of the participant’s salary deferrals from base pay for the Plan year.

1. Description of Plan (continued)

The Health System also makes fixed employer contributions for each participant who is credited with 1,000 hours of service and is employed on December 31 of that Plan year. A participant who terminates employment during a Plan year due to death or disability or reaches normal retirement age is eligible for the fixed employer contributions. Fixed employer contributions consist of 1% or 4% of the participant's base pay earned for the year. In order to be eligible to receive a 4% fixed employer contribution rather than a 1% fixed employer contribution, a participant must have met the following three criteria on December 31, 2002: (1) be at least age 50; (2) be credited with at least 10 years of service for vesting purposes under the Plan; and (3) have years of age, plus years of service for vesting purposes under the Plan, totaling at least 65.

The Plan was amended for additional fixed contributions equal to 2% of the participant's base pay to be made to participants that are (a) an eligible bargaining unit employee under the provisions of the collective bargaining agreement for registered nurses, between the Health System and the Health Professionals and Allied Employees Union of New Jersey (Local 5118), dated April 1, 2004, and (b) vested in his or her fixed employer contribution account. As part of the union agreement executed in July 2017 and a memorandum of agreement executed in April 2020, the additional fixed contributions of 2% of the participant's base pay include the 2019 plan year and the 2020 plan year. An updated union agreement that was executed in June 2021 provides for the additional fixed contributions equal to 2% of the participant's base pay for the 2021, 2022, and 2023 plan years to be made to eligible participants as defined above. A further updated union agreement that was executed in 2024 extends the additional fixed contributions equal to 2% of the participant's base pay for the 2024, 2025, and 2026 plan years to be made to eligible participants as defined above. The contributions for each plan year are made in the subsequent year.

Participants may transfer rollover contributions from other qualified retirement plans or individual retirement accounts, as defined.

Participants are not allowed to contribute to the Plan.

Participants may invest in any investment option or combination of investment options. Investment elections may be changed at any time.

Participant Accounts

Each participant's account is credited with the participant's rollover contributions and the Health System's contributions and allocations of Plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their rollover contributions, plus actual earnings thereon. A participant is 100% vested in the fixed employer contribution portion of his or her account and qualified Health System matching contributions, plus actual earnings thereon after two years of credited service or upon reaching age 65, death, or disability.

Forfeited balances of terminated participants' non-vested accounts are used to reduce Health System contributions. At December 31, 2024 and 2023, available forfeited non-vested accounts totaled \$22,421 and \$20,556, respectively. Forfeitures of approximately \$6,977 and \$ 18 were used to reduce employer contributions for 2024 and 2023, respectively.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding balance of loans to the participant during the previous one-year period, or 50% of the participant's vested account balance. Only one loan for each participant may be outstanding at any time, and participants may only borrow from the Plan once in any one Plan year. Loans must be repaid within 5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate determined by the plan administrator commensurate with local prevailing rates being charged by commercial lenders for similar loans. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, retirement age, death or disability, a participant may receive a lump-sum amount equal to the vested value of his or her account. If the participant becomes disabled or dies before normal retirement, the account becomes 100% vested and the participant or designated beneficiary will be paid the total amount credited to the participant's account. The Plan was amended and restated effective January 1, 2020 to include provisions related to the distribution of accounts that are \$5,000 or less.

Plan Termination

Although it has not expressed any intent to do so, the Health System has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Health System, as provided by the Plan's provisions. The Health System pays for certain administrative expenses of the Plan such as recordkeeping fees, trustee fees, and audit fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. The Plan provides for a revenue credit program in connection with revenue sharing with certain fund investment managers. The amounts are used to pay Plan expenses. All other administrative expenses of the Plan are paid by the Health System and are excluded from the accompanying financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

2. Summary of Significant Accounting Policies (continued)

In accordance with Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

- Level 1 – Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2 – Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 – Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management’s judgment about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividend income is recorded on the ex-dividend date. Capital gain distribution is included in dividend income. Net appreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee and custodian of the Plan.

4. Fair Value Measurements

ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are as described in Note 2. The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level of input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value. There have been no changes in the techniques and inputs used at December 31, 2024 and 2023.

Registered investment companies: Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Self-directed brokerage accounts: Such accounts hold mainly registered investment companies and an interest-bearing cash account, which is valued based on cash deposited plus interest earned.

Collective investment trust fund: Valued using the readily determinable fair value. The fair value per share of this fund is published and is the basis for current transactions.

4. Fair Value Measurements (continued)

The Finance Committee of the Board of Trustees of the Health System is responsible for determining the Plan's valuation policies and analyzing information provided by the investment trustee that is used to determine the fair value of the Plan's investments.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Tax Status

The Plan has received a determination letter from the Internal Revenue Service ("IRS") dated May 15, 2014, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan invests in shares of registered investment companies managed by an affiliate of Fidelity Management Trust Company. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are reported as notes receivable from participants in the accompanying statements of net assets available for benefits.

8. Subsequent Events

Management has evaluated the need for additional disclosures and/or adjustments resulting from subsequent events for the Plan through October 15, 2025, the date the accompanying financial statements were available to be issued.
