Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of United Audit Systems, Inc. Savings & Investment Plan (the "Plan") have been prepared on the accrual basis using accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value and are valued daily. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade date basis. The cost of investments sold is computed on an average cost basis for all realized gains and losses. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments to Participants

Benefit payments to participants are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Related Party Transactions

Certain plan investments are shares of investments managed by Principal Life Insurance Company, and John Hancock Life Insurance Company, the trustee and recordkeeper as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Certain employees of United Audit Systems, Inc. (the "Company") provide administrative and executive oversight services to the Plan. The Plan is not charged by the Company for the services.

A shareholder of the Company is an owner of a service provider that performs third party administrative services for the Plan and therefore, these transactions qualify as party-in-interest transactions.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Subsequent Events

In preparing its financial statements, Plan management has evaluated events subsequent to the balance sheet date through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan, established on February 1, 1994, is a defined contribution plan covering substantially all employees of the Company. Employees become eligible on the first day of the month which coincides with the employee reaching age 21 and completing 6 months of service. Effective August 15, 2024, employees become eligible upon completing 3 months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). It has been amended for compliance with the applicable provisions of the Economic Growth and Tax Relief Reconciliation Act ("EGTRRA"), effective January 1, 2002. Effective March 1, 2017 the Plan was amended and restated. Effective January 1, 2022 the Plan was restated. Effective August 15, 2024 the Plan was restated.

Contributions

Each year, participants may contribute before tax and Roth after-tax contributions to the Plan up to 75% of their eligible annual compensation, as defined by the Plan document. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 for 2024). Section 414(v) of the Internal Revenue Code of 1986 as amended allows a maximum catch-up contribution of \$7,500 for 2024. If participants do not elect otherwise, their compensation will be automatically reduced by 3% and this amount will be contributed to the Plan as elective contributions due to the Plan's auto enrollment feature. The auto enrollment will increase 1% each year up to 10%. Participants may also contribute amounts representing distributions from other qualified plans. The Company may contribute to the Plan an amount of net profits at the discretion of the Company's Board of Directors. They may also make a discretionary match contribution. During 2024, a \$232,921 discretionary matching contribution was made.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's voluntary contributions and charged with withdrawals, if applicable, and allocations of (1) the Company's discretionary contribution, if any, and (2) Plan earnings, losses and administrative expenses. Allocations of the Company's discretionary profit-sharing contributions are based upon compensation. Allocations of Plan earnings, losses and administrative expenses are based upon account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions and Plan earnings thereon is based on years of continuous service using the elapsed time method. A participant is 100% vested after 5 years of credited service.

Hardship Withdrawals

Participants qualify to take a hardship withdrawal if a participant has an immediate financial hardship resulting from certain events as identified in the Plan document. Hardship withdrawals may only be taken from the employee deferral account.

Payment of Benefits

On termination of service due to retirement, death, disability, other termination of employment with United Audit Systems, Inc., or termination of the Plan, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a partial withdrawal. Participants with a vested account balance of \$5,000 or less may be automatically distributed as a lump-sum.

In-service distributions are permissible for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits.

Forfeitures

The non-vested portion of terminated participant account balances first must be used by the Company to pay administrative expenses under the Plan, and then to reduce future employer contributions. During 2024, \$35 was used to pay plan expenses, and \$1,594 was used to offset employer contributions. As of December 31, 2024 and 2023, the balance of unallocated forfeitures was \$21,956 and \$9,337, respectively.

NOTE 3 TAX STATUS

The Company has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the provider's prototype, as designed, is in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, participants will become fully vested in their account balances.

NOTE 5 ADMINISTRATIVE EXPENSES

Certain Plan expenses are paid by the Company and accordingly, are not reflected in the Plan's financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

NOTE 6 INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

NOTE 7 FAIR VALUE MEASUREMENTS

Applicable GAAP for Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). - Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

Mutual funds: Value at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: The NAV of the pooled separate accounts are based on the market value of the underlying investments. The NAV of the pooled separate accounts are not publicly-quoted prices in an active market. The pooled separate accounts invest in various mutual funds, equity and debt securities and commercial real estate to generate their investment return.

Collective investment trusts: Valued based on the NAV of units of a collective trust as published by the trustee. The existence of certain conditions can limit the trust's ability of the Plan to transact with participants at fair value of the collective trust. Specifically, any event outside the normal operation of the trust which causes a withdrawal from the investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, layoffs, bankruptcy, plant closings, plan termination, mergers, early retirement incentives, communications designed to induce participants to transfer from the fund, competing fund transfer or violation of equity wash or equivalent rules in the plan, and changes in qualification status of employer or plan. As of December 31, 2024, the occurrence of an event outside the normal operation of the trust which would cause a withdrawal from the investment contract is not considered probable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
