INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tobin Lucks, LLP 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Tobin Lucks, LLP, (the “Partnership”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. The specific provisions of the Plan are contained in the Plan document which governs the legal operation of the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General Description and Eligibility

The Plan is a qualified, defined contribution plan covering all employees who have attained age 21 of the Partnership and completed three months of service. The purpose of the Plan is to provide retirement, disability, and death benefits for the Partnership’s eligible employees and their beneficiaries. The Plan is designed to qualify under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Security Act of 1974 (“ERISA”). The Plan’s effective date was July 1, 1997. Participants can enter the Plan on the first day of the month after meeting the Plan’s eligibility requirements.

2. Contributions

Under the 401(k) arrangement eligible employees participating in the Plan shall file a salary reduction agreement with the plan administrator specifying the amount of compensation or percentage of compensation subject to limitations. The Plan provides rules for excess contributions and its distribution. Furthermore, the Plan does not consider 1) Leased employees, 2) Non-resident aliens with no U.S. source income, 3) Members of a collective bargaining unit where retirement benefits were the subject of good faith bargaining, and 4) Associate Attorneys eligible for matching contribution. Associate Attorneys may make a pretax contribution to the Plan through salary deferrals in any amount not to exceed the annual maximum defined by tax law, as defined in the Plan.

Participants may make pretax contributions to the Plan through salary deferrals in any amount not to exceed the annual maximum defined by tax law, as defined in the Plan. A participant may discontinue contributions at any time. Participants direct the investment of their contributions into various investment options offered by the Plan. The Partnership contributes 50% of the first 4% of compensation that a non-attorney participant contributes to the Plan. The amount of Partnership contribution for the Plan year ending December 31, 2024 was \$86,626. The Partnership may also, at its discretion, make a profit sharing contribution. There were no profit sharing contributions for 2024.

3. Participant Accounts

Each participant’s account is credited with the participant’s contributions, the participant’s share of the Partnership’s matching contribution and is charged with an allocation of administrative expenses. Investment income and losses are allocated to participant accounts based on the ratio of their account balance to the total account balances of all participants in the same investment, as defined.

3. Participant Accounts (Continued)

Discretionary contributions are allocated among eligible participant accounts in the ratio that each such participant's compensation for the Plan year is to the total compensation for all eligible participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions as desired, in any of a variety of options held by John Hancock Life Insurance Company (U.S.A.) ("John Hancock U.S.A."), as chosen by the employer. Participants may change their investment options daily.

5. Vesting

Participants are immediately 100% vested in their voluntary contributions and actual earnings thereon. Vesting in the Partnership's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant's employer contribution portion of their account shall vest ranging from 20% to 100% for two to six years of service. The participant's interest in the matching contribution account shall vest 100% upon death and disability.

6. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate of interest published by the Wall Street Journal as of the date of the loan, plus 2%. The term of the loan may not exceed five years except when loan proceeds are used to purchase the participant's principal residence, in which case a reasonable term is determined at the time the loan is made. Principal and interest is paid ratably through a salary reduction each pay period.

7. Payment of Benefits

As a general rule, termination by resignation or dismissal, disability, retirement or financial hardship, fully vested accounts will be distributed. If a participant dies before distribution of the participant's vested interest commences, the participant's entire vested interest shall be disbursed immediately following the calendar year in which the participant died.

There is only one form of payment under the Plan. The distribution will be in the form of a lump-sum distribution equal to the value of the participant's vested interest in their account, or the participant may select an alternate form of payment, if permitted under the Plan at the time of the distribution.

8. Forfeitures

Any portion of a participant's account, which is nonvested upon separation from service, is forfeited. Forfeitures reduce discretionary Partnership matching and profit sharing contributions, if any. Any remaining forfeitures are allocated among the participants. At December 31, 2024 and 2023, there were no unallocated forfeitures.

9. Plan Termination

The Partnership expects that the Plan will be continued indefinitely and the Trust is irrevocable but continuance of the Plan by the Partnership is not assumed as a contractual obligation. The Partnership reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The statement of changes in net assets available for benefits presents the net appreciation (depreciation) in the fair value of the Plan's investments, which consists of realized gains or losses and unrealized appreciation (depreciation) on those investments.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As of December 31, 2024 and 2023, the Plan does not contain any benefit-responsive contracts. The statement of changes in net assets available for benefits is prepared on a fair value basis.

2. Plan Administration

The Partnership is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statement and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

4. Payments of Benefits

Benefits are recorded when paid.

5. Administrative Expenses

Administrative expense incurred by the custodian in performance of its duties are paid from the assets of the Plan. Substantially all other out-of-pocket administrative expenses of the plan are paid by the Plan sponsor. Investment related expenses are included in the appreciation of fair value of investments.

6. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information by investment advisors and the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The Plan invests in funds which invest in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different security transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

9. Contributions

Contribution from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the custodian of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements And Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: The net asset value ("NAV") of these accounts is based on the market value of their underlying investments. The NAV is not a publicly quoted price in an active market. The pooled separate accounts do not have unfunded commitments relating to their investments, or any significant restrictions on participant-directed withdrawals. Participant-directed withdrawals can be made on any business day and may have a redemption notice period for certain pooled separate accounts. Participant-directed transfers to other investments options are generally limited to two per calendar month.

Guaranteed interest account: Valued at contract value, which approximates fair value. Contract value represents contributions made under the contract plus compound interest earned less participant withdrawals and administrative expenses. Interest is earned over a defined term of three to ten years, provided all contributions remain in the account until maturity. Interest rates are established on the first day of the month and apply to all contributions made in the account during the period. Withdrawals taken prior to the end of the guarantee period may be subject to a market value adjustment. The average composite rate to participants was 1.84% and the yield ranged from 0.80% to 3.44% during the year ended December 31, 2024.

The primary investment objective of the guaranteed interest accounts is to seek to achieve investment income consistent with the preservation of principal, primarily through investments in federal and other government bonds, corporate bonds and commercial mortgages. Transfers between guaranteed interest accounts are not permitted. The guaranteed interest accounts do not have unfunded commitments relating to its investments, or any significant restrictions on participant-directed withdrawals. Participant-directed transfers between a guaranteed interest account and other investment options may be subject to a market value adjustment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – PARTY-IN-INTEREST TRANSACTIONS

The custodian is a party-in-interest with respect to the Plan. All investments are held with the custodian and they also provide participants record keeping services to the Plan. Notes receivable from participants of the Plan and the related interest income are also considered party-in-interest transactions.

The plan administrator authorized the plan's custodian, to establish an Expense Budget Account ("EBA"). The EBA is funded by the custodian's shared revenues from certain investments and is netted against earnings. At the direction of the Partnership, these funds may be used to pay reasonable Plan related expenses or can be allocated to the plan participants at the end of the year. For the year ended December 31, 2024 there was no shared revenue.

NOTE F - TAX STATUS

The Partnership adopted a volume submitter document, which received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. Administration errors, if any, that are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.
