Pflueger, Inc. Savings and Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pflueger, Inc. Savings and Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

NOTES TO THE FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The Pflueger, Inc. Savings and Retirement Plan (Plan) was established to enable eligible employees to share in the growth and profitability of Pflueger, Inc. and its subsidiaries (Company), and to provide them with an opportunity to accumulate capital for their future economic security. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a complete description of its provisions. The plan documents were amended and restated effective May 23, 2022.

General

The Plan is a profit sharing and salary deferral plan covering employees of the Company age 18 and over who have at least six months of service (except nonresident aliens with no earned income within the United States of America and residents of Puerto Rico). Employees are automatically enrolled in the Plan upon meeting the eligibility requirements. The automatic deferral rate is 3% of compensation unless the employee withdraws from the Plan or elects a different percentage. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may make salary deferral contributions to the Plan up to the lesser of their eligible compensation or \$23,000 and \$22,500 in 2024 and 2023, respectively, adjusted annually for the cost of living, plus an additional \$7,500 in 2024 and 2023, for employees age 50 and over. Employees may make rollover and transfer contributions from other qualified plans, except for Roth contributions. The Company may make discretionary matching contributions, which amounted to \$12,732 and \$14,241 during the years ended December 31, 2024 and 2023, respectively. Total contributions to each participant's account may not exceed the lesser of \$69,000 (\$73,500 with catch-up contributions) in 2024 and \$66,000 (\$67,500 with catch-up contributions) in 2023, or 100% of annual compensation, as defined.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary matching contribution; plus, an allocation based on participant earnings or account balances, forfeitures of terminated participants' nonvested benefits, and the Plan's net earnings; less an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are 20% vested in employer contributions after completion of two years of covered service, 40% after completion of three years of covered service, 60% after completion of four years of covered service, 80% after completion of five years of covered service, and 100% after completion of six years of covered service. Participants become fully vested in their account balances upon death, total and permanent disability, or early retirement (age 55 and at least six years of service). Participant voluntary contributions and rollover contributions, and the earnings thereon, are always 100% vested.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000, up to the lesser of \$50,000 or 50% of the vested portion of their account balance. The participant may only have one loan outstanding at any one time. The notes receivable and related interest must be repaid within five years unless the note is used to acquire a principal residence, for which the term may be extended up to 30 years. The notes are collateralized by the participants' account balances and bear interest at prevailing rates, which ranged from 4.25% to 9.50% and for the years ended December 31, 2024 and 2023. Principal and interest payments are paid ratably through monthly payroll deductions. The notes mature at various dates through June 2029.

Payment of Benefits

The vested amount in each participant's account is payable upon normal retirement (age 65), disability, death, or termination of employment. Participants may receive the entire value of their accounts in a single lump-sum payment or in periodic payments over a period not to exceed their life expectancy equal to their vested balance less the balance of any outstanding notes. Account balances of \$5,000 or less at termination are automatically disbursed to the participant.

Withdrawals

Active participants may withdraw all or a portion of their elective deferrals as in-service distributions after attaining age 59-1/2 or all or a portion of their vested account balances as hardship withdrawals, by submitting a written application that is approved by the plan administrator. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Services (IRS).

Forfeitures

Termination of employment for reasons other than retirement, disability, or death results in a forfeiture of the nonvested portion of the participant's account balance. Forfeitures may be used to pay for plan expenses and/or reduce future employer contributions. There were forfeited vested accounts of \$0 at December 31, 2024 and 2023. Forfeitures of \$142 and \$1,733 were applied to plan expenses for the years ended December 31, 2024 and 2023, respectively. No forfeitures were used for employer contributions during the years ended December 31, 2024 and 2023.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, it is reasonably possible that such estimates may change within the near term, and such differences could be material to the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value, except that fully benefit-responsive unallocated group annuity contracts are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Contributions receivable are recognized for amounts due from the participants and employer remitted to the Plan after year-end. At December 31, 2024 and 2023, the amount due from the participants was \$11,513 and \$12,395, respectively, and from the Company was \$384 and \$387, respectively. Contributions from plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is withheld from compensation. The receivables are typically short-term in nature and are expected to be collected in full.

Management has evaluated the collectability of employer contributions receivable in accordance with Accounting Standards Update No. 2016-13, *Financial Instruments – Credit Losses (Topic 326)*, and determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023. The Plan considers the Company's historical payment experience, current and future financial condition, and the legally binding nature of the contribution obligation in making this assessment.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Expenses are recognized when the related liability is incurred. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE C – CERTIFICATION FROM QUALIFIED INSTITUTION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value, the unallocated group annuity contract at contract value, and notes receivable from participants at December 31, 2024 and 2023, and the net appreciation in the fair value of investments and interest from the unallocated group annuity contract for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Transamerica Financial Life Insurance Company (Transamerica), the qualified institution of the Plan.

NOTE D – FAIR VALUE MEASUREMENTS

U.S. GAAP provides a hierarchy that prioritizes the inputs to the valuation methodologies used to measure fair value. There are three levels of the fair value hierarchy. Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs are unobservable and significant to the fair value measurement. The fair value measurement level of an asset or liability within the hierarchy is based on the lowest level of any input that is significant to the measurement. Valuation methodologies used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's pooled separate accounts are valued using the net asset value provided by the pooled separate accounts managers as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. Pooled separate accounts amounted to \$6,931,286 and \$6,396,618 as of December 31, 2024 and 2023, respectively. There were no investments valued using Level 1, 2, or 3 inputs as of December 31, 2024 and 2023. The valuation methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determining the fair value of certain investments could result in different fair value measurements at the reporting date.

NOTE E – POOLED SEPARATE ACCOUNTS

The pooled separate accounts have no significant unfunded commitments, redemption restrictions, or redemption notice periods and are redeemable daily. The pooled separate accounts seek to provide capital appreciation and current income consistent with their current asset allocations. The pooled separate accounts invest primarily in mutual funds, common and preferred stocks, corporate notes and bonds, and government issued notes and bonds.

The ability to exchange units of a pooled separate account may be restricted in the event that a sponsor or participant engages in trading patterns, which are detrimental to the pooled separate account or underlying investments. Investment funds may be subject to certain trading restrictions. Trading restrictions apply to transfers into an investment fund. Transfers out of a pooled separate account are allowed at any time. Information on trading restrictions can be found on the *Investment Fact Sheet*, which is available for each pooled separate account.

NOTE F – UNALLOCATED GROUP ANNUITY CONTRACT

The Transamerica's Stable Value Compass Account is an unallocated group annuity contract that complies with the fully benefit-responsive requirements of the Financial Accounting Standards Board. The fund has no stated maturity date and no guaranteed yield. The unallocated group annuity contract is backed by the general account assets of Transamerica. Due to the nature of the contract, the contract does not have specific underlying assets assigned to it. Therefore, the value of the unallocated group fixed annuity contract reported to plan sponsors is the contract value which represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing contract. The fund sets an interest rate on a semi-annual basis and the rate of interest shall not change during the six-month period for which it is effective. The interest rates ranged from 1.0 % to 1.15 % and .65% to .75% for the years ended December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include amendments to the plan documents including complete or partial plan termination or merger with another plan, bankruptcy of the plan sponsor or other plan sponsor events such as divestiture of a subsidiary that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, and a material amendment to the agreement without the consent of the issuer.

NOTE G – ADMINISTRATION OF PLAN ASSETS

The Plan’s assets are held by the trustee of the Plan, Massachusetts Fidelity Trust Company, as of December 31, 2024 and 2023. Certain administrative functions are performed by officers or employees of the Company, who receive no compensation from the Plan. Trustee fees and other administrative expenses are paid by either the Plan or the Company, as provided in the plan document. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of pooled separate accounts. Expenses that are paid by the Company are excluded from these financial statements.

NOTE I – TAX STATUS

The Plan is a non-standardized pre-approved profit sharing plan. The Plan received a favorable opinion letter from the IRS dated June 30, 2020, that states that the Plan is designed in accordance with the application sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan has been amended and restated since the receipt of the IRS letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes the Plan is designed and is being operated in compliance with the applicable provision of the IRC.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator evaluated the Plan's tax positions as of December 31, 2024 and 2023 and for the years then ended, and determined that the Plan had no uncertain tax positions required to be reported in accordance with U.S. GAAP. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any open tax periods.

NOTE J – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan's assets are administered by and in the custody of Transamerica and, therefore, these transactions qualify as party in interest transactions. The Plan sponsor paid certain administrative fees of the Plan.

NOTE K – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants become 100% vested in their employer contributions.

NOTE L – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan and Company operate in the State of Hawaii. Local, national, and international events can have severe, adverse effects on economic conditions in Hawaii. These financial statements do not include the adjustments that would result if the Plan was to account for future losses or asset impairments, as the effects on the financial statements of the Company from such changes in economic conditions are not presently determinable.
