### **Opinion**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are

presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter**

The financial statements of the Plan as of and for the year ended December 31, 2023 were audited by other auditors whose report dated August 12, 2024, expressed an unmodified opinion on those statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Washington Technology Industry Association Employee Benefit Trust (the “Plan”) is a multiple employer health and welfare plan established by the Washington Technology Industry Association (“WTIA”) on January 1, 2000 to provide benefits to eligible employees of participating employers and their dependents. The Plan is funded primarily by employer contributions in accordance with applicable participation agreements between qualified employers that are members of the WTIA or associations and the Board of Trustees. The Plan is also funded by participant self-pay contributions. The Plan is subject to provisions of the Employee Retirement Security Act of 1974 (ERISA), as amended.

The Plan provides fully insured medical, prescription drug, dental, vision, group life, short-term disability, long-term disability, accidental death and dismemberment, employee assistance and family benefits platform services.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. Contributions**

Employer and participant contributions are determined via a rate schedule based upon the type of coverage for employees and their dependents. Contributions receivable are recorded when invoices are issued. No allowance is provided for estimated uncollectible accounts.

**D. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation and depreciation includes gains and losses on investments bought and sold as well as held during the year.

**E. Benefits and Benefit Obligations**

The Plan provides health and welfare benefits to eligible and qualified participants. Benefits are recorded when paid.

The obligation for premiums payable are estimates of the costs of premiums incurred under terms of the Plan at December 31 and paid subsequent to December 31.

The Plan has no postretirement benefit obligations as the Plan does not provide retiree coverage.

**F. Tax-Exempt Status**

The Plan has received tax-exempt status from the Internal Revenue Service under Section 501(c)(9) of the Internal Revenue Code (the "Code"). The Board of Trustees and Plan legal counsel believe the Plan is designed and operated in compliance with applicable regulations. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**G. Risks and Uncertainties**

Plan investments are exposed to various risks including interest rate, market and credit risk. Due to the level of risk associated with investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could be material to the financial statements.

During the year ended December 31, 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balance.

**H. Reclassification**

Certain December 31, 2023 account balances have been reclassified to conform to the December 31, 2024 financial statements presentation.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 - Inputs are quoted prices in active markets.

Level 2 - Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 - Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments include an interest bearing cash account and mutual funds valued based on quoted prices in an active market. During the years ended December 31, 2024 and 2023, there were no transfers between levels within the fair value hierarchy.

**NOTE 4 - PLAN TERMINATION**

Although they have not expressed any intent to do so, the Board of Trustees has the right under the Plan to modify the benefits provided to active employees, to discontinue contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

**NOTE 5 - RELATED PARTY TRANSACTIONS**

WTIA is the endorsing sponsor of the Plan. During the years ended December 31, 2024 and 2023, employer contributions from WTIA totaled \$1,127,606 and \$1,179,620, respectively.

The Plan has contracted directly with WTIA to provide marketing, sales, and financial services, as well as a license to WTIA's trademarks and membership data and the associated goodwill, and access to WTIA's membership list and contact information. For the years ended December 31, 2024 and 2023, the Plan recognized expenses totaling \$729,848 and \$1,046,209, respectively, for such fees.

The Plan has contracted directly with HR Benefits, Inc., WTIA's wholly owned subsidiary, to provide administrative, marketing, sales, advisory, monitoring and compliance services. For the years ended December 31, 2024 and 2023, the Plan recognized expenses totaling \$2,399,547 and \$4,887,971, respectively, for such fees.

HR Benefits Inc. has subcontracted with a third-party administrator, Vimly Benefit Solutions, Inc. (Vimly), to provide eligibility and administrative services. For the years ended December 31, 2024 and 2023, payments to Vimly by HR Benefits, Inc. for such administrative expenses totaled \$286,217 and \$526,134, respectively. Vimly was a participating employer in the Plan during 2023 and contributions totaled \$1,701,515. In 2024, Vimly was no longer a participating employer in the Plan.
