To the Plan Committee, Participants, and Beneficiaries of the

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the financial statements of the ScottMadden, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### Notes to Financial Statements December 31, 2024 and 2023

#### NOTE A - DESCRIPTION OF THE PLAN

The following description of the ScottMadden, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**[1] General:**

The Plan is a defined contribution plan covering all employees of ScottMadden, Inc. (the "Company") who have completed one month of service and are age 21 or older, excluding union employees whose benefits are the subject of good-faith bargaining, nonresident aliens, leased, part-time, temporary, or seasonal employees, and employees who are residents of Puerto Rico. Eligible employees can begin participating in the Plan on the first day of each month following the date that eligibility requirements are satisfied. The Plan's trustee and recordkeeper is Principal Trust Company (the "Trustee"), a member of the Principal Financial Group. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**[2] Contributions:**

Participants may contribute up to 100% of pre-tax compensation, as defined by the Plan. The Plan also permits Roth contributions, and participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. In no event may participant pre-tax and Roth contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Company made nonelective safe harbor matching contributions equal to 3% of eligible participants' compensation for the plan year. For the year ended December 31, 2024, the employer safe harbor matching contribution totaled \$848,874. As of December 31, 2024 and 2023, \$848,874 and \$746,385 is included in the employer's contributions receivable on the statements of net assets available for benefits.

The Company may make discretionary profit-sharing contributions during the year. Participants must complete one year of service and be employed on the last day of the plan year to be eligible to receive profit sharing contributions. This discretionary profit-sharing contribution is allocated to participants annually based upon their eligible compensation for the year. The Company's profit-sharing contribution for 2024 was 3% of eligible compensation. The Company's profit-sharing contribution for the year ended December 31, 2024 totaled \$713,664. As of December 31, 2024 and 2023, \$713,664 and \$463,395 is included in the employer's contributions receivable on the statements of net assets available for benefits.

The Company may make additional discretionary matching contributions during the year. Participants must complete one month of service and be employed as a research analyst, analyst, senior analyst, or support staff member. The Company's additional discretionary matching contribution for 2024 was 200% of elective contributions up to an annual maximum of \$2,000, not to exceed 4% of elective contributions each payroll. For the year ended December 31, 2024, the additional discretionary matching contribution totaled \$143,786. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

#### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

##### [3] Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching and/or profit-sharing contributions, and (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### [4] Vesting:

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Participants are fully vested in the Company's additional matching contributions plus actual earnings thereon after one year of service.

Vesting in the profit-sharing contribution portion of their accounts, plus actual earnings thereon, is as follows:

##### [5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally may not exceed five years, unless for the purchase of a primary residence, in which case the term is not to exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at the current Prime lending rate at the date of the loan. Interest rates on outstanding loan balances range from 3.25% to 8.50% at December 31, 2024 and 2023. Participants may have only one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### [6] Payment of benefits:

On termination of service due to death, disability, retirement, or for other reasons, a participant may elect to receive either installment payments or a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows for in-service withdrawals for participants who have attained the age of 59½, or in the event of financial hardship, as defined by the Plan.

**[7] Forfeitures:**

Forfeited nonvested accounts may be used to reduce employer contributions or allocated to participants. During the year ended December 31, 2024, forfeitures of \$26,994 were used to reduce employer contributions. Forfeited nonvested accounts available at December 31, 2024 and 2023 were \$63,177 and \$28,178, respectively.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**[1] Basis of accounting:**

The financial statements are prepared on the accrual method of accounting.

**[2] Subsequent events:**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

**[3] Investment valuation and income recognition:**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**[4] Payment of benefits:**

Benefits are recorded when paid.

**[5] Plan expenses:**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

**[6] Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Principal Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes of net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Mutual funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market fund** - Valued at one dollar per share held by the Plan at year-end. Money market funds held by the Plan are mutual funds invested in highly liquid, near-term instruments and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

**Common trust funds** – Common trust funds are comprised of shares or units in commingled funds that are not publicly traded. The underlying assets in these funds are primarily publicly traded equity securities, fixed income securities, and commodity-related securities and are valued based on the underlying unit value as provided by the Trustee. Unit values are calculated by the investment manager or sponsor of the fund and have varying liquidity, redemption period notices and other restrictions.

**Collective trust funds** - Valued based on the underlying unit value as provided by the Trustee. Valuation of the funds’ units is published daily and is the basis for current transactions. Unit values are determined by dividing the value of each fund’s net assets by the total number of participants’ units outstanding on the valuation date. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments. If the Plan were to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly, business manner.

**Stable value collective trust fund** – A stable value fund that is composed primarily of fully benefit-responsive investment contracts and that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE E - TAX STATUS**

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA, sponsored by Principal Life Insurance Company. On June 30, 2020, the Internal Revenue Service (“IRS”) stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”) and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are managed by Principal Trust Company and its affiliates. Principal Trust Company is the Plan Trustee and, therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan to Principal Trust Company were \$56,471 for the year ended December 31, 2024.

#### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan’s investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE H - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan’s investment earnings activity, and thus not separately identifiable as an expense.

### **NOTE I - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.
