We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit.

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of The Cooper Health System 403(b) Plan (the “Plan”) provides general information about the Plan’s provisions. The Cooper Health System (the “Health System”) is the plan sponsor. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan’s provisions, copies of which may be obtained from the Health System.

General

The Plan is a 403(b) tax sheltered annuity defined contribution plan adopted effective October 1, 2005. Any employee hired by the Health System and certain of its affiliates that adopt the Plan will be automatically enrolled in the Plan. However, a participant may elect not to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Fidelity Management Trust Company, Equitable Financial Life Insurance Company (“Equitable”), Metropolitan Life Insurance Company (“MetLife”), The Lincoln National Life Insurance Company (“Lincoln”), Empower Annuity Insurance Company (“Empower”), Empower Trust Company, LLC (subsequent to the March 31, 2023 with Prudential Trust Company), and Teachers Insurance and Annuity Association and College Retirement Equities Fund (“TIAA-CREF”) hold the annuity contracts and custodial accounts of the Plan.

Contributions

If automatically enrolled, a participant’s deferral is set at 3% of eligible compensation until changed by the participant. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Effective May 6, 2024, the Plan was amended to allow Roth deferral contributions and effective July 29, 2024, the Plan was amended to allow in-plan Roth rollover contributions. All contributions are subject to certain limitations of the Internal Revenue Code (the “Code”).

The Health System does not make any contributions to the Plan. However, the Health System makes a matching contribution to the Cooper Health System, Inc. Defined Contribution Retirement Plan for each participant who makes a salary reduction contribution to this Plan.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participants may transfer rollover contributions from other qualified retirement plans or individual retirement accounts, as defined.

Participants may invest in any investment option or combination of investment options offered by the Plan and can change their investment options at any time.

Participant Accounts

Each participant's annuity contract or custodial account is credited with the participant's contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's annuity contract and custodial account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's annuity contract or custodial account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon.

Participant Loans

Participants may borrow from their annuity contracts or custodial accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding balance of loans to the participant during the previous one-year period, or 50% of the participant's vested annuity contract or custodial account. Loans must be repaid within 5 years or up to 20 years for the purchase of a primary residence. The loans are secured by the balance in the participant's annuity contract or custodial account and bear interest at a rate determined by the plan administrator commensurate with local prevailing rates being charged by commercial lenders for similar loans. Principal and interest are paid ratably through payroll deductions.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Health System, as provided by the Plan's provisions. Administrative expenses paid by the Plan include record-keeping and loan transaction fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Health System and are excluded from the accompanying financial statements.

Payment of Benefits

Upon separation from service with the Health System due to death, disability, retirement, or termination, a participant may elect to receive either a lump sum or installments under the Plan. Effective March 1, 2020, if a participant makes no election and his or her annuity contract or custodial account balance is at least \$200, the amount is automatically rolled over to an Individual Retirement Account.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service ("IRS"). Effective January 1, 2020, a participant's contributions are no longer suspended for the six-month period following the date of a hardship distribution.

Plan Termination

Although it has not expressed any intent to do so, the Health System has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred.. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

Investments held by the Plan are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividend income for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, Equitable, MetLife, Lincoln, Empower, Empower Trust Company, LLC, and TIAA-CREF, the custodians of the Plan.

4. Fair Value Measurements

Fair value is defined under Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). To measure fair value, a hierarchy has been established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs. As such, the hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below.

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

The Cooper Health System 403(b) Plan

Notes to Financial Statements (continued)

4. Fair Value Measurements (continued)

- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value:

Mutual funds and self-directed brokerage accounts: Mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Self-directed brokerage accounts consist primarily of mutual funds and interest-bearing cash. Interest-bearing cash is valued based on cash deposited plus interest earned.

Guaranteed annuity contracts (non-benefit responsive): The guaranteed annuity contracts are not fully benefit-responsive investment contracts. Guaranteed annuity contracts are valued at contract value, which approximates fair value. Contract value is measured as accumulated cash contributions and transfers in, plus interest, minus withdrawals, charges, and transfers out. Each contract has a guaranteed minimum interest rate of between 1% to 3%.

Guaranteed interest options: The guaranteed interest options are not fully benefit-responsive investment contracts. Guaranteed interest options are valued at contract value, which approximates fair value. Contract value is measured as contributions and transfers in, plus interest, minus withdrawals, charges, and transfers out. Interest is credited daily to amounts deposited in the guaranteed interest options; the interest rate is reset periodically. The annual minimum guaranteed interest rate is never less than the lifetime minimum guaranteed interest rate. The interest rate credited to participants as of December 31, 2024 and 2023 was 2% to 3%.

4. Fair Value Measurements (continued)

Variable annuities: Variable annuities offered through TIAA-CREF are not sold directly to the public similar to mutual funds. The underlying assets of the variable annuities are traded daily; therefore, units in the variable annuities are calculated daily and published by an investment company. The changes in unit values reflect the gains, losses, dividends, and interest received by the underlying assets of the variable annuities. The unit value is determined in a manner similar to a net asset value calculation: dividing the net assets by the number of units outstanding. Variable annuities consist of CREF Accounts and a TIAA Real Estate Account (“REA”). The REA generally invests in real estate properties and real estate-related investments. Transfers out of the REA are limited to one per calendar quarter. The CREF Accounts invest principally in foreign and domestic common stocks, investment-grade fixed income securities, inflation-indexed bonds, and short-term investments in accordance with each portfolio’s investment objectives. To reduce market timing and excessive trading, generally a participant is locked out of a CREF Account for 90 days if a purchase, sale, and repurchase within that account is made within a 60-day period. Were the Plan to initiate a full redemption of the variable annuities, TIAA-CREF reserves the right to temporarily delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner.

Separate accounts: Separate accounts are established by the custodians through variable annuity accounts. Each separate account is made up of multiple subaccounts which hold a single registered mutual fund. Separate accounts are designed to seek long-term growth of capital or long-term capital appreciation and income with diversified securities of different asset classes and investment styles as each separate account strives to attain each portfolio’s investment objectives. The fair value of separate accounts has been determined using the net unit value (similar to net asset value) of the participation units. The net unit values of the participation units in the subaccounts are determined by the investment advisors based on the value of the underlying mutual funds held in the subaccounts, minus any contract charges, divided by the number of participation units outstanding. Participant-directed redemptions have no restrictions. Were the Plan to initiate a full redemption of the separate accounts, the insurance companies reserve the right to temporarily delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner.

Level 3 Purchases

During 2024, the Plan's participant-directed purchases of interests in the guaranteed annuity contracts and guaranteed interest options equaled \$207,161.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

6. Tax Status

The underlying volume submitter specimen plan has received an advisory letter from the IRS dated August 7, 2017, stating that the written form of the underlying specimen plan is qualified under Section 403(b) of the Code. Any employer adopting this form of plan will be considered to have a plan qualified under Section 403(b) of the Code and, therefore, the related custodial accounts and tax-deferred annuities are tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Investment Contracts with Insurance Company

The Plan holds the following fully benefit-responsive guaranteed contracts: Lincoln Fixed Account, MetLife Strategic Value Annuity, and MetLife Fixed Interest Option (collectively, "guaranteed interest accounts"); MetLife Stable Value contract – guaranteed investment contract; and TIAA Traditional Account – Benefit Responsive guaranteed annuity contracts. Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive investment contracts represents contributions plus earnings, less participant withdrawals and administrative expenses.

Guaranteed annuity contracts: The Traditional Annuity is offered by TIAA-CREF through three types of products for the Plan – Retirement Annuity (“RA”), Supplemental Retirement Annuity (“SRA”), and Group Supplemental Retirement Annuity (“GSRA”) (collectively, the “TIAA Traditional Annuity”). The TIAA Traditional Annuity is a fixed annuity contract that provides a guarantee of principal, a guaranteed minimum rate of interest, and the potential for additional interest as declared by TIAA-CREF. The contract value equals the accumulated cash contributions and interest credited to the Plan’s contracts, less any withdrawals. There are no restrictions on participant-initiated transfers and withdrawals for the SRA and GSRA; however, no lump-sum cash withdrawals are allowed for the RA and transfers must be spread out in ten annual installments.

Guaranteed investment contract: The guaranteed investment contract (“GIC”) is offered by MetLife and is credited with an interest rate, which renews annually. The assets of the GIC are invested in a MetLife separate account. Interest is credited to the contract at a rate that reflects the performance of the underlying portfolio within a MetLife separate account. The GIC has a minimum guaranteed interest rate of 1.0%. MetLife guarantees principal and accrued interest for participant-initiated withdrawals as long as the contract remains active.

Guaranteed interest accounts: The Strategic Value Annuity account offered by MetLife is credited with an interest rate, which generally varies with each deposit. The MetLife Fixed Interest Option contract and the Lincoln Fixed Account are credited with an interest rate, which renews annually. The guaranteed interest accounts have a minimum guaranteed interest rate of 3.0%.

7. Investment Contracts with Insurance Company (continued)

The issuer of each contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than a percentage as stated within the contract. Such interest rates are reviewed and may be reset frequently as stated within the contract.

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

The contracts will terminate on the date on which there are no deposit arrangements in effect under the contracts; provided, however, that provisions relating to annuities in the course of payment will continue to govern payment of such annuities until the final payment under each such annuity is made. In addition, the contracts do not permit the contract issuers to terminate the agreements unless the Plan is not in compliance with the insurance contract agreements.

8. Party-In-Interest Transactions

The Plan invests in certain investments managed by Fidelity Management Trust Company, Equitable, MetLife, Lincoln, Empower, and TIAA-CREF. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are reported as notes receivable from participants in the accompanying statements of net assets available for benefits.

In addition to the participant loans described in Note 1, the Plan permits participants with custodial accounts at TIAA-CREF, Lincoln, and MetLife (Contract #1071020) to take Plan loans. These Plan loans are issued directly from general assets owned by TIAA-CREF, Lincoln, and MetLife and not from the participants' custodial accounts. Plan loans are collateralized with participants'

custodial accounts which are held in the TIAA Traditional Account, Lincoln Fixed Account, or the MetLife Fixed Interest Option contract. Interest rates for Plan loans may be fixed or variable, and the initial rate is determined by the terms of the contracts. Principal and interest are paid directly to TIAA-CREF, Lincoln, or MetLife. Plan loans are not included in notes receivable from participants on the accompanying statements of net assets available for benefits. Approximately \$114,000 and \$141,000 of annuity account values as of December 31, 2024 and 2023, respectively, serve as collateral for the Plan loans, which are included in investments on the accompanying statements of net assets available for benefits.

9. Subsequent Events

Management has evaluated the need for additional disclosures and/or adjustments resulting from subsequent events for the Plan through October 15, 2025, the date the accompanying financial statements were available to be issued.
