## INDEPENDENT AUDITORS' REPORT

To the Trustees of the  
Children's Therapy Center 403(b) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Children's Therapy Center 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Children's Therapy Center 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Children's Therapy Center 403(b) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Children's Therapy Center 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE A.--DESCRIPTION OF PLAN**

The following description of Children's Therapy Center (Employer or Organization) (formerly known as Dynamic Partners) 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan originally became effective on January 1, 1997, as a defined contribution plan covering all employees of the Organization. The Plan adopted a volume submitter 403(b) Plan effective January 29, 2019. Employees must be age 21 and complete one year of service (500 hours). Effective January 1, 2020, the Plan was amended and restated to change the definition of compensation to exclude deemed section 125 compensation, offer QNEC's, as well as make various miscellaneous and regulatory changes. Effective December 31, 2023 the Plan was amended to incorporate the SECURE Act 1.0.

*Contributions:* The Plan is funded by participant elective deferrals of eligible compensation and discretionary employer matching contributions. Participants may contribute on a pre-tax basis up to the maximum amount allowed by law. All participants who are eligible to make elective deferral contributions may designate any or all of their deferrals as Roth elective deferrals. For the year ended December 31, 2024, the employer matching contribution was calculated as 25% of elective deferrals up to a maximum of \$1,500.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirements plans (rollover contributions). Contributions are subject to certain limitations.

*Participant Accounts:* Each participant's account is credited with the participant's contribution, allocation of the employers' contributions and plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, and as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

*Vesting:* Participants are immediately vested in their elective deferrals, rollover contributions and employer matching contributions, plus actual earnings thereon.

*Retirement:* The normal retirement date is the first day of the month on or after the date the participant turns 65. Early retirement may be taken on the first day of the month on or after the participant turns 55.

*Payment of Benefits:* On termination of service, due to death, payments shall be made to a beneficiary payable in a lump sum or other form as stated by the beneficiary. For termination of service due to disability or other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution, installment payments, annuity or may continue to participate in the Plan investments and benefit will be provided upon retirement or death. Terminated participants with a vested account balance of \$5,000 or less shall receive a single lump sum distribution of the entire account balance. If the participant does not provide consent, the balance will be rolled over to an IRA for the benefit of the participant. Hardship distributions are allowed in accordance with the provisions of the plan. In-service distributions upon attainment of age 59 ½ are allowed.

*Notes Receivable from Participants:* Participants are allowed to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance from Lincoln Financial Group Trust, Inc. Loans are to bear an interest rate of prime plus 1%. The minimum payment period is one month and the maximum payment period is twenty years if the purpose of loan was for the purpose of securing a primary residence. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. A participant may only have one loan outstanding. Principal and interest are paid through payroll deductions.

*Investment Options:* Participants are allowed to direct their contributions and account balances in investment options with Lincoln Financial. The plan sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

**NOTE B.--SUMMARY OF ACCOUNTING POLICIES**

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*Use of Estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Actual results could differ from those estimates.

**NOTE B.--SUMMARY OF ACCOUNTING POLICIES (Continued)**

*Investment Valuation and Income Recognition:* The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are recorded at contract value.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by the investment advisors and custodians. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants:* Under Lincoln Financial Group Trust, Inc., notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as benefit payments based on the terms of the plan document. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

*Payment of Benefits:* Benefits are recorded when paid.

*Plan Expenses:* The employer or the Plan may pay expenses of the Plan. Accordingly, certain expenses of maintaining the Plan are paid directly by the Organization or Employer and not included in these financial statements. Fees relating to administration of notes receivable from participants and distribution fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. The Plan pays for fees such as recordkeeping, compliance, custodial and trustee, and certain investment related expenses.

**NOTE C.--FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan invests in two group fixed annuity contracts issued by Lincoln that guarantee a fixed rate of interest: the Lincoln Stable Value Account and the Lincoln Fixed Account. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Contract value of the Plan's investment in the Lincoln Stable Value account was \$307,021 and \$351,594 at December 31, 2024 and 2023, respectively.

Contract value of the Plan's investment in the Lincoln Fixed Account was \$481 and \$108,465 at December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan that is declared quarterly. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the schedule maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Several events could cause the issuer to cancel the contract, such as non-payment of any charges, no additional deposit activity, or discontinuation. It is important to note that these events are highly unlikely. Upon termination by Lincoln, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

**NOTE D.--CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, net increase in contract value of investments, and dividend and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., and Lincoln National Life Insurance Company (the custodians of the Plan).

**NOTE E.--FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable annuity contracts:* The variable annuity contracts invest in pooled separate accounts which consist of a variety of underlying investments, primarily mutual funds valued at NAV provided by administrators of the funds, which is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets, less liabilities, and then divided by the number of units outstanding. There are no unfunded commitments, and the investments can be redeemed daily. However, participants that have chosen an annuity redemption and are receiving payments may change Plan investments but cannot receive payments other than the scheduled payments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE F.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are in funds managed by the custodians, Lincoln Financial Group Trust Company Inc. and Lincoln National Life Insurance Company; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

**NOTE G.--TAX STATUS**

Section 403(b) tax deferred annuity plans are not required to obtain determination letters from the Internal Revenue Service stating they are qualified under the Code. The Plan Administrator adopted a written plan in 2010 and believes the Plan has been designed and operated to comply with the applicable requirements of the Code and is tax exempt.

The plan sponsor adopted a 403(b) basic plan document provided by Lincoln Financial Group in 2010. The IRS established pre-approved plan programs under which a plan sponsor can obtain assurance that the written form of its plan satisfies Section 403(b).

Transition relief is provided to 403(b) plan sponsors who have made appropriate efforts to comply with the written plan requirement in the final regulations. The sponsor had adopted a written plan in 2010 which it believed satisfied the written plan requirement. The plan was amended and restated onto a pre-approved 403(b) Volume Submitter plan document on January 29, 2019 with the restated date of January 1, 2020.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

**NOTE G.--TAX STATUS (Continued)**

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions: however, there are currently no audits for any tax periods in progress.

**NOTE H.--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan shall become fully vested and non-forfeitable.

**NOTE I.--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate risk, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

**NOTE K.--OPERATIONAL ERRORS**

During the year ended December 31, 2024, a number of errors were discovered related to employer matching contributions following the transition from in-house payroll to Paylocity. As a result of the errors discovered, a matching contribution of \$2,296 was made during 2025, which is included as a receivable on the statement of net assets available as of December 31, 2024.

**NOTE L.--NON-EXEMPT TRANSACTIONS**

*Late Remittances*

As reported on the supplemental Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain Plan contributions of \$52,110 for the year ended December 31, 2024 were not remitted to the trust within the time frame specified by the Department of Labor’s Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company. During the year ended December 31, 2025, the Company will make contributions to the affected participants’ accounts to compensate for potential lost earnings resulting from the delays in the contributions for the nonexempt transactions that occurred during the year ended December 31, 2024.

**NOTE M.--SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
