## INDEPENDENT AUDITOR'S REPORT

### **Opinion**

We have audited the financial statements of California Health Insurance Trust for ACEC – California (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for plan benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), the related statement of changes in net assets available for plan benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for plan benefits of the Plan as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the changes in its net assets available for plan benefits in liquidation for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

## **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the California Health Insurance Trust for ACEC - California (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

### General

The Plan is a trust fund established on October 1, 1969 for the sole purpose of supporting and maintaining a welfare benefit plan program for the benefit of the companies that are association members of ACEC – California (the “Members”) and their eligible employees.

Employees of the Members and their dependents are eligible to participate in the Plan. The Plan is governed by a board of four (4) trustees (the Trustees, the “Plan Administrative Committee”) appointed by the American Council of Engineering Companies California. A board of three (3) to twenty-one (21) American Council of Engineering Companies California delegates will be selected by the member companies. Benefit and Risk Management Services, Inc. is designated by the Trustees as the third party administrator.

### Benefits

The primary purpose of the Plan is to provide dental, vision, disability, death and accidental death benefits for eligible employees and their dependents of the Members.

### Contributions

The Members will make periodic contributions to the Plan in an amount that the Trustees deem appropriate in order to enable the Plan Administrator to pay the premiums and other charges under the applicable group insurance contracts and otherwise to provide the benefits under the Plan for the Members’ employees and their dependents.

The Plan is funded exclusively through contributions from the Members that adopt the Plan. Contributions are collected and held by the Plan Administrator, who receives both member payments and employee self-payments, if applicable, and makes insurance premium and other payments on behalf of participants in the Plan.

### COBRA

Upon termination of a Member employee, the Plan is required to provide continuation of benefits through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”). COBRA contributions and payment of COBRA benefits are performed by the Plan Administrator. All COBRA activity is included in the financial statements of the Plan for the year ended December 31, 2024.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation

Due to the decision to terminate the Plan during 2024, management determined that liquidation of the Plan is imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. The 2023 financial statements were prepared as a going concern on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments in the 2024 Statement of Net Assets Available for Plan Benefits are reported at liquidation value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation.

All investments on the 2023 Statement of Net Assets Available for Plan Benefits are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the plan for its investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investments return for applicable investments.

Revenue Recognition

Revenue is recognized for billed premium contributions, commissions and other related fees in the month for which the related insurance coverage applies.

Insurance Premiums Paid for Benefits and Benefit Obligations

Benefits are provided to the Members' eligible employees and their dependents, which are in need of medical care, through insurance arrangements that transfer the risks of loss or liability to insurance carriers. Insurance premiums paid for benefits are recorded as they become due and payable by the Plan. As of December 31, 2024 and 2023, there were no premiums due to insurance carriers by the Plan.

Commission Income

The Plan generates insurance broker commission income equivalent to the agreed-upon percentage rate of monthly premiums. This commission is received on a monthly basis and is recorded in the month for which the related insurance coverage applies.

Administrative and Other Fees Billed to Members

The Plan charges administrative fees of \$10.50 per participant each month. These administrative fees are paid to the Plan Administrator on a monthly basis.

Additionally, the Plan charges a trust fee to cover other operating expenses incurred by the Plan including, but not limited to, accountants, actuaries, attorneys, consultants, investment managers and analysts, as designated by the Trustees. Trust fees are adjusted periodically by the Trustees, and vary by insurance carrier and Members.

Concentration of Credit Risk

*Cash and Cash Equivalents*

The Plan maintains its cash and cash equivalent balances in financial institutions which, from time to time, may exceed amounts insured by the Federal Deposit Insurance Corporation (FDIC), up to \$250,000 for interest-bearing accounts and noninterest-bearing accounts. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on cash.

*Major Members*

For the years ended December 31, 2024 and 2023, there were no Plan billings as a result of the premium holiday which commenced January 1, 2023, as further described under Note 4.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Financial instruments included in the Plan's statements of net assets available for plan benefits include cash equivalents and investments. For cash equivalents, the carrying amounts represent a reasonable estimate of fair values due to their short-term maturity. Investments are reflected at estimated fair value as described below.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, the determination of which category within the fair value hierarchy is appropriate for any given instrument is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the instrument.

**NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Cash and cash equivalents:* Valued at the carrying value, which approximates fair value due to short-term nature of such instruments.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Exchange traded funds:* Valued at the closing price as reported on the active market on which the ETF is traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – PLAN TERMINATION**

The Trustees have the right under the Plan to terminate the Plan at any time subject to the provisions of the Employee Retirement Income Security Act (ERISA). In the event the Plan terminates, the trust net assets shall be distributed by the Trustees in the following order unless a judgment or decree of a court of competent jurisdiction or any applicable law shall mandate a contrary application:

- a. Payment of benefits to eligible employees and their dependents, which are payable from the trust as the Plan Administrator shall direct the Trustees in writing.
- b. Payment of premiums or similar benefits described in Code Section 501(c)(9) and the regulations under that Section to eligible employees or their dependents or designated beneficiaries as the Plan Administrator shall direct the Trustees in writing. Objective criteria are to be used to restrict eligibility for the benefits and a disproportionate amount of the benefits are not to be provided to officers, shareholders, or highly compensated employees of the Members and its related organizations.
- c. Payment of all reasonable and necessary expenses of managing and administering the Plan to the extent that the expenses are not paid by the Members.
- d. In the event of Plan termination resulting in a deficit, the Members will absorb the loss.

On December 6, 2022, the Trustees of the Plan determined that the trust should wind up its affairs and terminate over the next few years. In order to do so, the Trustees decided to use the Plan's assets to provide a premium holiday to the participating employers and their employees which commenced as of January 1, 2023. The duration of the premium holiday is estimated to be approximately 30 months (coverage through June 30, 2025).

**NOTE 5 – TAX STATUS**

The trust established under the Plan to hold the Plan’s net assets is intended to qualify, pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), as a tax-exempt organization. The trust applied for a tax determination letter from the Internal Revenue Service (“IRS”), which was approved and is applicable as of October 24, 1974. The Plan Administrator believes that the Plan and trust are designed and are currently being operated in compliance with the applicable requirements of the IRC and continue to be tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are cash credits with Wedbush, the investment advisor of the Plan. Therefore, these transactions qualify as party-in-interest transactions permitted by the United States Department of Labor’s Rules and Regulations. The Plan Members and Plan Administrator are also a party-in-interest with respect to the Plan.

**NOTE 7 – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
