Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Sobrato Organization 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Sobrato Organization 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Description of Plan

General

Effective October 1, 1989, Sobrato Organization (the "Plan Administrator", or "Plan Sponsor", or "Company") adopted a defined contribution 401(k) plan (the "Plan") covering all eligible employees of the Company. The Plan excludes residents of Puerto Rico and employees covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan. The Plan was restated on November 26, 2021.

The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company has appointed an Administrative Committee (the "Committee") to manage the operations and administration of the Plan. The Company has contracted with Fidelity Management Trust Company ("Fidelity") as the trustee, custodian, and the third-party administrator to process and maintain the records of participant data and monitor compliance with governmental regulatory requirements.

Contributions

Each year, participants may elect to defer 100% of their annual gross compensation as defined in the Plan Document. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds and a common collective trust fund to its participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically entered into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Company is allowed to make discretionary matching contributions as defined in the Plan Document and currently matches 100% of employee deferral contributions up to a maximum of 10% of eligible compensation, capped at \$12,000 annually. The Company's matching contributions for the years ended December 31, 2024 and 2023 were \$896,403 and \$748,173, respectively. Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Company's matching contributions plus actual earnings thereon are vested 50% after the first year of service and 100% after the second year of service.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at 1.25%. Loan terms range up to 5 years, including for the purchase of a primary residence. A participant may only have one loan outstanding at any time. Principal and interest are paid ratably through semi-monthly payroll deductions. Effective October 14, 2024, the Plan amended their service agreement with Fidelity to issue new loans with interest rates at the prime rate.

Payment of benefits

Upon reaching the age of 59½ and at the discretion of the participant or upon termination of service due to death, disability, or retirement, a participant or the designated beneficiary may elect to receive a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account.

Upon termination, if the participant's or beneficiary's vested account balance is \$5,000 or less, the Plan allows the trustee to distribute the vested account balance to an Individual Retirement Account ("IRA") for the participant's benefit. If the vested balance is \$1,000 or less, it will be distributed as a lump-sum amount without the participant's consent.

Forfeited accounts

Forfeitures of non-vested employer contributions may first be used to pay Plan administrative expenses and any remaining amounts may be used to reduce future employer contributions payable under the Plan. At December 31, 2024 and 2023, forfeited non-vested balances were \$43,117 and \$13,888, respectively. For the year ended December 31, 2024 and 2023, no forfeitures were used to pay Plan administrative expenses.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Note 2 - Summary of accounting policies (continued)

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

The Plan's investment in the Managed Income Portfolio Class 2 Fund, a common collective trust fund, represents an indirect investment in a fully-benefit responsive investment contract, which is reported at fair value without presenting the adjustment to contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan Document. No allowance for credit losses was deemed necessary by the Plan Sponsor based on an assessment of the outstanding notes receivable from participants at December 31, 2024 and 2023.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions of \$5,142 to the affected plan participants on March 5, 2025.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, participants' withdrawals, as well as quarterly record-keeping fees from the third-party administrator are charged directly to the participants' accounts and are included in administrative expenses. Such fees totaled \$1,119 and \$1,000 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment management services are also included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

In preparing its financial statements, the Plan has evaluated subsequent events through October 14, 2025 which is the date the financial statements were available to be issued.

Note 3 - Certified investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management, and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

The Plan's investments in mutual funds and the common collective trust fund (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,989,281 and \$2,172,344 during 2024 and 2023, respectively.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

No assets were noted at Levels 2 and 3 for the years ended December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 4 - Fair value measurements (continued)

The Plan's common collective trust fund is invested in high-quality benefit-responsive investment contracts, fixed income securities, and money market funds. The underlying investments may include U.S. Treasury and agency bonds, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset-backed securities, and collective investment vehicles and shares of investment companies that invest primarily in fixed income securities, as well as futures contracts, options contracts, and swap agreements. The fair value of the Managed Income Portfolio Class 2 Fund, a common collective trust fund, is based on the investment's (NAV) per unit, as reported by the manager of the fund. The initial pricing input is the quoted price obtained for the underlying fund, which is then adjusted to apply factors disclosed in the contract. There is no immediate recognition of the investment gains and losses on the fund's securities. Instead, gains or losses are recognized over time by periodically adjusting the interest rate credited to the fund under the synthetic wrap. The synthetic wrap allows a stable value fund to maintain a constant NAV and protects the fund in certain circumstances.

Note 5 - Rollover contributions

During 2024, rollover contributions of \$187,435 from other plans came from four active participants. During 2023, rollover contributions of \$161,537 from other plans came from five active participants.

Note 6 - Related party transactions and party-in-interest transactions

The common collective trust fund and certain Plan investments in mutual funds are managed by Fidelity. Fidelity is the trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Refer to **Note 2 - Expenses** for expenses of the Plan paid by the Plan Sponsor as well as the Plan participants to the party-in-interest. All these transactions are considered party-in-interest transactions under ERISA regulations but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 7 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8 - Tax status

The Internal Revenue Service has determined and informed Fidelity by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Committee and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date and through the date of issuance of the financial statements. Plan management is currently in the process of determining the full extent of the errors related to the compliance matters (see Note 10). Plan management does not expect these errors to affect the Plan's tax-exempt status.

Note 8 - Tax status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position not likely to be sustained upon examination by taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 9 - Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks related to geopolitical tensions, economic instability, and changes in international trade policies, including the imposition of new tariffs, could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 10 - Plan compliance matters

For the years ended December 31, 2022 and 2021, employer matching contributions were calculated and funded on a per-pay-period basis rather than an annual basis as required by the Plan document, and the related true-up contributions were not funded. The effect of this error will be recognized in the period the corresponding true-up contributions are funded by the Plan Sponsor. The 2022 and 2021 true-up contributions were funded subsequent to year-end, on June 30, 2025.

For the years ended December 31, 2024 and 2023, it was discovered that participant deferral election changes were not consistently updated for calculating employee deferrals. Plan management believes the correction is not significant to the financial statements. The effect of this error will be recognized in the period the corresponding correction is funded by the Plan Sponsor. Plan management is currently working with Fidelity to determine the full extent of the 2024 error. Corrections for the 2023 errors were funded subsequent to year-end, on July 9, 2025.
