We have performed audits of the financial statements of Hachette Book Group, Inc. 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

**Note 1. Plan Description**

The following description of the Hachette Book Group USA 401K Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan was established on April 1, 2006 and amended and restated May 10, 2021 to reflect the Bipartisan Budget Act of 2018 and Code Sections 401(k) and 401(m) 2019 Final Hardship Regulations. Effective January 1, 2022, the Plan was amended to allow employees of Storey Publishing, LLC, Timber Press, Inc. and Workman Publishing Company, Inc. to participate in the Plan. The Plan adopted the Coronavirus Aid, Relief, and Economic Security ("CARES") Act September 9, 2022. The Plan is a defined contribution plan covering eligible employees of Hachette Book Group, Inc. and affiliated companies as defined in the Plan document (collectively, the "Company" or "Employer"). The Plan is administered by the Company's Pension and Benefits Board consisting of persons appointed by the board of directors of the Company. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA").

Contributions to the Plan are deposited with Fidelity Management Trust Company ("FMTC" or the "Trustee").

***Participant Eligibility***

Employees are eligible to participate in the plan immediately following their hire date.

***Contributions***

***Participant Deferrals***

A participant's pre-tax or Roth contributions made on his/her behalf by the Company for a Plan year consists of a deferral contribution ("Deferral Contribution"). A Deferral Contribution is an agreement ("Salary Reduction Agreement") by an employee to have contributed to the Plan up to 50% of his/her gross salary for each pay period (in 1% increments), subject to Internal Revenue Code ("IRC") limitation. Employees of 50 years of age and over who are making Deferral Contributions to the Plan may also make a catch-up contribution of up to \$7,500 in both 2024 and 2023. Employees are also able to make after-tax contributions to the Plan subject to the limitations of the IRC.

***Employer Non-Discretionary Matching Contributions***

The Company makes a non-discretionary matching contribution, which is 66.67% of the first 6% of the eligible contribution to the Plan for participants who complete one year of service with at least 1,000 hours.

***Employer Discretionary Contributions***

The Company may make a discretionary contribution. An employee must be employed on the last day of the Plan year to be eligible for the employer discretionary contribution. The Company did not make an employer discretionary contribution for the years ended December 31, 2024 and 2023.

***Participant Account***

Individual participant accounts are credited with participant contributions, the Company's contributions, and investment earnings or losses thereon, and charged with withdrawals and expenses. Contributions to the Plan are invested by the Trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

***Vesting***

Participant's contributions and earnings thereon are immediately vested at all times. The Company's non-discretionary matching contribution, non-elective contribution, and discretionary contribution will become vested in accordance with the following schedule:

Participants become 100% vested in the Company contributions upon normal retirement age (65) or disability.

***Forfeitures***

The non-vested portion of a participant's account is forfeited when the participant leaves the Company. Forfeitures are then retained by the Plan and are used to fund the Company's contributions. The following is the approximate forfeiture account activity for the years ended December 31, 2024 and 2023:

***Rollover Contributions***

Participants may make rollover contributions to the Plan before becoming eligible to participate in the Plan. However, they will not yet become a participant entitled to make pre-tax contributions and share in Employer contributions until Plan eligibility requirements have been met. Rollover contribution accounts will be subject to the terms of the Plan and will always be fully vested and non-forfeitable. If the rollover to the Plan is not a direct rollover from a prior employers' qualified plan but from a participants' personal Individual Retirement Account, it must be received by the Trustee within 60 days of the participant's receipt of the distribution.

***Distributions***

A participant's vested interest may be distributed upon termination of employment, disability, death or after attainment of age 59.5. Distributions will be made in the form of one of the following: a) lump-sum cash distribution, b) direct rollover distribution, c) combination cash distribution and direct rollover distribution, d) installment payments and partial withdrawals. In addition, distributions are available in the event of a hardship, subject to requirements in the plan document.

***Administrative Expenses***

Administrative expenses incurred by the Plan are primarily paid by the Company, except for application and loan maintenance fees, which are paid by the respective participants out of their accounts.

***Notes Receivable from Participants***

The Plan allows participants to borrow money from their accounts, as follows: (a) loans shall be granted in a uniform and nondiscriminatory manner; (b) the aggregate amount of all such loans to a participant shall not exceed the lesser of 50% of the participant's total vested interest in the Plan, or \$50,000, reduced by the highest outstanding loan balance in the account during the prior twelve month period; (c) the minimum loan amount is \$1,000; (d) the loan must be paid within 5 years (10 years for residence purchase), and (e) in the event of the termination of the participant before the loan is repaid in full, the unpaid balance thereof, together with interest thereon, shall become due and payable and the Trustee shall first satisfy the indebtedness from the distribution payable to the participant before making any payment to the participant's designated beneficiary.

The interest rate charged to the participant on a loan from the Plan is a reasonable interest rate as determined by the plan administrator based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate will remain fixed throughout the duration of the loan. Loan repayments are made through payroll deductions. Interest rates ranged between 3.25% and 9.50% at December 31, 2024.

***Plan Termination***

The Company expects to continue the Plan indefinitely, but it may terminate the Plan at any time. At the time of termination, all participants will become 100% vested and non-forfeitable without regard for their years of service (participants must be active employees at the time of termination). The plan administrator will instruct the Trustee either (1) to continue at the time to administer the Plan until all funds are depleted, or (2) to distribute the assets remaining in the funds. If the funds are to be distributed, the Trustee will distribute to each participant the amount credited to his/her account as of the termination date.

***Plan Mergers***

The Plan was amended effective April 1, 2022 when Workman Publishing Company Thrift and Profit Sharing Plan, Storey Publishing Savings and Retirement Plan, and Timber Press, Inc. 401(k) Plan were merged into the Plan. During the year ended December 31, 2023, an amount of unallocated funds related to a revenue credit was transferred into the Plan from the prior Workman Publishing Company Thrift and Profit Sharing Plan totaling \$15,646.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Benefits Paid to Participants***

Benefit payments to participants are recorded upon distribution.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions in the year a default occurs.

***Subsequent Events***

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available for issuance.

**Note 3. Risks and Uncertainties**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

**Note 4. Information Certified by the Plan's Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

**Note 5. Fair Value Measurements**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation techniques used to measure fair value are defined as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at both December 31, 2024 and 2023.

Mutual Funds: Shares held by the fund at year-end are valued based on quoted prices in an active market.

Common Collective Trust: The fair value of the common collective trust is determined by the trustee of the common collective trust based on the fair value of underlying assets, which represent the net asset value, a practical expedient to fair value, of units held by the Plan. The common collective trust does not have any unfunded commitments relating to its investments, or any restrictions on redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

Brokerage Options: Valued at the closing price reported on the active market in which the individual investments are traded. Investments include Fidelity Mutual Funds, Common Stock, External Mutual Funds and Cash.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

**Note 6. Income Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 7. Party-in-Interest Transactions**

Certain Plan investments are managed by FMTC, the Trustee as defined by the Plan. Therefore, these investments qualify as party-in-interest transactions under the Department of Labor’s rules and regulations. Fees paid to FMTC for administrative services amounted to \$111,448 and \$100,837 for the years ended December 31, 2024 and 2023, respectively. FMTC receives revenue from certain investments of the Plan. Fees paid for advisory services amounted to \$91,956 and \$75,704 for the years ended December 31, 2024 and 2023, respectively.

**Note 8. 8. Excess Contributions Payable**

Excess contributions payable represents amounts owed to participants who made excess contributions based on compliance testing performed by the Plan’s recordkeeper. The excess contributions payable as of December 31, 2024 and 2023 were remitted by the Plan to the participants in June 2025 and September 2024, respectively.

**Note 9. Reconciliation of Financial Statements to Form 5500**

The Form 5500 was prepared on the cash basis for the Plan year ended December 31, 2024 and 2023 and the financial statements were prepared on the accrual basis.
