## **INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees of the  
Taylor Electric Inc. Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Taylor Electric Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Taylor Electric Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Taylor Electric Inc. Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the

supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE A - DESCRIPTION OF PLAN

The following description of the Taylor Electric, Inc. ("Company") Retirement Plan ("Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

General – The Plan is a 401(k) Profit Sharing Plan with 401(k) and 401(m) provisions covering all full-time employees of Taylor Electric, Inc. ("the Company") who have completed one year of service or have completed at least five hundred hours of service in three plan years. They are then eligible to enter on the first day of the Plan quarter once eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions – Each year participants may contribute a percentage of pretax annual compensation, as defined by the Plan, up to the statutory dollar maximums imposed under the Internal Revenue Code (IRC). Contributions may also be characterized as ROTH (after-tax) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the IRC annual limit of \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a designated target-date fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a menu of mutual funds and a cash equivalent fund as investment options for participants. The Company made a matching contribution equal to 40% of each participant's salary deferral that does not exceed 6% of compensation for the year ended December 31, 2024. The matching contribution is calculated and paid every pay period. All contributions are invested as directed by the participant. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. All contributions are invested in a portfolio of investments as directed by the participant. Contributions are subject to certain statutory limitations.

## NOTES TO FINANCIAL STATEMENTS (Continued)

### NOTE A - DESCRIPTION OF PLAN (Continued)

Participant Accounts – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution, (b) Plan earnings and/or (losses), and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Forfeited Accounts - At December 31, 2024 and 2023, the value of forfeited, non-vested accounts were \$39,895 and \$19,003 respectively. These accounts will be used to reduce future employer contributions or to pay Plan expenses. During the Plan year ending December 31, 2024, the employer did not use any forfeitures to pay Plan expenses or offset employer contributions.

Investment Options – Investments of the Plan consisted of mutual funds and a cash equivalent account held at Ascensus Trust Company, the custodian, during the year ended December 31, 2024. Participant salary deferral contributions and employer matching contributions and are invested in the investment platform offered by the Plan based solely upon instructions received from participants.

Payment of Benefits – On termination of service, disability, retirement, or death, a participant will receive a lump-sum amount equal to the vested value of his or her account on the distribution date. The Plan allows for hardship withdrawals, as defined by the Plan. For termination of service due to other reasons, a participant may receive all or any portion of the vested value of their interest in his or her rollover account.

Expenses – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair values of investments.

### NOTE A - DESCRIPTION OF PLAN (Continued)

Vesting – Participants are vested in their accounts based on years of continuing service. A participant is 100% vested after five years of credited service. Participants are immediately vested in their elective deferrals and contributions from other plans.

### NOTE B - SUMMARY OF ACCOUNTING POLICIES

Date of Management's Review of Subsequent Events - Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting - The financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment committee determines the Plan's valuation policies. See Note C for discussion of fair-value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating Expenses - The Plan or the Company can elect to pay the operating expenses of the Plan.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payment of Benefits - Benefits are recorded when paid.

### NOTE C - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the period presented and there were no changes in the methods used to measure fair value as of December 31, 2023 and 2024.

#### *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted, net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

### NOTE D - TAX STATUS

The IRS has determined and informed the Company by a letter dated August 21, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended (see Note H) since receiving the August 21, 2015 determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believe, as of December 31, 2024, that the Plan was qualified and the related trust tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate the tax position taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audit by tax authorities however, there are currently no audits for any tax periods in progress.

### NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### NOTE F - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are mutual funds managed by Ascensus Trust Company. Ascensus Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$29,540 for the year ended December 31, 2024

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### NOTE I - PLAN AMENDMENTS

Effective January 1, 2024, the Company adopted an amendment to the Taylor Electric, Retirement Plan (the "Plan") to eliminate all provisions related to the Employee Stock Ownership Plan ("ESOP") component of the Plan. The Plan previously operated as a KSOP, which combined features of both a 401(k) and an ESOP. Under the amendment, the Plan continues as a 401(k) plan that includes 401(m) matching contribution provisions but no longer maintains an ESOP feature. Prior to the amendment, a portion of employee rollovers had been used to acquire and allocate employer stock to participants' rollover accounts through the ESOP component. As a result of the amendment, all employer stock previously held by the Plan was distributed out of the Plan to the affected participants.

Effect on Benefits and Net Assets:

- No additional allocations of employer stock will be made after the effective date of the amendment.
- The amendment did not reduce participant account balances or vested benefits.
- The Plan continues to provide for salary deferral contributions under section 401(k) and employer matching contributions under section 401(m).

The amendment effectively converted the Plan from a KSOP to a traditional 401(k) profit sharing plan, eliminating the ESOP provisions while maintaining the existing participant-directed investment structure. In addition, the plan was amended effective January 1, 2024 to allow an Eligible Employee who has not satisfied the Year of Eligibility Service requirement but who has completed at least five hundred Hours of Service in three Plan Years to be deemed to have satisfied the Year of Eligibility Service requirement.
