INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Fiduciary Committee of
The University of Pennsylvania Health
System 403(b) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the University of Pennsylvania Health System 403(b) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the University of Pennsylvania Health System 403(b) Retirement Savings Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the University of Pennsylvania Health System 403(b) Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about University of Pennsylvania Health System 403(b) Retirement Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit Section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the University of Pennsylvania Health System 403(b) Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about University of Pennsylvania Health System 403(b) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4(i)—Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or

is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion-

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF PLAN

The following description of the University of Pennsylvania Health System (UPHS) 403(b) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the University of Pennsylvania Health System ("UPHS") who have completed an hour of service. The Plan is subject to the provisions of ERISA. The Board of Directors of the Health System controls and manages operation and the administration of the Plan. The Plan Administrator and the Fiduciary Committee are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Each year, participants may contribute up to 75% of their pretax annual compensation, as defined. Bonuses are excluded from eligible compensation. There are no Plan Sponsor contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Plan annual earnings. All contributions to the Plan are used to purchase tax-sheltered annuity contracts and custodial accounts that are invested in the funding vehicles offered by TIAA, and Fidelity Management Trust Company. Assets held under the tax-sheltered annuity contracts and/or custodial accounts do not belong to the Plan but are held by TIAA and College Retirement Equity Fund (CREF) for the exclusive benefit of the Plan's participants and their beneficiaries. The individual account balance in the annuity contract and/or custodial account is the sum of the participant's contributions and matching contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of 50% of the vested balance of a participant's account balance, or \$50,000. A participant may have no more than two loans outstanding at any time. Loan terms may extend to a period not to exceed five years, or for a reasonable period of time over five years for the purchase of a primary residence. The loans are secured by balances in the participant's account. The loans bear interest at local prevailing rates for similar loans at the date the loan is issued. Principal and interest are paid ratably through periodic payroll deductions.

Plan Loans

Plan loans are issued as separate contracts by TIAA as contemplated under Internal Revenue Code (IRC) Section 72(p)(5) and do not represent Plan assets. Loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of his or her Fidelity Traditional account balance subject to annuity contract and Plan provisions. Loan terms range from one to five years in one-year increments (up to 10 years for the purchase of the participant's primary residence). Principal and interest are paid by the participant to Fidelity and each payment will reduce amounts collateralized by the borrowing participant's Fidelity Traditional account balance. Plan loans totaled \$1,148,261 and \$1,421,111 at December 31, 2024 and 2023, respectively.

If certain qualifying events occur, the loan becomes immediately due and payable with all interest and represents the plan loan default fund investment. Investments underlying defaulted loan balances are reflected in the Statement of Net Assets Available for Benefits until a distribution event occurs. This investment contract totaled \$618,139 and \$602,689 at December 31, 2024 and 2023, respectively. TIAA and CREF will utilize collateral in this investment to offset loans.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a distribution of his or her entire accumulated Plan balance, subject to the terms and certain limitations of the funding vehicles. Distribution options include lump-sum payments, partial payments, and installments. In addition, participants may elect in-service withdrawals after reaching age 59½. Hardship withdrawals are also permitted.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee/custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The mutual funds consist of accounts held at TIAA, CREF, Fidelity Management Trust Company and other non-proprietary mutual funds and are generally valued using market quotations or prices obtained from independent pricing services.

The CREF accounts and the TIAA Real Estate Account are used to fund variable annuity contracts. The CREF accounts invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. The TIAA Real Estate Account is a pooled separate account/insurance company separate account of TIAA investing mainly in real estate and real estate-related investments. Its value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally by using external appraisals. The TIAA Real Estate Account sometimes holds securities as well. The Prudential Guaranteed Income Fund is a pooled separate account/insurance company separate account of Fidelity. Its value is principally derived from the market value of the underlying fixed income investments. Both pooled separate accounts are generally valued using independent pricing sources.

The TIAA Traditional Annuity is another investment of the Plan, which is reported at contract value and segregated into non-benefit and fully benefit-responsive categories. The contract value of the TIAA Traditional Annuity equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any) less any withdrawals and transfers out (if any). Fair value approximates contract value for non-benefit-responsive versions of TIAA Traditional and fully benefit-responsive contracts are reported at contract value. TIAA's Traditional Annuity contract's fair value would be considered to be approximately the same value as the contract value.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

A participant's benefits will normally be distributed to the participant or the participant's beneficiary upon termination of service, retirement, disability or death, by transfer to another qualified plan or an individual retirement account through a lump-sum distribution or installment payments. In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59½. Hardship withdrawals are permitted when the criteria are met. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time. Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of fair value of investments. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

Contributions

Contributions from plan participants are recorded in the year in which the participant compensation is earned.

NOTE 3 - PLAN RECORDS MANAGEMENT

In November 2007, the Department of Labor issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting and disclosure requirements under Part 1 of Subtitle B of Title I of ERISA. Prior to the amended regulations, the Plan was not viewed as a separate reporting entity. Historically, the Plan was viewed as a collection of individual contracts with which participants could engage in a range of actions with limited involvement, if any, by the Plan Sponsor. Accordingly, various accounting and payroll records related to the Plan's 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009 were not sufficiently maintained by the Plan. Consequently, the Plan's financial statements have been prepared based on available records analyzed by Plan management. As certain records were not available from the inception of the Plan, the effect, if any, on the completeness or accuracy of the Plan's financial statements cannot be determined.

**NOTE 4 - INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEE/CUSTODIAN
(UNAUDITED)**

The current custodian and trustee of the Plan are the Teachers Insurance and Annuity Association of America (TIAA) and Fidelity Management Trust Company, respectively.

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, and Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equity Fund ("CREF"), the custodian of the Plan as of and for the year ended December 31, 2024, have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Certain information related to investments, at fair value and contract value, and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedules, include investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and Fidelity Management Trust Company (qualified institutions), custodian and trustee of the Plan, respectively.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual fund investments and self-directed brokerage accounts are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs), valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.
- TIAA Real Estate Account and the Prudential Guaranteed Income Fund (pooled separate accounts) are derived from the market value of the underlying real estate holdings, other real estate-related investments and fixed-income assets. The real estate holdings are valued principally using external independent appraisals. Accumulation units are available for transactions at the closing accumulation unit value on any day that the NYSE is operating. TIAA ensures that any redemptions or withdrawals are executed at quoted unit values.
- Non-benefit-responsive insurance contracts are valued at contract value, which approximates fair value. The contract value equals the accumulated cash contribution and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that would impact the value realized upon exiting the contract.

Investments in TIAA Traditional Annuity contracts (fixed annuity contracts) are contract based. Observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The fair value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to these investments that could impact the value realized upon exiting certain types of contracts with the TIAA Traditional Annuity contract. See also Note 2 for discussion of the TIAA Traditional Annuity. In determining the reasonableness of the methodology, Plan management evaluates a variety of factors, including a review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through a review of contract terms, while others are substantiated utilizing available market data.

The preceding methods described may produce a fair value calculation that may not indicate net realizable value or reflect future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - CONTRACTS WITH INSURANCE COMPANY

The Plan has variable annuity contracts with TIAA and CREF, which allow participants to allocate their contributions as premiums into a number of investment accounts with varying levels of market risk. Premiums allocated to variable annuity contracts purchase a number of accumulation units in the selected accounts. Accumulations are not guaranteed and may increase or decrease depending primarily on investment results. Participants may convert accumulation units to payments of annuity units in accordance with the terms of the employer plan and options available under the contract. If a participant dies prior to receiving benefits, the accumulation will provide a death benefit for the participant's beneficiary. Participants may withdraw all or part of their accumulations before starting to receive benefits and may transfer all or part of their accumulations among the Plan's other options in accordance with the terms of the employer plan.

The Plan has benefit-responsive fixed annuity contracts with TIAA. Contributions buy a contractual or guaranteed amount of future benefits for the investing participant. The contracts guarantee principal and a minimum interest rate and provide the opportunity for additional amounts in excess of the guaranteed rate. Allocations are backed by TIAA's claims-paying ability.

The guaranteed annual interest rate is 3% for all premiums under all accumulating contracts. For the TIAA Traditional Non-Benefit Responsive, the Retirement Annuity (RA) contract does not allow lump-sum cash withdrawals, and transfers must be spread over a period of 10 annual installments. With the Group Retirement Annuity (GRA) contract, lump-sum withdrawals are available only within 120 days after termination of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from the RA or GRA contracts must be spread over a period of 10 annual installments (or five annual installments for withdrawals after termination of employment through election of a five-year, fixed-period annuity). Institutional withdrawals from the TIAA Traditional Annuity in the RC contracts are allowed over a 60-month (five-year) period, with 30-day advance notice from the institution. The RA balance at fair value was \$9,587,409 and \$10,348,730 at December 31, 2024 and 2023, respectively.

The Supplemental Retirement Annuity (SRA) and Group Supplemental Retirement Annuities (GSRA) contract balances at contract value were \$44,856,200 and \$48,176,962 at December 31, 2024 and 2023, respectively.

The TIAA Traditional Annuity for Benefit Responsive within the SRA and GSRA contracts, as well as notes receivables from participants on the statement of changes in net assets available for benefits have no liquidity restrictions (other than the "equity wash" provision that applies to certain TIAA Traditional RCP contracts are benefit responsive as contemplated by FASB ASC 962-325-35-5. The TIAA Traditional Annuity holding within the RA, GRA and RC contracts have liquidity restrictions and are non-benefit responsive.

NOTE 6 - CONTRACTS WITH INSURANCE COMPANY *(continued)*

These contracts allow participants to allocate their contributions as premiums towards the purchase of a definite amount of lifetime benefits. Accumulated premiums are credited with a guaranteed interest rate and may also be credited with additional amounts declared by TIAA. Participants may receive benefits in accordance with the employer plan and options available under the contract. If a participant dies prior to receiving benefits, the accumulation will provide a death benefit for the participant's beneficiary. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed of the Plan.

Because the fixed annuity contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed annuity contract. The fixed annuity contracts are presented on the face of the statements of net assets available for benefits at contract value, which has been determined by TIAA to approximate fair value. Contract value, as reported to the Plan by TIAA and CREF, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. For accumulating RA contracts, the crediting interest rate was 4.61% and 4.85% as of December 31, 2024 and 2023, respectively. For accumulating SRA and GSRA contracts, the crediting interest rate was 5.75% and 5.39% as of December 31, 2024 and 2023, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exception under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The fixed annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 7 - RELATED-PARTY TRANSACTIONS

The Plan investments are managed and issued by TIAA and CREF and Fidelity Management Trust Company. TIAA, FSB, and Fidelity Management Trust Company are the custodian and trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to the custodian are reflected as a reduction in investments earnings.

Certain administrative functions of the Plan are performed by employees of the Plan Sponsor. No such employee receives compensation from the Plan. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any such intent, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts and the balance of the individual accounts of each participant would be distributed in a lump sum or by delivery of a fully paid annuity contract, as defined by the Plan.

NOTE 9 - TAX STATUS

The Plan intends to comply with the applicable requirements of Section 403(b) of the IRC. A tax determination letter program is not yet available for 403(b) employee benefit plans through the Internal Revenue Service (IRS). The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in accordance with the applicable requirements of Regulation 1.403(b)-3 of the Code. The Plan is required to operate in conformity with the IRC to maintain the tax exempt status for plan participants under section 403(b). The Plan has elected to utilize the employee benefit plan provisions, which allow certain changes to distribution and loan rules as prescribed by the SECURE Act and CARES Act. The IRS, the primary oversight body of the Plan, generally has the ability to examine income tax returns for up to three prior years.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any periods.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to several risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.
