Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of NOX US, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of NOX US, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

December 31, 2024 and 2023

Plan Description

The following description of NOX US, LLC (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who are 21 years of age, except employees covered by a collective bargaining agreement, nonresident aliens, leased employees, temporary employees, seasonal employees, and part-time employees who are scheduled to work less than 480 hours per year. Participants may begin deferring and receiving safe harbor matching contributions immediately upon hire date or turning age 21. The Company's discretionary matching and profit sharing contributions are limited to employees who have completed three months of service. Part-time, temporary, or seasonal employees become eligible to participate in the Plan after completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2021, participants are auto-enrolled to withhold 6% of eligible compensation and increasing 1% at each anniversary date to a maximum of 10%. Participants may opt out of the Plan or change the withholding percentages at any time. Effective January 1, 2023, participants are auto-enrolled at 3%.

Effective January 1, 2023, the Plan was amended to include safe harbor matching provisions whereby the Company commits to matching 100% up to 3% of eligible compensation and 50% of a participant's elective deferrals between 3% and 5% of eligible compensation.

Contributions

Each year, participants may authorize payroll deductions up to 100% of pre-tax compensation, as defined by the Plan, up to the IRS limitation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan has a safe harbor provision whereby the Company commits to match 100% of the participants elective deferrals that do not exceed 3% of eligible compensation, and 50% of a participant's elective deferrals between 3% and 5% of eligible compensation.

The Company may elect to make additional discretionary matching and profit-sharing contributions as a percentage of eligible compensation. For 2024, the Company did not elect to make discretionary matching or profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of (a) Plan earnings and (b) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

December 31, 2024 and 2023

Plan Description (continued)

Vesting

Participants are vested immediately in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing and discretionary matching contributions portions of their accounts plus actual earnings thereon is based on years of continuous service and is subject to the following vesting percentage provisions:

Investment Options

A participant may direct contributions in any of the investment funds offered by the Plan. Participants may change their investment options at any time.

Forfeited Accounts

If a participant terminates or is terminated from employment before becoming fully vested in their account balance, the non-vested portion of the participant's account is forfeited.

Participant Notes Receivable

Effective February 1, 2023, the Plan was amended to permit participant notes receivables. Participants are permitted to borrow a minimum of \$1,000. Only one note may be outstanding at a time. The interest rate is 1% over prime rate.

Payment of Benefits

Participants become eligible for the vested portion of their account balance upon retirement, death, permanent or total disability, or termination from the Company. A participant may elect to receive a lump sum payment in the amount of the vested interest in the participant's account. Participants may also take a lump sum in-service contribution after reaching age 59½.

Summary of Significant Accounting Principles

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Fair Value Measurements footnote for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participants Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Forfeitures

Accounts forfeited by participants who terminate service prior to becoming fully vested are used to reduce the Company's matching contribution or are reallocated to participants based upon their account balances. Any remaining amounts may be used to pay administrative expenses of the Plan. During 2024, participants forfeited approximately \$47,000 of unvested Company contributions. There were approximately \$11,000 and \$38,000 in unallocated forfeitures as of December 31, 2024 and 2023, respectively. During 2024, the Company used approximately \$72,000 of Plan forfeitures to reduce the Company's safe harbor contribution and pay Plan administrative expenses.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the participant, as provided by the Plan agreement.

Fair Value Measurements

ASC 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective Investment Trust/Stable Value: Valued at the NAV of units of the fund. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidation will be carried out in an orderly manner.

Pooled Separate Accounts: Valued at fair value based on the underlying investments reported to the Plan by Principal Life Insurance Company.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information included in the financial statements and ERISA-required supplemental schedule.

Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$13,916 of administrative fees to the Recordkeeper and Custodian for the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Tax Status

The Company adopted a prototype non-standardized profit-sharing plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

Notes to Financial Statements

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan. In the event of termination or partial termination of the Plan, all amounts credited to a participants' account, including Company contributions, become fully vested.

Voluntary Compliance Program

The Plan experienced operational failures in 2024 and 2023. The Company did not calculate the employee contribution or employer matching contribution on certain eligible wages. Corrective contributions to participant accounts, including lost earnings, have been identified and quantified by the Company. The Company intends to make a voluntary submission to the IRS under the Employee Plans Compliance Resolution System (EPCRS) outlining the foregoing operational issues and proposed resolution and corrective actions. An estimate of approximately \$108,000 and \$16,000 as of December 31, 2024 and 2023, respectively, is recorded as a corrective contribution receivable. The estimate reflects a calculation from the DOL's Voluntary Fiduciary Correction Program (VFCP) online calculator. These amounts will be remitted by the Company and credit to participant accounts as soon as administratively possible, and upon approval of the IRS. Any differences in the estimated and final correction methods, as agreed upon with the IRS, will be reflected in future years. All corrective action, as required by the IRS, will be taken by the Company. No provision for income taxes has been included in the Plan's financial statements related to the foregoing matters because the Company believes that the Plan continues to be qualified, and the tax status of the related trust continues to be exempt.

Subsequent Events

The Plan evaluated subsequent events through October 15, 2025, the date the financial statements were issued.
