Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nanostone Water, Inc. & Solecta, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Nanostone Water, Inc. & Solecta, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 2014, as restated January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective April 1, 2024, the Plan executed an adoption agreement to reflect a change in the ownership structure of Nanostone Water, Inc. & Solecta, Inc. (the Plan Sponsors or the Companies), specifically an increased ownership interest by Solecta, Inc. Accordingly, the Plan's name was updated from Nanostone Water, Inc. 401(k) Plan to Nanostone Water, Inc. & Solecta, Inc. 401(k) Plan. On the same date, the Plan transitioned its trustee and custodian from Voya to Fidelity Management Trust Company (Fidelity). As part of this transition, Plan assets totalling \$7,629,109 were successfully transferred from Voya to Fidelity on April 2, 2024. These changes were administrative in nature and did not affect the rights or benefits of Plan participants. Management continues to monitor the Plan's structure and service providers to ensure alignment with fiduciary responsibilities and regulatory requirements.

Participant Eligibility

All employees of the Companies, excluding certain members of collective bargaining agreements, nonresident aliens, and employees acquired in an Internal Revenue Service (IRS) Code section 410(b)(6)(C) transaction, as defined, become eligible for participation on the date of hire and for those who are age 18 or older.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for safe harbor matching contributions, through which the Companies match 100% of the first 4% of eligible compensation that a participant contributes to the Plan. For the year ended December 31, 2024, safe harbor contributions amounted to \$355,085. Safe harbor contributions for the year ended December 31, 2023, amounted to \$449,601, which is net of forfeitures of \$602.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Contributions (Continued)

Additional discretionary nonelective contributions may be made by the Companies at the option of their Board of Directors. Participants become eligible for these contributions after completing 1,000 hours of service during the Plan year. Participants must be employed by the Companies on December 31 to receive them. For the years ended December 31, 2024 and 2023, there were no discretionary nonelective contributions to the Plan. All contributions are subject to applicable IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Companies' matching contributions, allocations of the Companies' discretionary nonelective contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and in the Companies' safe harbor matching contributions, including any actual earnings thereon. Vesting in the discretionary nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the Companies' nonelective contribution and related earnings after completing two (2) years of credited service. Participants are also 100% vested upon death, permanent disability, or attainment of normal retirement age, as defined.

Notes Receivable from Participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

The vested benefits are paid to the participants or their beneficiaries upon the participants' retirement, death, disability, or termination of employment with the Companies. In the event of the above, the participants or their beneficiaries will receive a lump sum distribution if the account balance, excluding rollover balances, has a value of less than or equal to \$1,000. Terminated participants' vested account balances, excluding rollover balances, of greater than \$1,000 and up to \$5,000 may be automatically distributed to an Individual Retirement Account (IRA). Participants whose account balances, excluding rollover balances, exceed \$5,000 may elect to receive a lump sum distribution or may leave their vested balance in the Plan.

Hardship withdrawals are permitted by the Plan as defined in the IRC. Participants may also withdraw their vested account balance upon attaining age 59 ½.

Forfeited Accounts

Forfeitures may be used to reduce future employer contributions or to pay Plan administrative expenses. The changes in the Plan's forfeitures account balance for the years ended December 31, 2024 and 2023 are as follows:

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance companies, as applicable. See Note 3 for the discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation (Depreciation) in Fair Value of Investments

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits and is presented as part of investment income (loss).

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the note receivable balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

NOTE 3 FAIR VALUE MEASUREMENT

The Plan has adopted Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. This framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 3 FAIR VALUE MEASUREMENT (CONTINUED)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Money market fund – The fair value of this investment is determined using observable inputs other than quoted prices in active markets, including quoted prices for similar assets and market-corroborated inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the year, the Plan Sponsors reviewed the classification of the Plan's investments and reclassified the investments between mutual funds and money market fund within the Level 2 fair value hierarchy. The prior year's presentation has been adjusted to conform to the current year's classification, where applicable. This reclassification had no impact on the total investment balances or the net assets available for benefits as of December 31, 2024 and 2023.

NOTE 4 CONCENTRATIONS

As of December 31, 2024 and 2023, the Plan had investments of \$3,609,267 and \$3,565,243, respectively, that were concentrated in four funds, namely T. Rowe Price Large-Cap Growth Fund I Class, BlackRock Life Path Index 2040 Fund Class K, BlackRock Life Path Index 2045 Fund Class K, and BlackRock Life Path Index 2035 Fund Class K.

NOTE 5 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by Fidelity, the Plan's current custodian. Prior to the transition to Fidelity, the Plan's custodian was Voya. Both entities, as service providers to the Plan, are considered parties-in-interest as defined by ERISA. For the years ended December 31, 2024 and 2023, the Plan incurred fees of \$48,006 and \$45,323, respectively, for investment management services. These fees were paid directly from Plan assets. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers of the Companies. These individuals may be considered parties-in-interest due to their roles in Plan administration. No direct compensation was paid by the Plan for these services. All party-in-interest transactions were conducted in accordance with the Plan provisions and applicable ERISA regulations.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.

NOTE 7 PLAN TAX STATUS

On April 1, 2024, the Plan transitioned from the pre-approved plan offered by CCH Incorporated, DBA ftwilliam.com to the Fidelity Basic Plan Document No. 17. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC.

NOTE 7 PLAN TAX STATUS (CONTINUED)

The Plan Administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are normally exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 9 FINANCIAL INFORMATION CERTIFIED BY CUSTODIANS

The Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, were obtained by management and agreed to or derived from information certified by Voya, the custodian of the Plan through March 31, 2024, and Fidelity, the custodian of the Plan beginning April 1, 2024. The Plan Administrator has obtained certifications from the custodians that information provided to the Plan Administrator by the custodians related to the Plan's assets is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following:

- Investments and notes receivable from participants, as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment activity, as reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023;
- Investment information disclosed in Note 3 to the Plan's financial statements; and,

NOTE 10 NONEXEMPT TRANSACTIONS

The Plan Sponsors inadvertently failed to deposit participant contributions within the required time frame as stated by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. For the year ended December 31, 2021, participant contributions amounting to \$1,268 were not deposited timely and, as of the date these financial statements were available to be issued, remain unremitted and uncorrected.

Additionally, during the months of March and April 2024, contributions totaling \$97,241 were deposited after the required time frame due to administrative delays associated with the transition of custodial services from Voya to Fidelity. As of the date of these financial statements, the lost earnings associated with the late contributions for both 2021 and 2024 have not yet been calculated or paid. The Plan Sponsors have acknowledged these delays and intend to deposit the applicable lost earnings to the Plan once determined, in accordance with DOL guidance.

NOTE 12 NEW LAWS AND REGULATIONS

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE 2.0) became law. The new law makes changes to include provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE 2.0 changed the retirement plan rules for long-term, part-time employees. The 401(k) plan requirement to allow employees to contribute elective deferral was expanded to 403(b) plans.

For plan years beginning in 2024, if an employee has three consecutive 12-month periods with more than 500 hours of service in each, the employee must be eligible to enter the plan, and the period of service was reduced from three to two consecutive 12-month periods, for plan years beginning after December 31, 2024.

The IRS issued proposed regulations in February 2023 addressing the use and timing of forfeitures in qualified retirement plans. These regulations apply to plan years beginning on or after January 1, 2024. The regulation states that forfeitures must be used no later than 12 months after the end of the plan year in which the forfeitures were incurred. However, the transition rule also provides that any forfeitures that were incurred in any plan year beginning before 2024 are treated as having been incurred in the first plan year that begins on or after January 1, 2024, and, thus, must be used no later than December 31, 2025, for a calendar year plan. The Plan will ensure that all forfeitures from years prior to 2024 are used by December 31, 2025, to comply with this requirement.

For plan years beginning in 2026, catch-up contributions for participants age 50 or older earning more than \$145,000 annually will be required to be made on a Roth (after-tax) basis. Management is monitoring regulatory guidance and evaluating administrative updates required to comply with this provision.

The Plan will implement the above legislative changes and intends to formally execute the required plan amendments reflecting their implementation by the deadline of December 31, 2026.

NOTE 13 SUBSEQUENT EVENTS

Plan management has evaluated events subsequent to December 31, 2024 to assess the need for potential recognition and/or disclosure in the financial statements. Such events were evaluated through October 15, 2025, the date the financial statements were available to be issued. Based upon this evaluation, it was determined that no subsequent events occurred that require recognition or additional disclosure in the financial statements other than the matters described below.

On July 1, 2025, the Plan Sponsors merged to form a new entity, Acuriant Technologies, Inc. As a result of this corporate merger, the Plan name was changed to Acuriant Technologies, Inc. and Solecta, Inc. 401(K) Plan effective September 15, 2025. As of the date these financial statements were available to be issued, no changes have been made to the Plan's terms, operations, or sponsorship other than the name change. The Plan continues to operate under its existing provisions, and all participant rights and obligations remain unchanged.

Management is actively monitoring the transition and will evaluate any potential future impact to the Plan, including changes to plan governance, administrative processes or fiduciary responsibilities, as integration efforts progress.
