## INDEPENDENT AUDITOR'S REPORT

To the Management of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Countryside Rentals, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Countryside Rentals, Inc. (“the Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who are age 21 or older and have completed 500 hours of service within their first six months or once they completed one year of service, defined as 1,000 hours. Participants are eligible to receive employer contributions after completing a year of service. The Plan requirements are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum percentage allowable not to exceed the limits of Code Sections 401(k), 402(g), 404 and 415 of pretax annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching and profit-sharing contributions to the Plan. In 2024 and 2023, the Company made a matching contribution equal to 100% of the first 5% of eligible compensation that a participant contributed to the Plan. In addition, each year the Company makes a profit-sharing contribution based on employee classification, as determined by the Company. In 2024 and 2023, the profit-sharing contribution classes received 1.67%, 3.00% or 5.00% of participant eligible compensation. Participants direct the investment of their contributions and Company contributions into one or more investments offered by the Plan.

**NOTE 1 – DESCRIPTION OF THE PLAN (CONT'D)**

Participant Accounts

Each participant's account is credited with its proportionate share of employee elective deferrals, the plan sponsor's matching contributions, the plan sponsor's profit-sharing contributions and the Plan's earnings. Forfeitures of non-vested matching contributions are used first to reduce the Plan sponsor's future matching contributions and then profit-sharing contributions. Allocations of discretionary contributions and Plan earnings are based on participants' compensation or account balances, as provided by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

Vesting

Participants are immediately vested in their contributions plus the actual earnings thereon. Vesting in the Company's matching and Profit-Sharing contribution portion of their accounts plus actual earnings thereon is based upon years of service. Participants are 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum specified by the plan administrator up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and bear an interest rate of Prime plus 1%. The notes receivables are secured by the balance in the participant's account. Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Principal and interest is paid ratably through payroll deductions. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into the following investment options:

A "pooled separate account" with Lincoln National Life Insurance Company, which includes a selection of various mutual funds.

A guaranteed fund, which is a guaranteed investment contract offered by Lincoln Life Insurance Company.

Investment Options (Cont'd)

Participants may change their investment choices an unlimited number of times within the separate account. However, certain restrictions apply to the exchange or transfer of amounts in the guaranteed fund.

Payment of Benefits

On termination due to retirement, death or disability, the participant may elect to receive a lump sum payment or elect to receive periodic payments. The lump sum payment would be equal to the full value of their own contributions plus earnings thereon and the vested portion of the Company's matching contributions and earnings thereon. In addition, the Plan includes a provision for employees to make withdrawals from their account under certain "hardship" circumstances. For termination of service due to other reasons, a participant may receive the value of their vested interest as a lump sum distribution.

Excess Contributions

At December 31, 2024 and 2023, amounts payable to participants totaling \$24,061 and \$0, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability and are reported as corrective distributions. The Plan distributed the 2024 excess contributions to the applicable participants on April 28, 2025.

Forfeited Accounts

The Plan includes provisions to allow the forfeited balances to be allocated as follows:

- Restoration of participant's forfeitures
- Used to reduce employer contributions
- Used to offset plan administrative expenses

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$19,273 and \$27,170, respectively. During 2024 and 2023, a total of \$9,243 and \$13,332, in forfeitures were used to reduce the employer matching contribution and profit-sharing contribution, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

New Accounting Pronouncements

While FASB regularly issues new Accounting Standards Updates (ASUs), the Plan did not apply any new ASUs in 2024.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants totaling \$24,061 and \$0 for contributions in excess of amounts allowed by the IRS are recorded as a liability with the corresponding reduction in 2024 and 2023 contributions, respectively. The Plan distributed the 2024 excess contributions prior to April 28, 2025.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

The company absorbs significant costs of plan administration related to legal. Fees related to the administration of notes receivable are included in administrative fees.

Date of Management Review

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONT'D)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Pooled Separate Accounts:** The fair value of mutual funds in pooled separate accounts is determined by each fund's custodian based on the fair value of the underlying securities within the fund, which represent the net asset value of shares held by the plan at year end. The investment in the fund is carried at fair value based on the closing price of the National Association of Securities Dealers Automated Quotations (NASDAQ). Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

Based on the above definition, all plan assets have been classified as Level 2 at December 31, 2024 and 2023. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The plan's policy is to recognize transfers between levels as of the end of reporting period. There were no significant transfers between levels during 2024 and 2023.

**NOTE 4 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2006, the Plan entered into a group annuity contract which included guaranteed and separate accounts with Lincoln National Life Insurance Company ("Lincoln"). The group annuity contract offers a guaranteed fund investment option without a guaranteed minimum interest rate. Lincoln maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$54,207 and \$42,941, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, however there is no minimum interest rate requirement. The average yield based upon earnings and interest rate credited to participants for the guaranteed contract was 2.77% and 2.54% for 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Examples of such events include (1) If the contract owner breaches the contract in some way (failure to pay any charges billed to the contract owner, failure to furnish requested information or other documentation, discovery by the insurance company that the contract owner has misrepresented any material information.) (2) If the plan ceases to meet the requirements of the appropriate Code sections (3), if, after a reasonable amount of time, the account has not grown sufficiently. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Lincoln National Life Insurance Company. Lincoln National Life Insurance Company is the trustee as defined by the Plan. Fees paid by the Plan for the investment and loan management services amounted to \$10,770 for the year ended December 31, 2024.

TAP Consulting is the investment advisor to the Plan. Fees paid by the Plan for investment advisory services amounted to \$42,801 for the year ended December 31, 2024.

Burke and Schindler is the Third Party Administrator for the Plan and provides administrative services for the Plan. Fees paid by the Plan for these administrative services amounted to \$16,391 for the year ended December 31, 2024.

These transactions qualify as party-in-interest transactions. Munninghoff, Lange & Co. is the independent auditor for the Plan.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 7 – PLAN AMENDMENTS**

The Plan was restated effective January 1, 2022. There were no amendments to the Plan in 2024.

**NOTE 8 – TAX STATUS**

Effective January 1, 2013, the Plan adopted a volume submitter profit sharing plan with a cash-or-deferred arrangement, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving that opinion letter. However, the Company believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 8 – TAX STATUS (CONT'D)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) for any uncertain position that more likely would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

There are no reconciliation items between the statements and the 5500.

**NOTE 12 – CORRECTIVE CONTRIBUTIONS**

The general rule as interpreted by the Department of Labor and the courts has been that if the employer was able to segregate other payroll-related items from general assets, so too must 401(k) participant contributions be segregated within seven business days. In 2023, the Plan sponsor remitted \$90,851 in delinquent employee deferrals and missed earnings on those amounts.
