We have performed audits of the financial statements of Borland-Groover Clinic, P.A. Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan:

The following description of Borland-Groover Clinic, P.A. Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, established on August 14, 1970, and restated January 1, 2022, is a defined contribution plan covering all employees of Borland-Groover Clinic, P.A., BGC Holdings, Inc., and Jax Anesthesia Providers, LLC, collectively referred to as the “Company” throughout these financial statements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees who have completed 3 months of service with 250 hours and who are age 18 or older are eligible to participate in the Plan, except members of the collective bargaining agreement, residents of Puerto Rico, employees acquired in merger or acquisition, or independent contractors. The Plan has an automatic enrollment provision that provides for a 3% salary deferral followed by an annual 1% increase up to a maximum of 10%, whereby employees must elect out of the Plan if they do not wish to participate. Eligible participants can enter the Plan immediately upon meeting the eligibility requirements.

Employees who are age 18 and have completed one year of service, with 1,000 hours for a year of crediting service, are eligible for the annual nonelective profit-sharing contribution.

Contributions

Each year participants may elect to contribute up to the maximum of their pretax annual compensation as determined by the Internal Revenue Service (“IRS”) and as defined by the Plan. In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company has elected to make discretionary profit-sharing contributions to the Plan. These contributions are allocated based on segmented groups of participants, as well as a discretionary matching contribution to be determined annually by the Company. The Company contributed \$7,716,447 as a discretionary profit-sharing contribution for the year ended December 31, 2024.

Investment Options

The Plan permits every participant to direct their investments under the Plan. The Plan offers mutual funds and common collective trusts as the primary investment options. The Plan allows participants to invest in the Charles Schwab Self-Directed Brokerage Account, which enables each participant to self-direct his or her money into a full range of investment options, including individual stocks and bonds, as well as allowing access to additional mutual funds.

1. Description of Plan (Continued):

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Company contributions, and Plan earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant's account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant's account.

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. Vesting in the Company's nonelective profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service with 1,000 hours for a year of crediting service. All employer contributions become fully vested in the event of death, disability, or reaching the normal retirement age while under the Company's employment.

Participant vesting in nonelective profit-sharing contribution is as follows:

Benefits Paid to Participants

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account in accordance with Plan provisions. In-service withdrawals are allowed for participants who attain the age of 59 ½. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

Administrative Expenses

Administrative expenses of the Plan may be paid by the Company or Plan. Unless paid by the Company, administrative expenses are allocated to (1) participant accounts proportionally based on the value of the account balances, (2) as an equal dollar amount based on the number of participants of the Plan, or (3) charged to the related participant's account, based on the nature of the expense.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

1. Description of Plan (Continued):

Forfeited Accounts

Forfeitures of non-vested participant balances are generally used to reduce future employer contributions and pay Plan expenses. At December 31, 2024, and 2023, forfeited non-vested accounts totaled \$35,975 and \$84,014. During 2024, there were \$166,479 in forfeitures used to reduce employer contributions.

2. Summary of Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 3 for a discussion of fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported using the average cost method.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in a combination of investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Reclassifications

Balances in cash as of December 31, 2023 have been reclassified to conform with current year presentation.

3. Fair Value Measurements:

Financial Accounting Standards Board, Statement of Accounting Standards Codification Topic 820 (“ASC 820”), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts: Self-directed brokerage accounts are comprised of interest-bearing cash, common stock, mutual funds, and unit investment trusts, all of which are valued at the closing price reported in the active market in which the securities are traded.

Common/collective trust fund: Valued at the NAV of units of the common/collective trust. The NAV, as provided by the trustee of the common/collective trust fund, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. Parties-in-Interest Transactions:

Certain Plan investments are in holdings managed by T. Rowe Price (“T. Rowe”), the trustee of the Plan and recordkeeper. Accordingly, transactions with T. Rowe qualify as party-in transactions permitted under provisions of ERISA. Fees paid to T. Rowe by the Plan for administrative expenses amounted to \$83,078 for the year ended December 31, 2024.

Ando Consulting, LLC and Mariner Institutional, LLC provide investment management and advisory services to the Plan. Accordingly, transactions with these companies qualify as party-in-interest transactions. During 2024, the Plan paid \$13,750 to each service provider for investment management and advisory services.

Deloitte Tax LLP provides compliance and tax advisory services to the Plan. Accordingly, transactions with these companies qualify as party-in-interest transactions. During 2024, the Plan paid \$15,100 for compliance and tax advisory services.

6. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

7. Tax Status:

The Plan obtained a determination letter on August 19, 2020, in which the IRS stated that the Plan was designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe the Plan is currently being operated in compliance with the applicable requirements of the IRS.

Management has evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require recognition of liability (or asset) in the accompanying financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state, or local tax authorities for years before 2021.

8. Subsequent Events:

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be filed, and has determined there were no material events requiring recognition or disclosure.
