**Note 1 - Plan Description**

The following brief description of the Vopak North America Inc. Incentive Savings Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering eligible employees of Vopak North America Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was formed by the Company on February 1, 1986 and has been amended and restated from time-to-time.

**Plan Administration**

An internally appointed administrative committee consisting of Company employees serves as the plan administrator and is responsible for overseeing the day-to-day operations of the Plan. Empower Annuity Insurance Company (EAIC) serves as the asset custodian of the Plan's pooled separate accounts and guaranteed interest account. Empower Trust Company, LLC (ETC) serves as the trustee and asset custodian for its mutual funds and notes receivable from participants.

**Eligibility**

Participation in the Plan is available for all employees (other than leased employees, union employees or nonresident aliens) immediately following their date of hire.

**Contributions**

The Plan allows participants to contribute 1% to 60% of their compensation on a pre-tax or Roth basis. All eligible employees who do not make an affirmative deferral election (including an election to defer 0% of compensation) within 45 days of being hired shall be deemed to have elected to defer 6% of their compensation on a pre-tax basis, which is increased by 1% annually until a deferral rate of 15% is reached. The Company provides matching contributions to the Plan equal to 75% of participant contributions, up to a 6% deferral. Participants aged 50 and older are permitted to make elective catch-up deferrals in accordance with Section 414(v) of the Internal Revenue Code (IRC). Contributions are subject to IRC limitations. Participants may also make rollover contributions from other qualified plans and certain other qualified sources as defined in the plan document.

**Participant Accounts**

Upon enrollment in the Plan, a participant may direct the investment of his or her account balance. The investment options available include mutual funds, pooled separate accounts, and a guaranteed interest account. Participants may change their investment options at any time. Investment income or loss is allocated daily to participants based on their respective balances in the funds.

**Vesting and Forfeitures**

Participants are immediately vested in their contributions plus actual earnings thereon. The Plan provides for 25% vesting in employer contributions after two years of employment and an additional 25% vesting annually until the participant is 100% vested. Participants are fully vested upon attainment of normal retirement age, currently age 65, death or permanent and total disability.

The employer contributions forfeited by non-vested participants are applied to reduce employer contributions or to pay for plan expenses. At December 31, 2024 and 2023, the forfeiture balance was \$30,009 and \$25,374, respectively. During 2024, \$152,735 of forfeitures were used to reduce employer matching contributions and \$9,866 of forfeitures were used to pay for plan expenses.

If a participant is rehired before incurring five consecutive one-year breaks in service, any amounts forfeited will be reinstated if the rehired participant repays to the Plan the amounts previously distributed upon his/her prior termination.

**Notes Receivable from Participants**

Notes receivable from participants are loans to participants, secured by the vested portion of their accounts. Participants of the Plan are eligible to obtain loans of up to \$50,000 less the participant's highest outstanding loan balance during the preceding 12 months, or 50% of their vested account balance, whichever is less. The minimum loan amount is \$1,000. Loans are generally obtained for a period from one to five years unless for the purpose of acquiring a primary residence, in which case the loan term may be up to 30 years. Loans bear interest at the prime rate plus 2% at the time the loans are issued. Principal and interest repayments are made by payroll deductions or direct payment by the participant.

**Benefit Payments**

Upon termination of service, death or disability, a participant's vested balance may be received by the participant as a lump-sum payment or annuity or transferred directly to an Individual Retirement Account (IRA) or another qualified employer-sponsored plan. Participants with a vested account balance of \$1,000 or less receive an automatic lump-sum distribution from the Plan. Participants who terminate with an account balance of more than \$1,000 but less than \$7,000 receive their distribution in a direct rollover to an IRA designated by the plan administrator, unless another form of distribution is elected by the participant. If a participant's vested balance is \$7,000 or greater, the participant may elect to leave his/her vested balance in the Plan and defer distribution until a future date.

Plan participants may withdraw the value of their account while still employed upon the attainment of age 59½, for reasons of financial hardship, and for other such reasons as defined in the plan document.

Upon withdrawal from the Plan or termination of employment, participants may be subject to income tax on contributions and income earned.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested in their accounts and all balances will be distributed.

**Note 2 - Summary of Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Valuation of Investments and Income Recognition**

Investments of the Plan, except for the fully benefit-responsive guaranteed interest account which is reported at contract value, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains and losses on investments sold during the year as well as unrealized appreciation or depreciation of the investments held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, as the notes are collateralized by the participants' account balances. In general, notes receivable from participants are considered to be in default in the calendar quarter following the quarter in which no payment is made. Delinquent loans are treated as benefits paid to participants or beneficiaries based upon the terms of the plan document when a distributable event has occurred. Interest income on notes receivable from participants is recorded on the accrual basis.

**Benefit Payments**

Benefits paid to participants or beneficiaries are recorded when paid.

**Administrative Expenses**

Unless paid by the Company, at its discretion, administrative expenses are paid by the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for investment in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and may impact participants' account balances and amounts reported in the financial statements.

**Subsequent Events**

The administrative committee evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Information Certified by the Plan's Asset Custodians**

The administrative committee has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the administrative committee has obtained certifications from EAIC and ETC as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and accompanying notes to financial statements as to investments, notes receivable from participants, investment income, interest income on notes receivable from participants, and all information in the supplemental schedule of assets (held at end of year) is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information certified by the asset custodians to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule of assets (held at end of year), as applicable.

**Note 4 - Fair Value Measurements**

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* These funds are valued daily, based upon quoted market prices.

*Pooled Separate Accounts:* These investments are valued at their net asset value (NAV) as reported by the issuer based on quoted prices of the underlying investments, when available, net of certain expenses. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

**Note 5 - Guaranteed Interest Account with Insurance Company**

The Plan has a fully benefit-responsive evergreen group annuity contract with EAIC, through its investment in the Guaranteed Income Fund. EAIC maintains the contributions in a general account, which is considered a general account evergreen group annuity product with a guarantee backed by the full faith and credit of EAIC. EAIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, the Guaranteed Income Fund is a fully benefit-responsive guaranteed interest account that is reported at contract value. Contract value represents deposits made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise as of December 31, 2024 or 2023. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.5%. The interest rate is reviewed on a semi-annual basis for resetting.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. In addition, there are no events that allow EAIC to settle at an amount different from contract value.

**Note 6 - Tax Status**

The pre-approved plan document adopted by the Plan received an opinion letter from the Internal Revenue Service (IRS) dated December 4, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan document has been amended since receiving its IRS letter; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no open audits for any tax periods in progress.

**Note 7 - Party-in-Interest Transactions**

The Plan engages in investment transactions with funds issued by EAIC, which qualify as parties-in-interest with respect to the Plan. These transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

**Note 8 - Nonexempt Party-In-Interest Transactions**

As reported in the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, there were unintentional delays in remitting \$796,595 of participant contributions and \$136,894 of participant loan repayments to the Plan within the timeframe specified by the DOL's Regulation 29 CFR 2510.3-102. The untimely remittances relate to the 2021 through 2024 plan years. The Plan Administrator remitted the late participant contributions and loan repayments to the Plan during the applicable periods from 2021 through 2024 and is in the process of calculating lost earnings.
