Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Wood, Smith, Henning & Berman, LLP Attorneys & Staff 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Wood, Smith, Henning & Berman, LLP Attorneys & Staff 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Wood, Smith, Henning & Berman, LLP (the "Partnership" or "Employer"), was established on January 1, 2004, and restated effective January 1, 2021. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and provide benefits in the event of disability, death, termination of employment, or financial hardship. The Plan covers all employees of the Employer who meet certain eligibility requirements. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026 to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Partnership is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Partnership has delegated certain responsibilities for the operation and administration of the Plan. John Hancock Life Insurance Company (the "Custodian") is responsible for the custody of the assets of the Plan and executing transactions related to the Plan's investments. John Hancock Retirement Services is the Plan's recordkeeper and is responsible for maintaining participants' accounts and executing participant-initiated transactions. Ascensus is the Third Party Administrator ("TPA") for the Plan and provides certain participant level services as described in the TPA agreement.

Eligibility

Employees of the Partnership must be at least 21 years of age and must complete a minimum of 500 hours during the first six months of service to be eligible for Plan participation. If 500 hours of service is not attained during the first six months of service, employees will satisfy the minimum service requirement upon completion of a year of service. Employees may enter the Plan on January 1 or July 1 following the date that Plan eligibility requirements are met. Employees will be eligible for any Employer contributions by being employed at the end of the Plan year and completing 1,000 hours of service during the year.

Eligibility (continued)

Excluded persons are Equity Partners, Accounting Administrator, Accounting Clerk, Administrative Clerk, AP Clerk, Billing Clerk, Chief Financial Officer, Chief Information Officer, Chief Operating Officer, Financial Controller, Firm Administrator, Human Resources Coordinator, Office Administrator, Office Services Clerk, Operations Controller, Payroll Manager, Receptionist, Assistant Human Resources Coordinator, Payroll Coordinator, union employees, certain nonresident aliens who have earned no income from sources within the United States, residents of Puerto Rico, and leased employees.

Participant accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Employer's contributions, if any and Plan earnings, and charged with Plan losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Contributions

Participants are allowed to contribute up to 40% of their eligible pre-tax or after-tax (as Roth contributions) compensation, as defined in the plan documents, up to the annual contribution limit as defined in the IRC, which was \$23,000 for 2024.

Plan participants who have attained age 50 or older before the end of a calendar year are allowed to make additional contributions called "catch-up contributions" to the Plan, up to the annual contribution limit as defined in the IRC, which was \$7,500 for 2024.

The Partnership may provide discretionary Employer contributions, as determined each year by the Partnership, to the accounts of participants. For the Plan year ended December 31, 2024, the Partnership did not make any discretionary Employer contributions.

Vesting

Participants are immediately vested in their contributions to the Plan, plus actual earnings thereon. Participants vest ratably in Employer contributions, plus actual earnings thereon, and become 100% vested after six years. Participants become fully vested in Employer contributions upon attainment of retirement age, full and permanent disability, or death.

Forfeitures

Forfeitures may occur as a result of excess Employer contributions or forfeited nonvested Employer contributions. Forfeitures are retained in the Plan and may be allocated to participants as additional Employer contributions, used to reduce Employer contributions, or used to offset Plan expenses. No forfeitures were used to offset Plan expenses for the year ended December 31, 2024. Unallocated forfeitures are held in a cash account and totaled \$3,897 and \$3,897 respectively, as of December 31, 2024 and 2023.

Notes receivable from participants

The Plan allows participants to borrow not less than \$1,000 and up to a maximum equal to the lesser of 50% of their account balance or \$50,000. Notes receivable from participants (or "participant loans") must be repaid within five years, unless the participant's loan is used to acquire a primary residence, in which case the repayment term may exceed five years. Participant loans bear interest at a rate commensurate with local prevailing rates for instruments with similar characteristics at the time of issuance. Principal and interest are generally paid ratably through payroll deductions with payments made each pay period. Outstanding participant loans at December 31, 2024, bear interest at annual rates of between 5.25% and 10.50% and mature at various dates through October 2039.

Payment of benefits

Distributions and withdrawals are payable to participants upon retirement, termination of employment, attainment of age 59 ½, financial hardship, disability, or death. If a participant's vested account balance is equal to or less than \$1,000, the balance is immediately distributed as a lump-sum payment. Upon termination, if a participant's vested account balance is greater than \$1,000 and less than or equal to \$7,000, their balance shall be automatically rolled over into an individual retirement account designated by the Plan administrator, unless otherwise elected. If the account balance is greater than \$7,000 upon termination, the participant can consent to either a distribution paid in the form of a lump sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan documents.

Upon attaining the age of 59 ½, the participant may, while still employed by the Partnership, request a withdrawal from their account balance. Hardship distributions are permitted under limited circumstances as described in the plan documents.

Administrative expenses

Administrative expenses are generally paid by the Partnership, but may, at the discretion of the plan administrator, be paid by the Plan. Transaction fees for certain participant-initiated activity are charged to the specific account of the participant initiating any such transaction. The Plan is not required to reimburse the Partnership for expenses paid on its behalf.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit and changes therein.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on sale on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses have been recorded as of December 31, 2024. Delinquent participant loans are recorded as deemed distributions based upon the terms of the plan document.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Partnership, which is the pay date. Contributions from the Partnership, if any, are recorded in the year they are earned and to coincide with the year in which the Partnership records the contribution in its general ledger. The Plan records receivables for contributions based upon the contributions recorded in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the rollover contribution are received by the Custodian.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan has evaluated events through October 15, 2025, the date the financial statements were available for issuance. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Custodian, determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, and interest income on notes receivables from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024, ("supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the Plan's financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access at the measurement date.

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - inputs are unobservable inputs for the asset or liability and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts ("PSA"): Valued using the net asset value ("NAV") per share as a practical expedient to fair value as provided by the managers of the fund. Pooled separate accounts offered are proprietary to the Custodian and many invest exclusively in one underlying mutual fund traded on an established market. As such, the separate accounts begin with a price determined by the Custodian and the number of units issued are calculated to match the current fair market value of the underlying mutual fund holdings (shares x price). This is known as unitizing the underlying assets. However, the rate of return of each will be consistent, taking into account any Plan or participant expenses.

The pooled separate accounts allow for participants to invest in the following: various large-, medium-, and small-cap index funds, both foreign and domestic oriented, strategized to approximate the aggregate returns posted to the respective stock indices; target-date mutual funds which adjust their investment mix to better preserve a greater proportion of contributed capital as the respective investment approaches the respective target retirement date; mutual funds which specialize in the investment in growth-oriented foreign and domestic stocks; and mutual funds which invest in bonds backed by corporate bond holdings.

4. FAIR VALUE MEASUREMENTS (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Investments valued using NAV as a practical expedient to fair value are not disclosed within the fair value hierarchy.

As of December 31, 2024 and 2023, investments measured at NAV were \$39,784,288 and \$32,441,345, respectively. These assets had no unfunded commitments, no redemption notice period, and a daily redemption frequency.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items.

Certain fees and expenses of the Plan relating to legal, accounting, and other administrative services are paid by the Partnership.

The Custodian receives and retains earnings on funds received or credited to the Plan's account before they are invested, allocated, or applied in accordance with the Plan's instruction or on funds withdrawn, collected, or deducted from the Plan's account before actual disbursements are made to recipients. The Plan's TPA is compensated indirectly by the Custodian through a revenue sharing agreement that provides for estimated administrative fees of 0.60% of the Plan's assets annually. When actual administrative fees are less than what was paid, the overpayment is refunded to the participants and reflected as other income on the statement of changes in net assets available for benefits.

Certain Plan investments are managed by affiliates of the Custodian. Transactions in these funds are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from prohibition of party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. TAX STATUS

The Plan has adopted the Ascensus LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan. The Internal Revenue Service informed Ascensus LLC by a letter dated June 30, 2020, that its plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of its employees. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
