Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BiOrigin Specialty Products Union 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of the BiOrigin Specialty Products Union 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established effective December 30, 2014, and is a defined contribution plan covering all eligible union employees (as defined in the plan document) of Dunn Paper, Inc. and adopting employers Dunn Paper – Natural Dam, Inc., Dunn Paper – Wiggins, LLC, and Menominee Acquisition Corporation (collectively, the Company or Employer). Employees are eligible for participation in the Plan if they are: (1) full-time employees or (2) part-time employees who have completed a year of service. Employees may begin participating in the Plan on the first day of the month following meeting eligibility requirements. Employees are not eligible for participation in the Plan if they are: nonresident aliens, leased employees or temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Change in trustee: Effective January 1, 2024, the trustee of the Plan switched from Principal Trust Company and Principal Life Insurance Company (collectively, "the Former Trustees") to Ascensus LLC (the Current Trustee).

Contributions: Each year, participants may contribute up to 90% of their eligible annual compensation, in a pretax or Roth basis, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their account balances into various investment options offered by the Plan.

The Company may make a discretionary matching contribution in an amount equal to a percentage of a participant's elective deferrals as determined by the Company or Collective Bargaining Agreement. The Company may also make discretionary contributions in an amount to be determined by the Company. Discretionary contributions, if any, will be allocated to participants' accounts in the ratio that eligible compensation bears to the total eligible compensation paid to all eligible participants. For the year ended December 31, 2024, the Company approved a discretionary matching contribution to employees for approximately \$562,000. The Plan also allows for additional contributions in an amount to be determined by the Company.

Vesting: Participants are immediately vested in all participant and rollover accounts plus actual earnings thereon. Participants vest in their respective share of the Company's discretionary contributions based on years of continuous service. A participant becomes 100% vested in discretionary match contributions after five years of credited service, with 20% vesting credited to the participant per year of service, as defined unless otherwise noted in the Collective Bargaining Agreement. A participant becomes 100% vested in discretionary contributions upon completion of three years of service with no vesting prior to the third year. A participant becomes 100% vested in certain prior year contributions made by the Company upon completion of two years of service.

A participant is also 100% vested in Company contributions on or after the date the participant reaches normal retirement age, on the date a participant becomes disabled, or on the date a participant dies.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's discretionary contributions, if any, and (b) plan earnings. Allocations are based on a participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Plan Description (Continued)

Forfeitures: If a participant terminates employment and is less than 100% vested in their Company contributions, the participant will forfeit the nonvested portion of their account. The Company uses forfeited nonvested amounts to pay the Plan expenses or reduce the Company contributions. Remaining forfeitures will be allocated to participants. At December 31, 2024 and 2023, there were forfeited nonvested accounts totaling \$40,885 and \$61,465, respectively. During 2024, \$31,282 of forfeitures were used to pay Plan expenses.

Notes receivable from participants: Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the participant's highest outstanding loan balance in the preceding 12 months or 50% of their vested account balance, subject to the approval of a loan application. Participants may not have more than three loans outstanding at any time. The loans are collateralized by the balance in the participant's account and bear interest at prime rate plus 1% at the time of loan origination. Loans are repaid through payroll deductions within a five-year period, unless the loan was made to acquire a primary residence, in which case the loan can be repaid over a 30-year period.

Payment of benefits: Upon termination of service due to death, disability, retirement or other reason, a participant or beneficiary is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Transfer out: During the year ended December 31, 2024, the Plan transferred \$983,609 of assets to the BiOrigin Specialty Products 401(k) Plan, which is also sponsored by the same employer. This transfer was initiated as a result of changes in employee status, whereby certain participants became eligible for participation in a different plan under the same sponsor. The transfer was made in accordance to plan rules and regulatory requirements and did not affect participant benefits.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting estimates: The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts where contract value is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Note 2. Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan may be paid by the Company and are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by Principal Trust Company ("the Former Trustee") and Ascensus Trust Company ("the Current Trustee")

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by the former and current trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the former and current trustee that information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedules related to the following assets and income.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4. Fair Value Measurements (Continued)

Units of pooled separate accounts: Valued at the total of the NAV of the fair value of securities and cash held by the accounts at year-end as reported by the investment advisor. NAV is determined based on observable inputs of underlying investments from active markets.

Units of common collective trust fund: Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Group Annuity Contract

The Principal Fixed Income Guaranteed Option (the PFIGO) is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant's account balances. This net crediting rate after the deduction of 1.55% for fees for administrative and record-keeping services provided to the Plan. The rate is reset on a semiannual basis.

Benefit payments are made at contract value (i.e., no market value adjustments or surrender charge adjustments) for plan benefit events including retirement, death, disability, termination of employment, loans, withdrawals or Plan termination. An employer level liquidation or employer-initiated transfer of the Plan's interest in the PFIGO will be subject to either a 12-month advance notice or a 5% surrender charge, whichever the Employer chooses. Notification of a Plan's intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan's interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan's interest in the contract. If this scenario occurs, the surrender charge will be billed to the Employer.

The credit risk of the issuer, Principal Life Insurance Company, was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A1 as of July 2024), Standard and Poor's (A+ as of April 2024), A.M. Best Company (A+ as of March 2024), and Fitch (AA- as of June 2024).

Note 6. Related-Party Transactions and Party-in-Interest Transactions

Certain investments of the Plan are managed by the Current Trustee. The Current Trustee is the trustee as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Fees paid by the Plan to service providers were \$79,172 for the year ended December 31, 2024.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain other administrative expenses are paid by the Company. Certain employees of the Company provide administrative and trustees services to the Plan. These employees are not compensated by the Plan for their services.

Note 7. Tax Status

On June 30, 2020, the Internal Revenue Service (IRS) issued an opinion letter to the preapproved plan that indicated the Plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the preapproved plan. The Plan Administrator believes that the Plan, as amended, is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 9. Prohibited Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit \$45,619 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The Plan Sponsor intends to calculate, and deposit the lost earnings to correct this failure in 2025. The Plan Sponsor will file Form 5330 and pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan Sponsor's assets and not from assets of the Plan.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
