The following description of the BHP Minerals USA Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was established, effective April 1, 2022, as a result of a spin-off of employees of the BHP Minerals Service Company from the BHP USA Retirement Savings Plan, a Plan previously sponsored by BHP Holdings (International) Inc. ("BHP"). BHP Minerals Service Company ("BHP Minerals" or "Employer"), the Plan sponsor, is a subsidiary of BHP. The Plan was established as a defined contribution plan covering substantially all employees of BHP Minerals Service Company, as defined in the Plan document. The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### Administration

BHP Minerals Service Company is the Plan's sponsor and Plan administrator. Vanguard Fiduciary Trust Company ("Trustee") serves as trustee for the Plan, and Vanguard Group, Inc. serves as the Plan's recordkeeper. Certain duties, on behalf of the Plan's sponsor, are carried out by the BHP Minerals USA Retirement Advisory Committee (the "Committee"). The Committee members are each appointed by the board of directors of the Company.

#### Contributions

All new employees are automatically enrolled in the Plan based on a pre-tax contribution rate of 6% unless the employee elects to waive immediate automatic enrollment. Participants may make contributions to the Plan on a pre-tax and/or after-tax basis as well as ROTH contributions through payroll withholding of any whole percentage up to 30% of their eligible earnings, subject to certain limitations applicable to highly compensated employees as further described in the Plan document. Contributions may not exceed the limitation (\$23,000 in 2024) set forth in Section 402(g) of the IRC. If Section 402(g) is exceeded, the Plan will automatically switch the participant's election to after-tax contributions for the remainder of the Plan year or up to the total annual contribution limit. Participants may make catch-up contributions (pre-tax contributions that exceed the annual elective deferral limit) during any calendar year ending on or after the participant's 50th birthday. A participant's total catch-up contribution was limited to a maximum of \$7,500 in 2024. After-tax and catch-up contributions are also eligible for matching.

The Company made a matching contribution equal to 100% of the first 6% of eligible earnings contributed to the Plan by the participants for each payroll period. Total employer matching contributions were \$2,047,916 for the year ended December 31, 2024.

The Company also made employer funded contributions to the Plan on behalf of eligible employees. All participants of the Plan are eligible to receive employer funded contributions. The employer funded contribution is equal to 8.5% of each eligible participant's earnings, plus 5.7% of each eligible participant's earnings in excess of the social security taxable wage base for the year, for each payroll period. Total employer funded contributions were \$3,656,347 for the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company contributions, and an allocation of investment income, net of administrative expenses. Investment income allocations are based on the performance of the funds in which the participant has directed his or her accounts to be invested. Upon the occurrence of a distributable event, the benefit to which a participant is entitled is the participant's vested balance in his or her account.

#### Investment Options

The Plan offers mutual funds and collective trust funds as investment options to participants. Additionally, the Plan offers a brokerage account investment option in which participants can select from a large number of mutual funds and individual securities such as common stocks and bonds. Participants may change their investment options at any time.

#### Vesting

Participants are immediately 100% vested in their accounts.

## NOTES TO FINANCIAL STATEMENTS

### 1. Description of Plan, continued

#### Forfeitures

The Plan contains forfeitures arising from participants terminating that are not fully vested or other benefits that are required to be forfeited under applicable law. Forfeitures are applied as follows: (i) first to reinstate any Plan benefits that are required to be reinstated, (ii) any remaining forfeitures are used to pay administrative expenses of the Plan, and (iii) thereafter, to offset future employer contributions. At December 31, 2024 and 2023, the Plan had forfeitures available of \$20,818 and \$3,602, respectively. During the year ended December 31, 2024, forfeitures used to pay administrative expenses, fund employer contributions and to reinstate Plan benefits amounted to \$4,797.

#### In-Service Withdrawals

A participant may take an in-service withdrawal of all or any portion of the balance in his or her after-tax account and/or rollover account. Once age 59 1/2 is attained, a participant may withdraw some or all of the vested amounts in his or her account. A participant may take a hardship withdrawal of all or any portion of the balance in his or her after-tax account and/or rollover account, as well as certain grandfathered Company contributions and tax-deductible retirement accounts, as described in the supplements to the Plan document. A hardship withdrawal shall only be made in the event of a financial need constituting a hardship, as defined in the Plan document.

#### Notes Receivable from Participants

Participants may borrow from the vested portions of their account balances a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 less the highest outstanding loan balance in the last 12 months or (b) 50% of their account balances. No more than one loan is allowed per account at any given time. The loans bear interest at a rate equal to *Reuters* prime rate plus 1%. Interest rates on outstanding loans ranged from 4.25% to 9.50% during the year ended December 31, 2024. Loans must be repaid within five years for general loans and ten years for loans used to purchase a primary residence. Loan repayments are made through payroll deductions. The entire outstanding loan balance becomes due upon employment termination.

#### Payment of Benefits

Upon retirement or other termination of employment, the participant (or his or her beneficiary in the event of death) will receive the value of the vested balance in his or her account according to the following four distribution options: (i) a single, lump-sum distribution in cash, (ii) two or more installments over such period of time as the participant or beneficiary elects, but not extending beyond the life expectancy of the participant and his or her surviving spouse or designated beneficiary, (iii) two or more partial withdrawals at the election of the participant or beneficiary, or (iv) a combination of the methods specified in (i), (ii) and (iii).

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### Expense Offset Arrangements

Fees incurred for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well as on investments held at the end of the year.

#### Benefit Payments

Benefits are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is accrued as earned. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### 3. Fair Value Measurements

Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### 3. Fair Value Measurements, continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan uses the market approach which uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trusts:* Valued at the NAV of units of a collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Self-directed brokerage accounts which include common stocks, mutual funds, and money market funds:* Valued using a variety of methods based on the nature of the underlying assets, but primarily valued at the closing price reported for the market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's administrators believe its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. Information Certified by the Plan's Trustee (Unaudited)

The Plan administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103- 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

### 5. Party-in-Interest Transactions

The Plan invests in shares of mutual funds, a collective trust fund, and a self-directed brokerage account, which are managed by an affiliate of the Trustee and the Plan issues notes receivable from participants. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

### 6. Tax Status

The Plan is based on a non-standardized pre-approved profit sharing plan with CODA sponsored by The Vanguard Group, who received an opinion letter from the Internal Revenue Service dated June 30, 2020, which states the non-standardized pre-approved plan is qualified under the applicable sections of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was tax exempt as of the financial statement dates.

### 6. Tax Status, continued

U.S. GAAP requires Plan management to evaluate the tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the DOL and IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan provides for various investment options. These investment options are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon any such termination, distribution of assets must be made as soon as administratively feasible to Plan participants and other payees. In the event of a Plan termination, all participants become fully vested in their account balances.

### 9. Delinquent Participant Contribution Transactions

During the years ended December 31, 2024, 2023, and 2022, the Company determined that certain employee deferrals, including payments on notes receivable from participants, aggregating \$129,521, \$1,842,977, and \$2,392,457, respectively, had not been remitted to the Plan in a timely manner, according to DOL regulations. Although these remittances were made, they fell outside the normal processing time the Company allows. An investigation was held to determine the root cause of the delinquent contributions, and corrective measures will be taken. The lost earnings for 2023 and 2022 were processed and deposited to participant accounts during August 2024. The lost earnings for 2024 are expected to be processed and deposited to participant accounts by December 31, 2025.
