#### NOTE 1 - DESCRIPTION OF PLAN

The following description of **United Grinding North America, Inc. 401(k) Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - On January 1, 1995, United Grinding Technologies, Inc. (the "Company") adopted a money purchase pension plan, which permitted only employer contributions. On January 1, 1996, the Company adopted a 401(k) profit sharing plan. Effective June 30, 2002, the Company ceased all benefit accruals under the money purchase pension plan. All assets of the money purchase pension plan were merged into the 401(k) profit sharing plan effective June 30, 2002. On August 23, 2013, the Plan's name changed from United Grinding Technologies, Inc. 401(k) Plan to United Grinding North America, Inc. 401(k) Plan to be consistent with the name change of the Company. The Plan allows all eligible employees of the Company who have six months of service to participate. Non-resident aliens, leased employees, and part-time, seasonal, or temporary employees whose regularly scheduled service is less than 1,000 hours are not eligible to participate in the Plan. In accordance with the SECURE Act, effective January 1, 2024, long-term part-time employees who were at least 21 years of age and worked at least 500 hours in each of the prior three years are eligible to participate in the Plan. Upon satisfaction of the eligibility requirements, employees are automatically enrolled at a 6% deferral rate on the first day of the month coinciding with or following the service requirement, unless they elect otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. The Plan also allows participants to make Roth 401(k) contributions. The Company's matching contribution is 35% of a participant's elective deferrals up to 6% of a participant's compensation. The Company may also make a discretionary profit sharing contribution to the Plan. All participants will share in the discretionary profit sharing contribution regardless of service completed during the Plan year or employment status at the end of the Plan year. The discretionary profit sharing contribution will be allocated to the participants in the same ratio as each participant's compensation to the total of such compensation of all participants. The Company did not make a discretionary profit sharing contribution in 2024 or 2023. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

**Participant Accounts** - Reliance Trust Company (the "Trustee") is Trustee and Custodian of Plan investments. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, distributions, and withdrawals. Company contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution, employer match, and discretionary contribution are to be invested.

**Vesting** - Participants are immediately vested in all contributions to the Plan and corresponding earnings.

#### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Notes Receivable from Participants** - Participants may borrow from the Plan in any amount between \$500 and \$50,000, but not more than 50% of their vested account balance. Loans bear interest at the prime rate plus 1%. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Plan provisions allow a participant to have a maximum of two loans outstanding at any one time. Principal and interest are paid ratably through payroll deductions.

**Benefits Paid** - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator. If the participant's account balance is \$5,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. Balances in rollover accounts are not considered in determining whether a terminated participant's vested balance is \$5,000 or less. In addition, participants may receive distributions from all vested amounts for qualified financial hardships.

**Forfeitures** - Forfeitures are used to reduce future Company contributions and pay Plan expenses. No forfeitures were used in 2024 or 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$23 and \$22.

**Investment Options** - Upon enrollment in the Plan, a participant may direct contributions in investment options in increments of one percent. Participants may change their investment options and deferral percentages at any time via telephone or the Internet.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Financial Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

**Investment Valuation and Income Recognition** - Investments are reported at fair value, with the exception of the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses is deemed necessary as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Company pays certain administrative expenses of the Plan, and the Plan participants will bear the responsibility of the remaining expenses. Investment related expenses are included in net appreciation (depreciation) in value of investments. Fees for specific transactions, such as loan and distribution withdrawals, are paid by the individual participant.

The Plan entered into an agreement with the third party administrator, ADP, that allows the Plan to accumulate any excess revenue up to 0.25% in a Plan Expense Account and to use these proceeds to pay reasonable expenses of the Plan. The Plan Expense Account is included in Plan assets and is invested in the MetLife Stable Value Fund. The revenue is accumulated in the account within 45 days after the end of each quarter and is included in investment income in the statement of changes in net assets available for benefits instead of being netted with the expenses it pays. Deposits to the Plan Expense Account totaled \$40,755 and \$34,641 for the years 2024 and 2023. This income was used to pay administrative expenses of the Plan in 2024 and 2023 (see Note 6). The balance in the Plan Expense Account was \$2,142 and \$2,074 at December 31, 2024 and 2023.

**Subsequent Events** - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in value of investments, and interest and dividends for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the Trustee of the Plan).

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Investments in registered investment companies:* Valued at the daily closing price reported by the fund as registered with the Securities and Exchange Commission. The funds held by the Plan are deemed to be actively traded and are required to publish their NAV and to transact at that price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Federated Capital Preservation Fund (the "Fund") is a common collective trust fund that is fully benefit-responsive. Federated Investors Trust Company, a wholly owned subsidiary of Federated Hermes, Inc., manages the fund. The Fund holds guaranteed investment contracts, separate account guaranteed investment contracts, and synthetic guaranteed investment contracts. The investment objective of the Fund is stability of principal and high current income.

The MetLife Stable Value Fund (the "MetLife Fund") is a common collective trust fund that is fully benefit-responsive. Metropolitan Life Insurance Company manages the fund. The MetLife Fund holds guaranteed investment contracts and provides a fixed interest rate for a fixed period. This interest rate is reset quarterly.

Certain events, such as premature termination of the contracts by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Federated Investors Trust Company and Metropolitan Life Insurance Company. The Plan Administrator believes the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

#### NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan assets are invested with Reliance Trust Company. Thus, Reliance Trust Company, as Trustee defined by the Plan, qualifies as a party-in-interest.

ADP is the third party administrator for the Plan, thus qualifies as a party-in-interest. Fees paid by the Plan to ADP totaled \$23,979 and \$22,164 for the years 2024 and 2023.

Everhart Advisors is engaged to provide advisory services for the Plan, thus qualifies as a party-in-interest. Fees paid by the Plan to Everhart Advisors totaled \$40,755 and \$34,641 for the years 2024 and 2023.

#### **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and its related regulations.

#### **NOTE 8 - TAX STATUS**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing and 401(k) Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 10 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS**

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

#### **NOTE 11 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

For the years 2024 and 2023, there were no differences between the financial statements and the Form 5500.
