#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

### 1. General information

The Following description of the Aveena's Loving Companion Care Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all employees of the Company. Employees are eligible to participate immediately upon employment. There are no age or service requirements for any type of contribution under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the plan sponsor.

#### *Contributions*

The Plan provides for employer contributions in the form of Qualified Nonelective Contributions ("QNECs"). At the inception of the Plan in 2021, unused balances from employer-provided benefit card programs that could not be carried forward by employees were transferred to the Plan and recorded as QNECs. These contributions were immediately and fully vested when made.

Effective January 1, 2022, the benefit card program was amended to allow employees to carry forward unused balances to subsequent years. Accordingly, no additional QNEC contributions from unused benefit card balances have been made to the Plan since 2022.

The Plan provides for employer contributions in the form of a prevailing wage contribution on behalf of each Participant who performs services subject to the Service Contract Act, Davis-Bacon Act, or similar federal, state, or municipal prevailing wage statutes. The prevailing wage contribution is determined as the amount equal to the remaining balance of the prevailing wage bona-fide fringe benefit obligation, based on the Participant's employment classification as designated under the applicable prevailing wage determination, after application of other bona-fide fringe payments. The contribution rates applicable to each prevailing wage employment or job classification are specified in Plan's Adoption Agreement. Prevailing wage contributions are not subject to age or service requirements, entry date provisions, or service and employment conditions, and Participants are immediately 100% vested in such contributions. Prevailing wage contributions are required under applicable prevailing wage laws, are not dependent on elective deferrals or continued employment, and are made regardless of age or length of service.

There was no employer contributions during the years 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and stable value funds as investment options for participants.

All contributions were made in compliance with the applicable requirements of the Internal Revenue Code and ERISA.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. General information (Continued)

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon and Company's contributions.

#### *Payment of Benefits*

On termination of service due to death, disability or retirement, a participant may elect to receive lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### *Forfeited Accounts*

Forfeitures may be used to pay any administrative expenses. As of December 31, 2024 and 2023, there were no forfeited nonvested accounts.

### 2. Summary of significant accounting policies

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value., except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### *Excess Contributions Payable*

Amounts payable to participants totaling \$5,000 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to 2024 contributions. There were no excess contributions for the year ended December 31, 2024.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of the Plan are included in administrative expenses and charged directly to the participant's account.

#### *Date of Management's Review of Subsequent Events*

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

### 3. Fair value measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

#### Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

#### Level 2 Fair Value Measurements

The fair value of corporate bonds and U.S. government securities are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

**4. Related party transactions and party in interest transactions**

Certain Plan investments are shares of mutual funds managed by Reliance Trust Corporation. Reliance Trust Corporation is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**5. Plan termination**

the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### 6. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### 7. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 8. Certified investments

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule of all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Corporation (the trustee of the Plan).

### 9. Subsequent event

On October 1, 2025, the Plan sponsor has approved a termination of the Plan. The Plan is expected to distribute all assets to participants and beneficiaries as soon as administratively feasible following receipt of necessary regulatory approvals. As of December 31, 2024, the Plan continued normal operations and accompanying financial statements do not include any adjustments related to this subsequent event.
