### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Goodwill Industries of Hawaii, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Goodwill Industries of Hawaii, Inc. 401(k) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- (1) **General** - The Plan is a defined contribution plan established by Goodwill Industries of Hawaii, Inc. and Goodwill Contract Services Hawaii, Inc. (collectively the Organization) effective January 1, 1999. The Plan covers substantially all employees of the Organization except for certain classes of employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (2) **Participation** - Employees who have completed six consecutive months of service, defined as at least 500 hours of service and are age twenty-one or older are eligible to make elective deferrals on the first day of the calendar quarter following completion of at least one hour of service during that Plan year. In addition, once eligible for elective deferrals, employees will be eligible for all other Organization contributions if they complete one year of service with at least 1,000 hours of service and are still employed by the Organization on the last day of the Plan year.
- (3) **Contributions** - Each year, participants may elect to defer up to 100% of pretax annual compensation as defined in the Plan, not to exceed limitations set forth by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Organization may make an annual matching contribution equal to a percentage of the participant's contribution during the plan year, up to an annual limit per eligible participant. The percentage to be matched and the limit for each Plan year is determined by the Organization. For the Plan years ended December 31, 2024 and 2023, the Organization made matching contributions of 50% of participants' annual contributions, up to 4% of the participants' eligible compensation during the respective years.

The Organization may also elect to make profit sharing contributions. No profit sharing contributions were made for the years ended December 31, 2024 and 2023.

- (4) **Participant accounts** - Each participant's account is credited with the participant's elective contributions, employer matching contributions, and allocations of employer profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- (5) **Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts plus earnings thereon is based on years of service. Participant's profit sharing and matching account shall be vested according to the following schedule:

1	0%
2	20%
3	50%
4	75%
5	100%

- (6) **Notes receivable from participants** - Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years, unless used to acquire a primary residence. Loans are secured by the participant's vested account balance and bear interest at a rate commensurate with prevailing rates for loans under similar circumstances at the date of the loan, as determined by the Administrative Committee. Principal and interest are paid ratably through payroll deductions.
- (7) **Payment of benefits** - Upon termination of service due to retirement, attainment of age 59½ years, hardship, disability, death, or other termination of service, a participant (or, in the event of a participant's death, their designated beneficiary), may receive the value of the vested interest in his or her account as a lump-sum distribution, in periodic installments over a fixed period, or a rollover to an IRA or another qualified retirement plan.
- (8) **Forfeitures** - As of December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$12,571 and \$8,324, respectively. These accounts will be used to reduce Organization contributions or to pay reasonable Plan expenses. No forfeitures were used for either purpose during the years ended December 31, 2024 or 2023.
- (9) **Plan termination** - Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, the accounts of all participants affected by the termination shall become fully vested.

**NOTE B - SIGNIFICANT ACCOUNTING POLICIES**

- (1) ***Basis of accounting*** - The financial statements of the Plan have been prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America (U.S. GAAP).
- (2) ***Use of estimates*** - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (3) ***Investment valuation and income recognition*** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (4) ***Notes receivable from participants*** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution on the basis of the terms of the Plan document.
- (5) ***Excess contributions payable*** - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and net appreciation (depreciation) in fair value of investments, if any. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.
- (6) ***Payment of benefits*** - Benefits are recorded when paid.
- (7) ***Administrative Expenses*** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.
- (8) ***Subsequent events*** - The Plan has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that required adjustment of or disclosure in the financial statements.

**NOTE C - CERTIFIED INVESTMENT INFORMATION**

Certain information related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the custodian of the Plan).

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the funds. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

**NOTE E - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE F - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Organization has indicated that it will take the necessary steps, if any, to maintain the Plan's qualified status.

**NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

Standard Retirement Services, Inc. (The Standard) provides recordkeeping services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid directly to The Standard, via The Standard's parent company StanCorp Financial Group, Inc., by the Plan were \$27,122 and \$25,690 for the years ended December 31, 2024 and 2023, respectively.

LPL Financial LLC (LPL) and the trust division of Central Pacific Bank (CPB) provide investment consulting services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid directly to LPL and CPB by the Plan were \$23,221 and \$20,220 for the years ended December 31, 2024 and 2023, respectively.
