Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Lotspeich Co. of Florida, Inc. 401(k) Profit Sharing Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 – Description of the Plan

The following description of the Lotspeich Co. of Florida, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established November 1, 1972 and restated effective January 1, 2021. The Plan is sponsored by Lotspeich Co. of Florida, Inc. (the “Company”). The Plan covers substantially all employees of the Company who have completed 90 days of service, are not union employees, and are at least 18 years of age. To be eligible to receive the company matching contribution and profit-sharing contribution, an employee must have reached 1,000 hours of service, be at least 18 years of age and be employed by the Company on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute up to 50% of annual compensation, as defined by the Plan. Participants may designate these deferrals to be pre-tax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company may make a discretionary matching contribution. The amount of the discretionary contribution is determined by the Company. All contributions are participant directed and are directed into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions and the discretionary matching contributions plus actual earnings thereon. The Company’s discretionary matching contribution begins to vest after two years of service at a rate of 20% per year and are fully vested after six years of service. Participant accounts become fully vested in the event of death, total disability, and normal retirement while still employed.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have two notes outstanding at a time. The notes are secured by the balance in the participant's account. The note interest rate is set at 2% above the prime rate, as defined. Principal and interest are repaid ratably through payroll deductions over a period of five years or less, unless for the purchase of a principal residence, in which case the note term may exceed five years.

Payment of Benefits

On termination of service due to death, disability, separation, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions and hardship withdrawals, as defined by the Plan, are allowed from all types of contributions. Early retirement distributions, as defined by the plan, are allowed from employer contributions only.

Forfeited Accounts

These accounts may be used to pay administrative expenses or used to reduce Company contributions. The amount of forfeited non-vested benefits used to reduce employer contributions for the year ended December 31, 2024 was approximately \$24,000. There were no forfeited non-vested benefits used to reduce employer contributions for the year ended December 31, 2023. At December 31, 2024 and 2023, the balance in the forfeited non-vested accounts totaled approximately \$8,700 and \$24,000, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 – Summary of Accounting Policies (Continued)

Investment Valuation

The Plan's investments, except for the Insurance Company General Account (ICGA), are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

ICGA held by a defined contribution plan that are fully benefit responsive are reported at contract value. Contract value is the relevant measurement because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract. Contract value represents contributions plus interest at the contract rate, less distributions and fees, if applicable. See note 5 for discussion of the ICGA.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan, of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Total administrative expenses paid by the Plan for the years ended December 31, 2024 and 2023 were approximately \$82,000 and \$84,500, respectively. Investment related expenses are included in net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution is recorded.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, and determined that no disclosure in these financial statements was necessary.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.,

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, other inputs that are observable, or can be corroborated by observable market data.

Level 3 – Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts (CIT) – CITs are valued at the NAV of the shares held by the Plan at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The CITs provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. There is no restriction in place with respect to the daily redemption of the CITs and there are no unfunded commitments.

Pooled Separate Accounts (PSA): PSA units are valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). While the majority of the underlying asset values are based on quoted prices, the NAV of the PSAs is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date and there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Note 5 – Insurance Company General Account

During 2024, the Plan invested in the Empower Fixed Account – Series Class IV (EFA). The EFA is a benefit responsive contract entered into with Empower Annuity Insurance Company of America (EAICA). EAICA maintains contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The EAICA is valued at contract value for presentation in the Plan's net assets available for benefits.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawal and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. At December 31, 2024, the effective net credit rate after the deduction for fees was 2.20%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan and EAICA are required to give a 75-calendar day notice before terminating the contract. Currently, Plan management believes the occurrence of an event that would cause the Plan to transact at less than contract value is not applicable.

Note 6 – Related Party and Party-In-Interest Transactions

For the years ended December 31, 2024, and 2023, John Hancock Life Insurance Company, the former custodian of the Plan and Wilshire Associates, Inc., an investment advisor to the Plan, received compensation from the Plan. For the year ended December 31, 2024, Retirement Solutions Specialists, the Plan's third-party administrator, also received compensation from the Plan. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for additional investment management services are included in net appreciation in fair value of the investment. Notes receivable from participants also qualify as party-in-interest transactions.

Note 7 – Income Tax Status

The IRS has determined and informed Definiti, LLC, the Plan's third party administrator, by a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan With CODA (the prototype plan upon which the Plan is based) is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the opinion letter, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRS and, therefore, believes the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Transfer of Assets

During December 2024, the Plan transferred assets from John Hancock Life Company, the former custodian, to Empower Trust Company, LLC, the current custodian. The Plan transferred approximately \$22,100,000 of plan assets, including Notes Receivable from Participants. As a result of this transfer, there was a blackout period from November 25, 2024, through December 19, 2024, where participants were unable to make changes to their accounts. These transactions qualify as party-in-interest transactions.
