## Notes to Financial Statements

### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Accounting***

The accompanying financial statements of Schneller Plumbing Heating & Air Inc 401(k) Plan (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value except the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and market risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

#### ***Benefit Payments***

Benefit payments are recorded when paid.

#### ***Related Party Transactions***

Certain plan investments in 2023 were managed by Mutual of Omaha Trust Company. Mutual of Omaha was the asset trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day administration. The Plan is not charged by the Company for these services.

#### ***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Management believes that the estimates utilized in preparing its financial statements are reasonable and prudent.

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Expenses*

Certain Plan expenses are paid by the Plan sponsor and accordingly, are not reflected in the Plan's financial statements. Investment related expenses are included in net appreciation of fair value investments.

##### *Subsequent Event Evaluation*

In preparing its financial statements, the Plan has evaluated events subsequent to the balance sheet date through October 9, 2025, which is the date the financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Schneller Plumbing Heating & Air Inc 401(k) Plan, effective April 1, 2011 and restated January 1, 2022, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is available to eligible employees of Schneller Plumbing Heating & Air, Inc. (the "Company"). An employee is eligible to be a participant in the Plan, after completing two months of service and reaching age 18. Participants are automatically enrolled at 3% of plan compensation unless otherwise opting out of the plan. An employee becomes eligible for non-elective employer contributions, employer matching and safe harbor contributions after completing one year of service or 1,000 hours.

##### *Contributions*

A participant may elect to contribute up to 100% of his or her pre-tax or post-tax earnings, not to exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986, as amended (\$23,000 in 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations. The Company matches the first 100% of participant contributions up to 3% and 50% of the next 2% of contributions.

##### *Participant Accounts*

Each participant's account is credited with the participant's and Company's contributions. Earnings and dividends attributable to investments are allocated to participant's accounts on a pro rata basis, based upon the proportion of a participant's investment fund account balance to the total investment fund balance of all participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### *Vesting*

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Rollover Contributions*

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

##### *Payment of Benefits*

Upon a participant's retirement at age 65, death, or other termination of employment with the Company, a participant may elect to receive vested benefits in the form of a lump-sum distribution or any form of installment payments. Under certain circumstances, vested benefits may be distributed early if participants are 59½ years or older.

In conditions of "financial hardship" a participant may apply to the Plan administrator for approval to withdraw the employee deferral portion of their 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

In the event of a Plan termination, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

#### NOTE 4 FAIR VALUE MEASUREMENTS

Generally accepted accounting principles ("GAAP") provisions of accounting for Fair Value Measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP provisions of accounting for Fair Value Measurements are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

### Notes to Financial Statements (Continued)

#### NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

*Pooled separate accounts:* Value based on the fair value of the underlying investments, which is represented by the net asset value ("NAV") of shares of the underlying fund as published by the trustee.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan was invested in a fully benefit-responsive investment contract with the trustee as of December 31, 2023. The trustee maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events may limit the ability of the Plan to transact at contract value with the trustee. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or plan termination, retirement incentive programs, and liberalization of plan withdrawal or transfer rules. As of December 31, 2023, the occurrence of any such event is not considered reasonable.

#### **NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **NOTE 7 TAX STATUS**

The Plan obtained its latest advisory letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the advisory letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.


