### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Family 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. #### **Note 1 - Description of the Plan**

The following description of the Family 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all employees of Spring Water of San Diego, LLC dba Blu Bulk Delivery, Diamond Environmental Services, L.P., Diamond Maintenance Services, LLC, Diamond Solid Waste Services, Inc., Diamond Power Services, Inc., and Hilltop Group, Inc. (collectively, the Company) except non-resident aliens with no U.S. source income, employees acquired through acquisition or merger during the transaction period, or leased employees who have completed one year of service and are age 21 or older. A year of service is defined as 12 consecutive months during which an employee completes at least 1,000 hours of service. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan engaged Ascensus Trust Company to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### Contributions

Each year, participants may contribute up to a specified percent of pretax annual compensation, subject to limits of the tax law as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Newly eligible participants elect their deferral amounts to be withheld. The Company may contribute discretionary matching, qualified non-elective contributions (QNEC), and non-elective contributions, the amounts of which are determined each year. During 2024, the Company made matching contributions equal to 50% of the first 3% of eligible compensation that a participant contributed to the Plan. The Company did not make any discretionary QNEC or non-elective contributions. Contributions are subject to certain limitations.

Employees working on a prevailing wage contract receive contributions that help satisfy the fringe benefit requirements or prevailing wage law. Such contributions are 100% vested. For purposes of receiving any prevailing wage contribution made to the Plan, participants are eligible to participate from their date of hire. Total prevailing wage contributions paid to the Plan were \$217,957 during the year ended December 31, 2024.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are made in a manner which recognizes each participant's account balance, investment selection, and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or up to 15 years for the purchase of a principal residence. Principal and interest is paid ratably through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with rates charged by commercial lenders for loans made under similar circumstances. The interest rates were 4.25%–9.50% for the years ended December 31, 2024 and 2023.

#### **Note 1 - Description of the Plan, continued**

##### Vesting

Participants are immediately vested in their deferral and prevailing wage contributions plus actual earnings thereon. Vesting in the Company's matching and non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become vested in their employer matching and non-elective contributions under a six-year graded vesting schedule. A participant becomes 20% vested after two years of credited service and is 100% vested after six years of credited service. Participants are 100% vested in the Company's QNEC. Any amount not vested upon a participant's separation from service is forfeited. A participant also becomes fully vested in the entire balance of their account upon attainment of normal retirement age, permanent disability, death, or termination of the Plan.

##### Payment of Benefits

On termination of service due to any reason, participants with vested account balances of less than \$5,000 may receive a single lump-sum payment or an automatic distribution to an Individual Retirement Account (IRA). Participants with vested account balances of \$5,000 or more may elect to receive a single lump-sum amount, choose to rollover their balance into another qualified retirement plan or IRA, or leave their balance in the Plan. Participants may also elect to take in-service withdrawals subject to the terms of the Plan document and Internal Revenue Service (IRS) regulations.

##### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,109 and \$31,602, respectively. During the year ended December 31, 2024, forfeitures of \$21,305 were used to pay Plan expenses.

#### **Note 2 - Summary of Significant Accounting Policies**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Payments of Benefits

Benefits are recorded when paid.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### **Note 2 - Summary of Significant Accounting Policies, continued**

##### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

##### Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees are charged to participants on a pro rata basis, equally to participant accounts, or specifically to a participant account for transactions specifically related to that participant.

##### Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 3 - Information Certified by Trustees**

The Plan's investments are held by Ascensus Trust Company and Newport Trust Company, LLC, the Trustees of the Plan. The annual record keeping is prepared by Ascensus, LLC, the Recordkeeper, on behalf of Ascensus Trust Company and Newport Trust Company, LLC. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses as charged by the Trustees. The Plan Administrator has obtained a certification from the Recordkeeper on behalf of the Trustees as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the following information provided to the Plan Administrator by the Trustees is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest on notes receivable from participants

#### **Note 4 - Fair Value Measurements**

Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

#### Note 4 - Fair Value Measurements, continued

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of inputs may be used to measure fair value:

Level 1 - quoted prices in active markets for identical assets or liabilities.

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 6 - Tax Status

The IRS has determined by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA sponsored by CCH Incorporated DBA ftwilliam.com, which has been adopted by the Plan, is acceptable pursuant to section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements at December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7 - Party-in-Interest Transactions

Economic Group Pension Services, Inc. provides third-party administration services to the Plan, Fisher Asset Management, LLC provides investment management services to the Plan, and Ascensus, LLC provides recordkeeping services to the Plan. Transactions with these entities qualify as party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.

#### Note 8 - Reconciliation of Financial Statements to Form 5500
