Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Franklin Sports, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

The following description of the Franklin Sports, Inc. 401(k) Plan (the Plan) of Franklin Sports, Inc. (the Company) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by the Company on July 27, 1994.

The Plan was most recently amended effective January 1, 2024, to reduce the minimum age for eligibility to participate in the Plan from 21 years to 18 years, and to remove the requirement for one year of service with 1,000 hours of service to become eligible for nonelective employer contributions and the requirement for three months of service to become eligible for employer matching contributions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Under a trust agreement dated July 27, 1994, the Employee Benefits Committee (the Committee) was appointed by the Company's Board of Directors as the Plan's trustee. The Committee transferred its responsibilities as plan trustee to the Fidelity Management Trust Company as of July 1, 2000. The Committee retains fiduciary responsibility for the Plan.

Eligibility requirements: The Plan allows for initial participation by any employee, excluding specific groups of employees, as defined in the plan document, who has attained the age of 18 years for the year ended December 31, 2024 and age of 21 years for the year ended December 31, 2023. Eligible employees can immediately enter the Plan upon hire.

For Plan years up to and including the year ended December 31, 2023, to become eligible for the nonelective employer contribution, if made by the Company, an eligible participant must have completed one year of service with the Company and have 1,000 hours of service in the plan year for which the contribution is made. To become eligible for the matching employer contribution, eligible employees must have completed three months of service with the Company. Effective January 1, 2024, these requirements no longer apply, and all employees of age 18 and older are eligible to participate in the Plan and to receive employer contributions.

Contributions: Eligible employees can contribute an amount up to 60% of compensation, as defined by the Plan, subject to certain limitations under the Internal Revenue Code (IRC). The Company provides a matching contribution equal to 25% of each participant's deferral contribution, limited to 4% of eligible compensation which has been deferred upon. For the years ended December 31, 2024 and 2023, gross matching contributions amounted to \$186,277 and \$169,461, respectively. These matching contributions were recorded net of forfeiture funds applied in the amount of \$5,841 and \$3,798, respectively, with the net matching contributions amounting to \$180,436 and \$165,663 for the years ended December 31, 2024 and 2023, respectively.

The Company provides a non-elective safe-harbor contribution of 3% of employee's eligible annual compensation.

Note 1. Description of Plan (Continued)

The Company also provides an elective contribution, based on a percentage of an employee's eligible annual compensation, at the Company's discretion. The contribution percentage is determined by a sliding scale based on four population groups. These population groups are ordered by years of service, as detailed in the table below. The percentages used to determine the contribution within each population group are subject to annual compliance testing requirements. The elective contribution for the 2024 and 2023 plan years was based on the following table:

Eligible compensation is also subject to certain limitations under the IRC. For the year ended December 31, 2024, elective and non-elective employer contributions amounted to \$348,567 and \$652,414. For the year ended December 31, 2023, elective and non-elective employer contributions amounted to \$309,991 and \$600,865. The contributions are reported as employer contributions receivable of \$1,000,981 and \$910,856 at December 31, 2024 and 2023, respectively. No forfeiture funds were applied against the employer contributions receivable at December 31, 2024 and 2023.

Participant accounts: Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer elective and non-elective contributions, as well as the participant's share of the Plan's earnings and any related investment expenses. The allocations are based upon each participant's account balance in relation to all participant account balances within each investment fund.

Vesting and forfeitures: Participants are fully vested in their contributions and the earnings thereon. The employer match and discretionary employer contribution vest ratably at 20% per year over a five-year period starting with the employee's first year of eligibility. Forfeitures represent non-vested portion of participants' accounts at the time of termination. For the years ended December 31, 2024 and 2023, total forfeitures amounted to \$12,642 and \$8,048, respectively. Unallocated forfeitures are used to pay administrative expenses or to reduce employer contributions. For the years ended December 31, 2024 and 2023, no forfeitures were used to pay administrative expenses. Forfeitures used to reduce matching contributions during 2024 and 2023 were \$5,841 and \$3,798, respectively. Forfeitures used to reduce elective employer contributions during 2024 and 2023 were \$4,671 and \$33,956, respectively. As of December 31, 2024 and 2023, there were \$9,899 and \$4,800 of unallocated forfeitures, respectively.

Investment elections: Participants may direct the allocations of their accounts in whole percentages to a variety of mutual funds, a common collective trust fund, and a money market fund.

Notes receivable from participants: Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 (less the highest outstanding loan balance in the previous 12 months) or 50% of their vested account balance. Loan terms are provided up to five years for the purpose of immediate and heavy financial needs, as defined, including loans which are for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus 1% at the time of the loan issuance. Principal and interest are paid through payroll deductions.

Note 1. Description of Plan (Continued)

Payment of benefits: A participant, or beneficiary in the case of death, may withdraw all or a portion of their account balance upon termination of employment, attaining early retirement age of 59½, attaining normal retirement age of 65, death, qualifying hardship, or permanent disability. Beginning in 2020, once a participant reaches the age of 72, the participant will receive minimum required distributions on at least an annual basis. Prior to 2020, once a participant reached the age of 70½, the participant would receive minimum required distributions on at least an annual basis. Generally, the participant will be distributed their vested account balance in the form of a lump-sum payment. However, a participant may also elect to receive their vested account balance in the form of installment payments.

Administrative costs: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The custodian has established an expense budget account, whereby any funds generated by investments under this arrangement can be used to offset plan expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

On a quarterly basis, the Plan receives revenue credits from Fidelity, the Plan's third-party administrator, which represent revenue generated by the Plan that is returned to the Plan by Fidelity. These funds may be used only for payment of reasonable and necessary expenses for the Plan or allocation to participants. The balance in the Plan's administrative budget account was \$0 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Plan received \$59,484 in revenue credits, which are included in other income on the statement of changes in net assets available for benefits, and used revenue credits of \$59,484 to pay Plan expenses during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair value measurements: U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that is observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation techniques: There have been no changes in the valuation techniques used during the current period.

Mutual funds: Mutual funds are valued at the quoted market prices. These securities are categorized in Level 1 as they are actively traded and no valuation adjustments have been applied.

Money market fund: The money market fund is stated at cost, plus accrued interest, which approximates fair value. This investment is categorized as Level 1.

Common collective trust fund: Valued at net asset value (NAV) per unit based on the underlying investments comprising the trust and based on audited financial statements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Note 2. Summary of Significant Accounting Policies (Continued)

Payment of benefits: Benefits are recorded when paid.

Income taxes: U.S. GAAP requires plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

Note 4. Information Prepared and Certified by Plan's Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, that was prepared by or derived from information provided by Fidelity Management Trust Company, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets are complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information related to the following assets:

Fidelity Management Trust Company also certified to the completeness and accuracy of \$4,266,848 and \$4,693,770 in net appreciation in fair value of investments, \$1,974,649 and \$1,053,755 of interest and dividends related to the aforementioned assets, \$20,474 and \$11,759 of interest income on notes receivable from participants, and \$59,484 and \$0 of other income for the years ended December 31, 2024 and 2023, respectively.

Note 5. Notes Receivable from Participants

The Plan permits its participants to obtain loans against their account balance. Loans to participants are collateralized by the respective participant's remaining account balance. Certain restrictions apply to participant loans, as defined in the Plan agreement. As of December 31, 2024 and 2023, total loans outstanding were \$318,661 and \$223,604, respectively.

During the years ended December 31, 2024 and 2023, interest earned on such loans was \$20,474 and \$11,759, respectively.

Note 6. Tax Status

The Plan document is stated in accordance with the Fidelity Volume Submitter Defined Contribution Prototype Plan. This prototype plan obtained its latest advisory letter on March 31, 2014, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. The Plan Administrator believes that the Plan continues to be designed and is currently being operated in compliance with the applicable provisions of the IRC. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Approximately 9% and 13% of the Plan's assets are held in the Putnam Stable Fund as of December 31, 2024 and 2023, respectively, which is a Common Collective Trust. As such, this is considered to be a concentration of credit risk.

Note 8. Party-in-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain plan investments are shares of various mutual funds and a money market fund which are owned and managed by Fidelity Investments Institutional Operations Company, Inc., an affiliate of Fidelity Management Trust Company, the trustee of the Plan. In addition, the Plan issues loans to participants, which are secured by the balances in the participant's account, and also constitute party-in-interest transactions.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
