Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the accompanying financial statements of Teachers Fringe Benefit 403(b) Program (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institutions, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Teachers Fringe Benefit 403(b) Program has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 3, the Plan has excluded from its investments in the accompanying statements of net assets available for benefits. Certain annuity and custodian accounts issued prior to January 1, 2009, and related records were maintained at a contract level; therefore, management has not maintained, and the Plan's vendors did not provide, sufficient accounting records and supporting documentation relating to certain annuity and custodian accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL Field Assistance Bulletin No, 2009-02, *Annual Reporting Requirements for 403(b) Plans*.

The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. The amounts of these excluded annuity and custodial accounts and related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The Plan has not maintained sufficient accounting records and supporting documents related to these annuity and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply audit procedures sufficiently to determine the extent to which the financial statements may have been affected by those conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Teachers Fringe Benefit 403(b) Program's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Teachers Fringe Benefit 403(b) Program, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

Supplemental Information Required by ERISA

The supplemental information of Schedule H, line 4i, Schedule of Assets (Held at End of Year) and Schedule H, line 4a, Schedule of Delinquent Participant Contributions as of or for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of the Teachers Fringe Benefit 403(b) Program (the Plan) provides only general information. Participants should refer to the Plan document for more complete description of the Plan's provisions.

General and eligibility

The Plan is a 403(b) tax deferred annuity plan, established on September 1, 2004. The Plan has since been amended and restated throughout the years to comply with certain tax legislation. The Plan provides for the employees of the Center for Advancement of Jewish Education (Plan Administrator) and affiliated organizations (collectively, Employers) to participate beginning on the first day of the pay period immediately following their date of hire. There is no minimum age or service requirement. Permissible employees include employees of the Plan Administrator and Employers, as defined in accordance with the universal availability standards.

Empower Retirement Services, LLC (Empower) serves as the Plan's recordkeeper. Empower Annuity Life Insurance Company of America (EAIC) and Empower Trust Company, LLC (the Trustee) serve as the Plan's custodian and trustee, respectively, of the Plan's guaranteed investment contract and mutual funds, offered by the Plan's primary recordkeeper.

The recordkeeper and custodian of the Plan's pooled separate accounts (PSAs) and a guaranteed investment contract is Mutual of America (MOA). The recordkeeper for the Plan's Stable Value Fund investment is FasCore, LLC with the custodian being Metropolitan Life Insurance Company. Participants are no longer allowed to make contributions into investments held by MOA and MetLife (MetLife).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may voluntarily contribute up to 100% of their eligible annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Catch-up contributions are permitted for participants who are age 50 or older during the Plan year. Special catch-up contributions are permitted for participants who prior to the age of 50 have at least 15 years of service with the same qualified employer. All participant contributions are participant-directed and may be invested into various investment options offered by the Plan.

The Plan provides for the Employers to make discretionary matching contributions, up to a maximum of 4% of the participant's eligible compensation, as defined, that a participant contributes to the Plan.

Contributions are subject to certain IRS limitations.

Participant accounts

Each participant account is credited with the participant's contributions and an allocation of: (a) the Employers' contributions (if any), and (b) Plan earnings or losses thereon. Participant accounts are charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All participant contributions are participant-directed and may be invested into various investment options offered by the Plan.

Note 1 – Description of Plan, Continued

Vesting

Participants are immediately vested in their individual contributions, and their Employer's discretionary matching contributions, plus actual earnings thereon.

Forfeitures

Forfeited nonvested accounts may be used to offset certain Plan administrative expenses or reduce the Employers' future contributions. During the year ended December 31, 2024, forfeitures of \$160 were used to offset certain Employers' contributions and Plan administrative expenses. At December 31, 2024 and 2023, available unallocated forfeitures amounted to \$17,372 and \$17,175, respectively.

Payment of benefits

On termination of service, retirement, disability or death, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her accounts. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. In-service withdrawals are permitted from pre-tax contribution account balances upon reaching early retirement (age 59 ½) or demonstration of financial hardship.

Notes receivable from participants

A participant may borrow from the Plan an aggregate amount not to exceed the lesser of: (a) \$50,000 or (b) 50% of the participant's vested account balance. Interest on participant loans is the prime interest rate plus 1 percentage point. Participants may only have one outstanding loan at any given time. The notes are secured by the vested balance in the participant's account and principal and interest are paid according to the note agreements through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions in accordance with the Plan's provisions.

Investment options

Participants may direct their contributions and the Employers' contributions into any of several investment options, including mutual funds and a stable value fund. Participants may change their investment options at their discretion. The Plan also has investments in PSAs and a guaranteed interest contract; however, participants are no longer permitted to direct their contributions into these investments.

Plan expenses

For the year ended December 31, 2024, the Plan classified certain administrative expenses as an expense rather than as a reduction of investment income. Substantially all administrative expenses for maintaining the Plan are paid by the Employers and are not reflected in these financial statements. Certain expenses paid by the Plan consist of recordkeeping, trustee, custodian, professional fees, and third-party administration fees.

Certain participant directed transactions such as loan processing fees and withdrawal fees are charged directly to the participants' accounts. Fees from covered service providers of the Plan are in compliance with Department of Labor's (DOL) regulations under ERISA Section 408(b)(2).

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the Trustee.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and those differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, liquidity risk and credit risk. Due to the level of risk associated with certain investment securities, including the uncertainty related to changes in the value of investment securities, it is at least reasonably possible changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Payment of benefits

The Plan records benefits when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Related fees are charged directly to the borrowing participant's account and included as administrative expenses when incurred. Any delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative expenses

The Employers absorb a significant part of the administrative costs for the Plan, including professional fees for accounting, auditing and Plan administration, contract charges and serving fees. Administrative fees paid by the Employers are excluded from these financial statements.

Administrative expenses, continued

Participant requested transactions such as loan origination and distribution fees are paid by the participants of the Plan. Investment management fees charged to the Plan for investments in the various funds are deducted from income earned and are reflected as a component of net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

Uncertain tax positions

U.S. GAAP requires Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at December 31, 2024 that it would be unable to substantiate.

Note 3 – Excluded Investments

The Plan has excluded from investments in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, certain annuity and custodian accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have been excluded from the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. The amounts of these excluded annuity and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Note 4 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FasCore, LLC, Mutual of America Life Insurance Company, Empower Annuity Insurance Company of America, Empower Trust Company, LLC, and Reliance Trust Company, the qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental information is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the Schedule H, Line – 4i Schedule of Assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 5 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts (PSA) – units held in the PSAs are valued at the net asset value (NAV) based on the fair market value of the underlying investments of the PSA less its liabilities. PSAs are either made up of a single underlying mutual fund or multiple underlying funds. The NAV per share is used as a practical expedient to estimate fair value of a PSA as long as certain requirements are met. This practical expedient is not used if it is determined to be probable that the PSA will sell for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments related to this investment. This is a direct filing entity.

Stable value fund – The stable value fund is a collective trust fund composed of a group annuity contract consisting of separately managed fixed income investment portfolios. The stable value fund is valued at the net asset value (NAV), which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily with no advance notice. There are no unfunded commitments related to these investments. If the Plan initiates a full redemption of the stable value fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. This is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan invests in certain fully benefit-responsive investment contracts as of December 31, 2024 and 2023, which are summarized at contract value as follows:

The Plan invests in two fully benefit-responsive investment contracts with two insurance companies. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contracts with the insurance companies meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the contract issuers (EAIC and MOA), represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on MOA and EAIC's ability to meet their financial obligations. MOA and EAIC's ability to meet their contractual obligations may be affected by future economic and regulatory developments.

EAIC General Account

The Plan invests in the EAIC General Account (GA) which is a fully benefit-responsive investment contract issued by Empower Annuity Insurance Company of America (EAIC). EAIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The EAIC contract guarantees a minimum annual interest of 1%, not to exceed 3%. The crediting rates are reviewed on a quarterly basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with EAIC. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. In addition, certain events allow EAIC to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuers. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with EAIC and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow EAIC to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of EAIC.

MOA Interest Accumulation Account

The Plan invests in a fully benefit-responsive investment contract issued by Mutual of America Life Insurance Company (MOA or the issuer). MOA maintains the contributions in its general account. The Interest Accumulation Account (IAA) is credited with earnings on the underlying investments and charged for participant withdrawals, transfers, and administrative charges. Amounts allocated to the IAA become part of the general assets of MOA.

There are no reserves against contract value of the credit risk of MOA or otherwise. The crediting interest rate is based on a formula agreed upon with MOA but may not be less than 1.00% or more than 3.00% as specified in the contract. Such interest rates are reviewed periodically, but no less than annually for resetting. MOA guarantees the value and bears full investment risk for all amounts that participants allocate to MOA's general account.

Certain events limit the ability of the plan to transact at contract value with MOA. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations; (4) the failure of the plan to qualify under 401(a) of the IRC or the failure of the trust to be tax exempt under Section 501(a) of the IRC; or (5) premature termination of the contract.

MOA Interest Accumulation Account, continued

The Plan Administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with MOA, and that also would limit the ability of the Plan to transact at contract value with the participants. However, MOA has the right to delay transfers and withdrawals from the IAA for up to six months following the date that it receives the transaction request.

Note 7 – Plan Termination

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would remain 100% vested in their account balances.

Note 8 – Tax Status

The Plan uses a volume submitter plan document sponsored by Empower. Empower Retirement, LLC received an opinion letter from the IRS, dated April 7, 2021, which states that the prototype document, as then designed, satisfies the applicable provisions of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Accordingly, Plan management has determined it does not have any uncertain tax positions as of December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 9 – Party-In-Interest Transactions

Parties-in-interest are defined under the DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Administrator, the Employers, and certain others. Empower serves as the recordkeeper. Additionally, FasCore and MOA serve as the recordkeepers of certain portions of the Plan's investments. As such, fees paid for loan origination and distribution services and other services qualify as party-in-interest transactions.

The Plan's investments also include shares of mutual funds, fixed annuity contracts and accounts which are managed, administered, and/or issued by the Empower Annuity Insurance Company of America and Empower Trust Company which provide trustee and custodial services to the Plan. Therefore, transactions in these investments qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers and employees of the Plan Administrator and the Employers. No officer or employee receives compensation from the Plan for these services.

Note 10 – Prohibited Transactions

During the year ended December 31, 2024, participant contributions and loan repayments totaling \$60,470, were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute prohibited transactions as defined by ERISA. During 2025, approximately \$4,848 late contributions were corrected.

Note 11 – Subsequent Events

The Plan evaluated events occurring subsequent to December 31, 2024 through October 14, 2025, the date the financial statements were available to be issued, for events that should be recorded in the financial statements or disclosed in the notes thereto.
