To the Plan Administrator  
Veros Software Inc. 401(k) Plan

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Veros Software, Inc.'s 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Description of Plan**

The following description of the Veros Software, Inc. 401(k) (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**a. General**

The Plan is a defined contribution plan originally established on January 1, 2007 and subsequently amended and restated as of May 23, 2023, by Veros Software, Inc. The Plan was formed under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan was subsequently adopted by certain subsidiaries and related companies of Veros Software, Inc., the parent company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

As of December 31, 2024, the following entities (collectively, the “Company,” “Employer” or “Plan Sponsor”) participate in the Plan:

- Veros Software, Inc.
- Veros Real Estate Solutions, LLC
- Electronic Appraisal Solutions, Inc. (DBA Valligent)

Effective June 2024, the Plan transferred the assets from the Empower Trust Company, LLC to Fidelity Management Trust Company.

**b. Administration**

The Plan administrator is responsible for the day-to-day administration and operation of the Plan. Empower Trust Company, LLC was the custodian and recordkeeper of the Plan’s assets and maintained the individual participant account balances through June 23, 2024. Effective June 24, 2024, the Plan transferred asset, custodial, and recordkeeping duties to Fidelity Management Trust Company. Empower Trust Company, LLC and Fidelity Management Trust Company (the “Custodians”) are the custodians of the Plan’s assets and also maintain the individual participant account balances for the year ended December 31, 2024. The Custodians have the power to administer the Plan and apply all of its provisions on behalf of the Plan Sponsor. The Plan Sponsor has the discretion to appoint or remove any trustee or agent of the Plan.

**c. Eligibility**

The Plan generally covers all employees of the Company who are age 18 or older and have completed two months of service, provided that the individual is an eligible employee on such date.

The service requirement shall be deemed met no later than the end of an eligibility computational period during which the employee completes 1,000 hours of service, provided that the individual is an eligible employee on the applicable entry date. Excluded employees include employees who are included in a unit of employees covered by a collective bargaining agreement, if retirement benefits were the subject of good faith bargaining, and if the collective bargaining agreement does not provide for participation in this Plan, non-resident aliens, and part-time, temporary, leased, or seasonal employees who are scheduled to work fewer than 1,000 hours.

Employees may enter the Plan on the first day of each month coincident with or next following the date on which the eligibility requirements have been met.

d. Participant Contributions

Participants may contribute to the Plan up to 100% of eligible compensation through pre-tax and Roth salary deferrals, subject to IRC limit of \$23,000 for the year ended December 31, 2024. Upon reaching the age of 50, participants may make additional catch-up contributions limited to \$7,500 for the year ended December 31, 2024.

Participants may also make rollover contributions from other qualified defined contribution or benefit plans and certain individual retirement accounts.

e. Employer Contributions

The Employer may, at its sole discretion, make discretionary matching contributions to the Plan on behalf of all contributing participants. Matching contributions are allocated to participants' accounts in an amount equal to a discretionary percentage or amount of each participant's elective pre-tax, after-tax, and Roth contributions, which is determined by the Company each Plan year. For the year ended December 31, 2024, the Company elected to match 50% of each participant's elective deferrals up to a maximum of 6% of the participant's eligible compensation.

The Employer may make additional discretionary profit-sharing contributions to participants' accounts. The amount of such contributions, if any, is determined annually by the Company. Profit-sharing contributions are allocated to each eligible participant's account no later than the last day of the Plan year based on each participant's eligible compensation in proportion to the total compensation for all eligible participants. The Employer did not make any discretionary profit-sharing contributions to the Plan for the year ended December 31, 2024.

f. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. Participants can direct their account into a variety of investments offered by the Custodians. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant's vested account.

g. Vesting

Participants are always 100% vested in their elective salary deferrals, catch-up contributions, rollover contributions, and any earnings (losses) thereon. Participants vest in Employer discretionary matching contributions, profit-sharing contributions and any earnings (losses) thereon as follows:

2	50%
3	75%
4 or more years	100%

Participants or their beneficiaries become 100% vested in their accounts if they are employed with the Company and reach normal retirement age, become totally disabled, upon death, or upon Plan termination.

h. Forfeitures

Participants who terminate employment forfeit the non-vested portion of their Employer discretionary matching and profit-sharing contributions and any earnings thereon. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$23,599 and \$8,683, respectively. Forfeitures may be used to pay Plan administrative expenses or reduce Employer contributions. For the year ended December 31, 2024, no forfeitures were used to pay Plan administrative expenses or reduce Employer contributions.

i. Notes Receivable from Participants

Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance, subject to a minimum of \$1,000. Loans are repayable in equal installments of principal and interest per pay period and are paid through regular withholding from payroll. Generally, the maximum term of a loan will be 5 years unless the loan is used to acquire a principal residence, in which case the term may be for a period of 15 years. The collateral for a loan made shall be 50% of the participants vested account balance. New loans bear interest at the prime rate and are fixed at the inception of the loan. As of December 31, 2024, loans mature through 2029 and bear interest at rates ranging between 8.00% and 9.50% per annum which is commensurate with local prevailing rates as determined by the Plan Administrator at the time of the loan.

j. Payment of Benefits

Upon termination of service, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. Participants must take all non-taxable loans before applying for a hardship distribution. If a participant terminates employment and the participant's account balance does not exceed \$7,000, the Plan administrator will authorize the benefit payment without the participant's consent.

If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Company may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

k. Administrative Expenses

All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Company. Expenses, to the extent not paid by the Company, are paid by the Plan and allocated to participants based on their account balances. For the year ended December 31, 2024, the Plan paid expenses of \$43,558.

Expenses that relate solely to a specific participant, such as fees for notes receivable or benefit payments, are assessed to the participant. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

## 2. **Summary of Significant Accounting Policies**

a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") as set forth by the Financial Accounting Standards Board (the "FASB").

b. Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the amounts of net assets available for benefits, changes therein, accompanying footnote disclosures and the supplemental schedules. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

d. Payment of Benefits

Benefits are recorded when paid.

e. Subsequent Events

The Plan administrator has evaluated subsequent events through October 15, 2025, the date the financial statements were made available for issuance.

### 3. Information Certified by the Custodians (Unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(c) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodians.

The classification of the investments into the appropriate fair value hierarchy levels (1, 2 or 3) as disclosed in Note 5 is not certified by the Custodians and is the responsibility of the Plan's management.

### 4. Investments

All Plan investments are participant-directed and held by the Custodians as of December 31, 2024 and 2023. Participants can direct their accounts among various mutual funds and a common collective trust.

### 5. Fair Value Measurements

#### a. Fair Value Hierarchy

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets,
  - Quoted prices for identical or similar assets or liabilities in inactive markets,
  - Inputs other than quoted prices that are observable for the asset or liability, and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Mutual Funds

Valued at quoted market prices which are available on active markets and, therefore, are classified as Level 1 within the valuation hierarchy.

#### Common Collective Trust

Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV is used as the practical expedient to estimate fair value and it is based on the fair value of the underlying investments. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes these valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common collective trust is a stable return fund whose primary objective is to provide investors with a moderate level of stable income without principal volatility. There were no unfunded commitments as of December 31, 2024 and 2023.

## 6. Party-in-Interest Transactions

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned.

Certain Plan investments were managed by the Custodians as of December 31, 2024 and 2023. Accordingly, the investment transactions with the Custodians qualify as party-in-interest transactions.

The Company is a party-in-interest to the Plan. However, there were no transactions with the Company other than the funding of contributions to the Plan and the payment of certain administrative expenses.

## 7. Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue employer contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## 8. Tax Status

The Plan adopted a Fidelity Non-Standardized Pre-Approved Profit Sharing Plan. Fidelity received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that as of that date the Plan document was designed in compliance with the applicable IRC requirements.

The Plan has been amended since receiving the opinion letter. However, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Therefore, Plan management believes that the Plan is qualified and the related trust is tax exempt as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, foreign currency and overall market volatility risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 10. Non-Exempt Transaction

During 2024, the Company failed to timely remit participant contributions totaling \$628, to the Plan as required by the Department of Labor rules and regulations. The Company is in the process of taking the appropriate steps to correct the late remittances, calculating and restoring any lost earnings and the applicable excise taxes.
