NOTE 1 - DESCRIPTION OF PLAN

The following description of the St. Vincent De Paul Village 401K Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan covers substantially all eligible employees of St. Vincent De Paul Village (Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization is the Plan's Sponsor and serves as the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan as well as determining and reviewing the appropriateness of the Plan's investment offerings and investment performance.

The Plan is a defined contribution plan under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan became effective on January 1, 1992, and was restated in its entirety effective August 15, 2024. The Organization entered into an agreement with Transamerica Life Insurance Company to serve as Custodian of the Plan's assets through their agent, Reliance Trust Company, and to provide Plan recordkeeping and investment services, respectively through November 2024 and Empower Annuity Insurance Company (Empower) to serve as Custodian of the Plan's assets, thereafter. A third-party administration firm maintains participant accounts and provides administrative services for the Plan. The Trustee of the Plan is an officer of the Organization.

Eligibility

For elective deferrals, an employee is eligible to participate in the Plan upon completing 83 hours of service in a one-month period. Plan entry dates are the first day of the month coinciding with or next following the date eligibility requirements are met.

For matching and discretionary profit-sharing contributions, employees are eligible upon completing one year of service.

Participant Contributions

The Plan provides for automatic enrollment of eligible new hires at the rate of 4% of compensation. Unless an eligible employee affirmatively elects otherwise, automatically enrolled participants will have their deferral contributions increased by 1% a year not to exceed 6% of compensation.

Participants may contribute a portion of their annual compensation into a pre-tax deferral account and/or an after-tax Roth account up to the maximum allowed by the Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Employer Contributions

The Organization may make an annual matching contribution to eligible participants employed on the last day of the Plan year. No such matching contribution was made or declared for 2024. In addition to the matching contribution, the Organization may make discretionary profit-sharing

contributions. For 2024, the Organization made profit-sharing contributions totaling \$246,042 and is presented on the Statements of Net Assets Available for Benefits as employer contributions receivable.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contributions and, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of all assets attributable to their account. Each participant designates the percentage of any one or more of their accounts that is to be invested in each of several authorized investment funds designated by the Plan Administrator.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum distribution, annuity, direct rollover to an individual retirement account (IRA) or to another employer's tax qualified plan. Active participants may withdraw part of their account in a single sum in the event of undue financial hardship or attainment of age of 59½. If a terminated participant's account balance is \$5,000 or less, the Plan may distribute the account balance to an IRA without prior approval of the participant.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. A year of service is determined based on elapsed time. A participant is vested in employer contributions based on the following schedule:

Forfeited Accounts

Generally, a participant's unvested portion of the employer matching contributions is forfeited upon termination of employment. Forfeitures are maintained in a separate account and may be used to pay Plan expenses or reduce matching contributions.

The balance in the forfeiture account was \$6,700 and \$3,853 as of December 31, 2024 and 2023, respectively. The Organization used \$3,958 in forfeitures for discretionary profit-sharing contributions.

Administrative Expenses

Fees related to the administration of distributions are deducted from participant accounts that initiate the transaction and are included in administrative expenses. Other expenses of the Plan are deducted on a pro-rata basis from participant accounts and are included in these financial statements.

Certain investment management fees and other charges paid to the Custodian are offset against fund performance in the net appreciation section of the Statement of Changes in Net Assets Available for Benefits and are not, therefore, separately reflected as investment expenses. Certain Plan expenses are paid by the Organization; therefore, they are excluded from these financial statements.

Plan Termination Provision

Although the Organization has not expressed any intent to do so, it has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become fully vested in their account balances.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (GAAP). Employee and employer contributions are recognized in the period that contributions are due.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policy utilizing information provided by the Plan Custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily closing price and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV per unit of the bank collective trust. The NAV is based on the underlying investments held by the fund less its liabilities. Participant transactions may occur daily. Since the NAV is a readily determinable value, it is included in the fair value hierarchy table.

NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, as agent of Transamerica Life Insurance Company through November 2024, and thereafter Empower, as the provider of Plan recordkeeping, administrative, and investment services and as the Custodian of the Plan, has certified the completeness and accuracy of:

- Investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Transamerica Life Insurance Company and their custodial agent, Reliance Trust Company through November 2024, and Empower thereafter; therefore, these transactions are considered to be exempt party-in-interest transactions. Administrative expenses paid by the Plan to Transamerica Life Insurance Company and other service providers are considered to be exempt party-in-interest transactions.

NOTE 6 - TAX STATUS

The IRS has informed the Plan sponsor by a letter dated June 30, 2020 for the prototype Plan adopted by the Plan, that the Plan and related trust are designed in accordance with applicable

sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 8 - DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, certain participant contributions were not remitted to the Plan within the time frame prescribed by the Department of Labor's regulations. These late remittances constitute nonexempt prohibited transactions under ERISA.

The Plan Sponsor intends to take corrective action by remitting the lost earnings to the Plan.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated the activity of the Plan through October 15, 2025, the date the financial statements were available to be issued and has determined that no subsequent events have occurred that would require recognition or disclosure in the financial statements or in the notes to the financial statements, except as noted below.

Effective September 1, 2025, the Plan amendment removes the prior service requirement of 83 hours for plan participation. Under the revised eligibility provisions, employees will become eligible to make 401(k) contributions on the first day of the calendar month coincident with or next following the completion of one month of service, provided they are an eligible employee at the end of that period. Eligibility for employer matching and non-elective contributions will require completion of at least 1,000 hours of service in a 12-month period.
