To the Participants and Beneficiaries

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of the Center for Biological Diversity 403(b) DC Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. Description of Plan

The following description of the Center for Biological Diversity (Organization) 403(b) DC Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a deferred arrangement that is part of an employee savings plan covering all employees of the Organization. Employees are eligible to make elective deferral contributions on their date of hire. Employees are eligible to receive employer contributions on their date of hire after one consecutive year of service as long as they have reached 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of pretax annual compensation as defined in the Plan. Participants may also make Roth contributions to the Plan. In addition, participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization will make a contribution equal to 5% of the participant's compensation for participants with one to four years of service, and that contribution will increase by 1% for each additional five years of service. In addition, if a participant contributes up to 2% of compensation, the Organization will match the contribution at 100%. Qualified non-elective contributions may be made to satisfy nondiscrimination rules. Contributions are subject to certain limitations imposed by the Internal Revenue Service (IRS).

Participant Accounts

Each participant's account is credited with the amount selected to be deferred, an allocation of the Organization's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

SECURE 2.0 Act

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provision to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Management has determined that there is no material impact to the Plan's 2024 financial statements.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contributions is based on years of continuous service. A participant is 100% vested in employer discretionary contributions, plus actual earnings thereon, after two years of service based on a cliff vesting schedule. To earn a year of service, participants must have 1,000 or more hours of service during the service period, which is a one-year period ending on December 31.

Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their balance, whichever is less. If the participant has more than one loan outstanding, the \$50,000 maximum will be reduced by the highest outstanding loan balance in the 12-month period prior to the new loan. Loan terms may not exceed five years, unless the loan proceeds are applied toward the purchase of a primary residence. In such cases, the term of the loan may be for the term of the mortgage, for a maximum of 15 years. Principal and interest are paid ratably through payroll deductions. The loans bear interest at the prime rate on the date of the loan plus 1%. Interest rates range from 4.25% to 9.5%.

Plan Loans

Certain other loans are issued to participants as separate contracts by TIAA-CREF Financial Services (a Custodian), as contemplated under Internal Revenue Code (IRC) section 72(p)(5), and do not represent Plan assets. Plan loans are collateralized by a participant's balance in their TIAA Traditional Non-Benefit Responsive and TIAA Traditional Benefit Responsive (collectively, TIAA Traditional) account balances in an amount equal to 110% of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45% of their TIAA Traditional account balance, subject to annuity contract and Plan provisions. Plan loan terms range from one to five years in one-year increments. Principal and interest is paid ratably by the participant to the Custodian and each payment reduces amounts collateralized by the borrowing participant's TIAA Traditional account balance. Plan loan balances outstanding from participants to the Custodian were \$54,853 and \$52,095 at December 31, 2024 and 2023, respectively.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Organization. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. For the year ended December 31, 2024, the Plan paid recordkeeping fees in the amount of \$13,536. The Plan did not pay any administrative expenses for the year ended December 31, 2023. All administrative expenses, including professional fees, were paid by the Organization on behalf of the Plan.

Payment of Benefits

On termination of services due to death, disability, retirement or other reasons, a participant will receive a lump-sum amount equal to the value of the vested interest in his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, the balance of forfeited non-vested accounts was \$7,995 and \$5,023, respectively. This account may be used to pay administrative expenses or reduce future employer contributions. During the years ended December 31, 2024 and 2023, there were no forfeitures used to pay administrative expenses or reduce future employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

4. Income Tax Status

The IRS has determined, by a letter dated March 31, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the determination letter date. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

5. Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: valued at the net asset value of shares held by the Plan at year end.

Guaranteed interest account (non fully benefit-responsive): valued at net asset value based on the market value of the underlying investments.

Pooled separate account: valued at the net asset value of shares held by the Plan based on the market value of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
