Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Canton Drop Forge, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statement section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

NOTES TO FINANCIAL STATEMENTS

1. Description of the Plan

The following description of the Canton Drop Forge, Inc. Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all qualifying employees of Canton Drop Forge, Inc. (Company). All employees are eligible to participate in the Plan after completing six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participant contributions are voluntary. Contributions of earned compensation are tax deferred up to a maximum as established by the Internal Revenue Service. The Company has agreed to match employee contributions at various rates as defined in the Plan. In addition to the above match, the Company has agreed to make nonelective contributions on behalf of certain employees of the Company as also defined by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of employer contributions, plan earnings and expenses, as defined by the Plan document. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and certain employer contribution plus actual earnings thereon. Participants may not withdraw their tax-deferred contributions except for reasons of hardship, retirement, death, or termination of employment. Vesting in the remainder of their account is based on years of continuous service, as defined.

Forfeiture Account

If a participant forfeits any portion of his non-vested account balance, any portion of such forfeitures not used to pay plan administrative expenses shall be applied to reduce employer contributions. Forfeitures during the year as well as the balance at December 31, 2024 were immaterial. Forfeitures utilized to reduce employer contributions were \$-0- for the year ended December 31, 2024.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Description of the Plan (Continued)

Plan Termination

Although it has not expressed any interest to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all participants will become 100% vested in the Company contributions and will receive a full distribution of the balance in their respective accounts in accordance with the terms of the Plan.

Payment of Benefits

A participant or his or her beneficiary, upon termination, death, or retirement, receives his or her vested interest in his or her account in the form of cash or in-kind distributions. Additionally, the Plan has provisions for an active participant to make in-service withdrawals and hardship withdrawals from his or her account, subject to limitations and restrictions.

Investment Options

Upon enrollment in the Plan, a participant may direct employer and employee contributions in any percentage increments to any of the available investment options. Participants may change their investment options at any time.

2. Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. **Accounting Policies (Continued)**

Benefit Payments

Benefits are recorded when paid.

Administrative Fees

All administrative fees are paid by the Company or the Plan at the option of the Company.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

3. **Unaudited Information**

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received a certification from Fidelity Management Trust Company, the Trustee of the Plan, acknowledging the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statements of changes in net assets available for benefits for the years then ended, the supplemental schedule as of December 31, 2024 and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

4. **Income Tax Status**

The Plan utilizes a Volume Submitter Plan Document offered by the Trustee. The Internal Revenue Service has informed the Trustee by a letter dated June 30, 2020, that the form of the Plan is acceptable under applicable sections of the Internal Revenue Code (IRC). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

5. **Party-In-Interest Transactions**

Certain Plan investments held at December 31, 2024 and 2023 are shares of mutual funds offered by Fidelity Management Trust Company (Fidelity), the Trustee of the Plan. As such, these investments and related transactions qualify as party-in-interest transactions. Fees paid by the Plan for the Trustee amounted to \$3,224 for the year ended December 31, 2024.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

7. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for Plan assets measured at fair value:

- Mutual funds are valued at fair value based on quoted market prices, which represents the net asset value of shares held by the Plan at year end. These funds are classified as Level 1.
- The investment in the collective investment trusts is held and managed by Fidelity Management Trust Company. The fair value of investments held in this account is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs (contributions, plus interest at a specified rate, less participant withdrawals), and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
