NOTE 1 • DESCRIPTION OF THE PLAN

The following description of the Independent Healthcare Management (hereafter referred to as the "Company") 401(k) Plan (hereafter referred to as the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan in which all the employees of the Company are eligible to participate upon completion of six months of service and attainment of age twenty-one. An employee may begin participating on the first day of the month coinciding with or next following the date you satisfy the eligibility requirements. The Company's Board of Directors and the Plan Administrator control and manage the operation and administration of the Plan. Minnesota Life Insurance Company serves as the Trustee of the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company, located in Forest, Mississippi, is a not-for-profit acute care and critical access hospital. The Hospital provides inpatient, outpatient geriatric psychiatric, rural health clinic and emergency care services for residents of Scott County, Mississippi, and surrounding areas. Admitting physicians are primarily practitioners in the local area. The Hospital was incorporated in Mississippi in 1989.

Contributions

Participants may contribute a percentage of pre-tax annual compensation, as defined in the Plan each year subject to regulatory limitations. The maximum amount of compensation that may be deferred by law is \$23,000 for 2024 and \$22,500 for 2023. This amount is adjusted by the Secretary of the Treasury for the percentage increase in the Consumer Price Index each year.

Additionally, participants age 50 and older can elect to make additional catch-up deferrals as described in the Plan, but not to exceed the limitation imposed by law of \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan document allows participants to designate some or all of their deferral contribution as an after-tax Roth 401(k) deferral contribution. Once the election is made to designate amounts as Roth 401(k) deferral contributions, it is irrevocable.

The Company may make discretionary matching contributions to the Plan in amounts determined by the Board of Directors. Catch-up contributions are not eligible for the Company discretionary matching contributions. The Plan also allows the Company to make discretionary profit-sharing contributions. There were no discretionary matching or profit-sharing contributions for 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's deferral contribution, the Company's discretionary matching contribution, an allocation of the Company's discretionary profit-sharing contribution and Plan earnings and charged with an allocation of service and investment fees expenses.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's match contribution and discretionary contribution portions of their accounts, plus actual earnings thereon, is 100 percent upon entering the Plan.

Investment Options

Upon enrollment in the Plan, a participant may make direct contributions in any investment option allowed by the Plan. Participants may change their investment options daily via telephone or internet.

Loan Policy

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging between 4.25 and 9.50 percent, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service, participants with vested benefits of \$1,000 or less are automatically paid a single lump sum payment, unless participants request a direct rollover of such funds to an IRA. Upon termination of service due to death, disability or retirement, participants with vested benefits greater than \$1,000 may elect to receive either a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Administrative Expenses

In 2024 and 2023, certain investment expenses were paid for by the Plan. All other administrative expenses were absorbed by the Company.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value measurement of investments. It is at least reasonably possible that the significant estimates used will change within the next year.

Employee and Employer Contributions

Employee deferral contributions are recognized as additions to net assets on the date on which such employee deferrals would otherwise have been payable to the participant. Employer discretionary contributions are recognized as additions to net assets upon formal approval by the Plan Sponsor's Board of Directors. Employee rollover contributions are recognized as additions to net assets on the date transferred from other qualified plans.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value) and any unrealized appreciation or depreciation for the year is reflected in the statements of changes in net assets available for benefits. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Concentration of Credit Risk

The Plan assets include a significant amount of pooled separate accounts, which invest primarily in marketable equity securities and fixed income securities. Accordingly, the performance of the investments is dependent on the equity and debt securities markets which involve price volatility. Additionally, the pooled separate accounts may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Subsequent events were evaluated by the Plan through October 9, 2025, which is the date the financial statements were available to be issued.

NOTE 3 • INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-related supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Minnesota Life Insurance Company.

NOTE 4 • FAIR VALUE MEASUREMENTS

Fair value measurements define fair value as the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. Fair value measurements establish a fair value hierarchy that prioritizes the observable and unobservable inputs used to measure fair value into three broad levels:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024.

Separate pooled accounts: Valued at fair value, determined by multiplying the number of shares of the respective underlying fund by the closing net asset value per share quoted by that fund.

The preceding methods may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 • INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

The Plan has entered into a traditional fully benefit-responsive investment contract with Minnesota Life Insurance Company (the "Insurer") totaling \$52,637 and \$50,225 as of December 31, 2024 and 2023, respectively. The Insurer maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon by the issuers. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This guaranteed investment contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the insurer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7 • PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions for years 2024 and 2023 was investment administrative fees payable to Plan Trustees of \$4,232 and \$3,603, respectively. Such fees are based on customary and reasonable rates for such services.

NOTE 8 • INCOME TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by the Insurer. The prototype plan has received an opinion letter, dated June 30 2020, from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

There were no uncertain tax positions identified related to the current year and the Plan has no unrecognized tax benefits at December 31, 2024 and 2023, for which liabilities have been established. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits as a component of income tax expense.

NOTE 9 • NON-EXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Plan remitted all employee contributions to the Plan, contributions of \$2,694 and \$14,394 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively. The Plan has started the process to correct the matters through the Voluntary Fiduciary Correction Program and make the participant accounts whole for the years ended December 31, 2024 and 2023.

NOTE 10 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. SECURE 2.0 has key effective dates which vary by provision. The plan has adopted and implemented all mandatory provisions to date with other provisions to be phased in over the next few years in accordance with applicable law and IRS guidance. Written amendments to the Plan to reflect these operational changes will be adopted at a later date.
