## Independent Auditor's Report

To the Trustee and Plan Administrator  
Southern Connecticut Vascular Center 401(k) Profit Sharing Plan & Trust

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***



## Notes to the Financial Statements

December 31, 2024 and 2023

### 1. DESCRIPTION OF PLAN

The following description of Southern Connecticut Vascular Center 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan established effective May 1, 2001, as restated December 14, 2023. The Plan covers substantially all employees of Southern Connecticut Vascular Center, LLC (the Company or Employer) who have completed three months of service and are age 18 or older. The Plan also covers substantially all employees of U.S. Vascular Management Group, LLC, Rhode Island Vascular Center, LLC, and New York Vascular Group, PLLC, entities related to the Company through common ownership. The Plan excludes employees covered by a collective bargaining agreement, nonresident aliens with no U.S. source income employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The plan administrator is responsible for oversight of the Plan. The plan administrator also determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions** - Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe-harbor matching contribution equal to 100 percent of the first 3 percent of compensation contributed by each eligible participant, plus 50 percent of the next 2 percent of compensation contributed by each eligible participant. Additional profit sharing amounts may be contributed at the option of the Board of Directors. For the year ended December 31, 2024, there were no profit sharing contributions. In order to receive a discretionary profit sharing contribution, participants must be employed on the last day of the plan year or have completed at least 501 hours of service during the plan year. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Plan also permits participants to direct their contributions to purchase life insurance policies. As of December 31, 2024 and 2023, one participant holds a life insurance policy with Massachusetts Mutual Life Insurance Company Policy.

**Participant accounts** - Each participant's account is credited with the participant's contributions and the Employer's safe-harbor matching contributions, as well as allocations of the Company's discretionary profit sharing contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant-directed transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are 100 percent immediately vested in their contributions and the Company's safe-harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing portion of their accounts is based on years of continuous service. A participant is 50 percent vested after two years of credited service and continues to vest in increments of 50 percent until 100 percent vested after three years of credited service. An employee is considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service at any time during a plan year. A participant will be 100 percent vested in all their account upon early retirement age, disability or death.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account. The loan interest rate, determined fixed as of the issuance date of the loan, is set at the Prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Loan terms range from one to five years or may extend up to ten years for the purchase of a primary residence.

**Payment of benefits** - On termination of service for any reason, a participant will become entitled to the vested balance of his or her account. Distributions will be paid in lump sum or partial lump sum, based on the election of the participant. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of a lump sum payment. If the participant's balance is between \$1,000 and \$5,000, the plan administrator may roll the amount into an individual retirement account on behalf of the participant without the consent of the participant. Participants with a vested balance greater than \$5,000 may defer payment of benefits till a later date. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date. In addition, the Plan allows for hardship distributions if certain criteria are met, as defined in the Plan.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59½.

**Forfeited accounts** - Forfeited non-vested discretionary profit sharing accounts may be used to reduce future employer contributions or to pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$40,033 and \$21,834, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, no amounts were applied to plan expense from forfeited nonvested accounts.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

**Subsequent events** - Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Interest-bearing cash:* These investments are stated at cost, which approximates fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed investment contract:* The Plan holds an interest in an investment contract that management has determined is not fully benefit responsive due to limitations on participants' ability to transact in this investment. As a result of change in custodians in 2023, participants may not contribute additional funds to this investment and they may only transfer certain amounts to other investment options over a five-year period. All other participant-directed transactions are permitted. Management has determined that contract value approximates fair value for its guaranteed interest contract. Contract value represents the accumulation of contributions made under the contract, plus guaranteed and additional interest, less funds used to pay benefits and administrative expenses of the contract.

*Cash surrender value of life insurance policy:* Valued at the cash surrender value of the policy as reported by MassMutual, which approximates fair value. Management has determined that this cash surrender value represents the best available evidence of fair value because that is the amount that could be realized by the Plan under the contract as of the financial statement date.

Because of the limited activity in this contract, the determination that surrender value approximates fair value for the investment in the insurance policy is only reviewed annually for financial reporting purposes. In reviewing the reasonableness of this determination, management reviews the contracts with MassMutual for changes in the contract, current insurance contract, current economic conditions, credit rating of insurance company and similar factors that could impact their conclusion.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company and Empower Annuity Insurance Company (EAIC), the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The life insurance policy held by MassMutual was not certified in 2024 and 2023. This investment was \$259,383 and \$187,904 as of December 31, 2024 and 2023, respectively, and had an increase in the cash surrender value of life insurance policy of \$71,479 for the year ended December 31, 2024, which is included in net appreciation in fair value of investments for the year ended December 31, 2024.

### **5. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan holds certain shares of money market and mutual funds, an unallocated investment contract, and a life insurance policy issued or managed by Fidelity, MassMutual, Empower Trust Company or their affiliates. Fidelity and MassMutual are third-party administrators and, therefore, these transactions as well as the Plan's payment of fees to Fidelity, MassMutual and Empower Trust Company or their affiliates qualify as party in interest transactions. Fees paid by the Plan to Fidelity, MassMutual, or their affiliates totaled \$88,801 for the year ended December 31, 2024.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions also qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### **7. TAX STATUS**

The Company adopted a pre-approved plan offered by Fidelity Management & Research Company LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. DELINQUENT PARTICIPANT CONTRIBUTIONS**

For the years ended December 31, 2024, 2023, 2022 and 2021, the Company did not remit certain participant contributions and participant loan repayments to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances of \$49,637, were identified on the Schedule of Delinquent Participant Contributions which were not corrected in 2024. Additionally, the Company will be compensating participants for lost earnings resulting from the delay in contributions.

### **9. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in a variety of investments. Investments are exposed to various risks, such as interest rate risk, financial market risk and credit risk as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with these investments, coupled with recent economic events, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.
